

MRS. ROOSEVELT IS WELCOMED ON VIRGIN ISLANDS

First Lady Makes Air Trip to Spot Where Columbus Landed On First Crossing — Takes Deep Interest

ST. CROIX, Virgin Islands, March 8.—(AP)—Mrs. Franklin D. Roosevelt, Governor Paul Pearson and a party aboard the airliner American Clipper came here today in 28 minutes from St. Thomas.

They went ashore at the place where Christopher Columbus is reputed to have landed from his first crossing of the Atlantic.

From the plane, Mrs. Roosevelt went ashore in a rowboat. She jumped from the rowboat to the dock and there she was presented a huge bouquet of flowers by a negro child.

Bottle for President
Another present was given here—a bottle of 45-year-old St. Croix rum "to take to the president."

At St. Thomas, Mrs. Roosevelt went swimming at 7:30 a. m., then she and her party visited the fort, butressed "Bluebird Castle," where federal money is now building a hotel to turn the pirate lair into tourist dollars as an aid to the impoverished islands.

Many Projects Seen
She saw the beginnings of farm work around Lindbergh bay, watched roads being built, school buildings repaired, and swamps drained.

Untringly she asked practical questions to bring out the facts on schools, on poverty, and on the pressing local problem of vagrant, parentless children.

Officials told her that the activities of the last few months had resulted in improvements with which nothing else since the islands were bought in 1917 could be compared. Federal flour, butter and pork are feeding the poor.

Whenever Mrs. Roosevelt went the enthusiasm was so rampant that a local doctor exclaimed: "The people are waving their hats off!"

Before her swim Mrs. Roosevelt and Governor Pearson skipped rope on the beach.

Women Reassured
Thousands of native women gathered about Mrs. Roosevelt told them:

"I hope you feel as long as my husband is in office you have a friend."

When she departed in an automobile for the airport the assembled women called:

"Kiss Blatte and Buzzie for me!"
"May a crown of glory rest on your head with diamonds in it!"
"God be with you!"

As the car departed, many of the spectators made the sign of the cross.

HOUGH FILES AS CANDIDATE FOR CIRCUIT JUDGE

A. C. Hough, attorney of Grants Pass, today formally filed his declaration of intentions to seek nomination for circuit judge from the district comprising Jackson and Josephine counties.

Attorney Hough is the third candidate for the judicial post to file, the others being Attorney J. G. Anderson of Grants Pass and Judge Harry D. Norton, incumbent. This means the judgeship will be voted upon at the May primary, as well as at the general election in November. The judgeship contest, under Oregon law, is non-partisan with no political designation. Had but two filed, there would have been no vote at the primary.

Attorney Hough has been a resident of Josephine county for 35 years and during that time more or less active in Democratic circles. He is well known in Josephine county. Last spring and summer he was chief counsel for E. H. Fehl and J. Arthur Ladieu, convicted in ballot theft, and advisor to those identified with the local agitation and vote stealing.

There are no other potential judicial candidates in sight.

A. E. Reames, attorney of this city, a high ranking Democrat of the state, and mentioned as a gubernatorial possibility, yesterday filed for Democratic precinct committeeman from the Medford Newtown precinct, Col. F. L. Tull Velle of Jacksonville, a war hero of local reputation, filed for the same post from the North Jacksonville precinct. They are the first two Democratic precinct committeemen to file slogans. Attorney Reames announces he will "support the principles of the Democratic party." Col. Tull Velle is under the sibilotheth: "I will support the policies of President Roosevelt." The Democracy of neither has ever been impugned.

Mrs. Stella Anderson is the first woman of the season to file for office. She seeks Democratic precinct committeeship, with the slogan, "I will serve to the best of my ability." Leona Ahstrom of Ashland filed for the same honor, but failed to state which precinct she was running in, so the filing will be returned for revision and correction.

A Republican finally showed up with ambitions to be a precinct committeeman, and filed yesterday. He is Fred C. Homes of Bellview, who has held the post before. Mr. Homes has no slogan.
