### Georgetown Dean Flays Dr. Butler for Disarmament Preachments — Far East Situation Held Dangerous

**Sparks From Mars**  
**TOKYO, April 18.**—(AP)—A foreign office spokesman said today that Japan is prepared to meet force with force, if necessary, to preserve peace in East Asia.

Of course, he said in discussing Japan's restated China policy, Nippon will be guided in the application of her policy of responsibility for tranquility in East Asia by circumstances.

**PARIS, April 18.**—(AP)—France threatens in a note to Great Britain to scrap all current disarmament negotiations unless she is given something equivalent to the military alliance in the old entente cordiale, it was revealed today.

**WASHINGTON, April 18.**—(AP)—The Daughters of the American Revolution, assembled in annual congress, heard an educator assert today that America has "passed from the post-war era to a new pre-war era."

Dr. Thomas Healy, assistant dean of Georgetown university's foreign service school, made this statement in an address hitting repeatedly at Dr. Nicholas Murray Butler, president of Columbia university, as a poor prophet on war.

He quoted Dr. Butler as saying four months after the world war started that there was no sanity in "useless armaments against nobody," and as saying more recently that some "have not heard Napoleon and Bismark are dead."

**Dictators Dangerous**  
 "The ignorance of the American people," Dr. Healy said, "is not so abysmal that they are not aware of the fact Napoleon and Bismark have been replaced by modern and possibly more dangerous counterparts in Hitler, Stalin, and a host of other military dictators who at this moment are ruling a large portion of the world. Unlike Napoleon and Bismark, the passion of Hitler and communism of Stalin have reached over into the very heart of America in an attempt to undermine the structure of our government."

He pronounced the Far Eastern situation "at least as dangerous as the European situation," with Russia and Japan both " feverishly preparing for war," and almost ready to "fly at each other's throats."

**Plan Patriotic Junk**  
 The daughters voted today to bring a school girl from each of the 48 states to Washington next spring on a patriotic pilgrimage.

Candidates will be selected on a good citizenship basis first, but final selections will be by lot.

The daughters also adopted resolutions which would make obligatory the teaching of American history and civil government in the schools; to demand a modern American merchant marine; and to urge adequate appropriations for U. S. M. T. C. and R. O. T. C. camps.

The organization will choose seven vice-presidents general tomorrow. Among the candidates are Mrs. Frederick F. Gundrum of Sacramento, Cal., and Mrs. John Y. Richardson of Portland, Ore.

# WORK FOR RELIEF PLAN IN COUNTRY

**PORTLAND, April 18.**—(AP)—Elmer Goudy, in charge of the Emergency Relief administration for Oregon, today explained that a "work for relief program" is being established in each rural county of the state, in an attempt to provide for those remaining on the county unemployment rolls.

Under this program, Goudy said, those who obtain relief from the SERA will be expected to make "payment in kind," by working on jobs designated by the SERA.

For example, if an unemployed man receives relief in the form of food and clothing in the amount of \$20 a month, he will be expected to repay the state with the equivalent of \$20 worth of labor on projects designated for his county, as compensation.

# SAVE ONE CENT ON FIRST STATE GAS

**SALZEM, April 18.**—(AP)—The initial carload of gasoline to be brought in by the state in a board of control move to lower gasoline prices in Oregon will be purchased tomorrow from Tacoma, William Einzig, purchasing agent, stated today.

The gasoline will be purchased at five and one-half cents there. This with the 5-cent state tax and transportation to Salem will bring it to 12.32 cents a gallon, Einzig stated. The state does not pay the federal one-cent gasoline tax. This price will be a saving of about one cent under bulk rates of the present contracts which expire May 1.

# BASIS OF ROW IN MANNING'S OFFICE HINTED BY STATE

(Continued from page one)

Jennie Lang, a resident of California who held a mortgage on the building. Manning Wanted Haste.

This suit, both Gillenwaters and George Roberts, defense lawyer, intimated was the reason Manning called Horan to his office last February 13. Manning was preparing for a business trip to California and was attempting to hasten the matter scheduled for answer on February 15.

Gillenwaters and Roberts completed their opening statements this morning and the first witnesses were to be called following the recess. A motion was to be argued first, however, when the defense protested against the state's request to permit the jury to view the scene of the shooting.

Prosecutor Nervous.  
 Young Gillenwaters, flushed and nervous, completed his opening statement in half an hour. Before the case swung into its major stages all witnesses were ordered from the courtroom. Families of Horan and Manning were permitted to remain.

The district attorney described Horan's activities on Lincoln's birthday and his subsequent visit with Manning upon the veteran attorney's invitation.

He said the state expected to prove that just before 6:00 o'clock persons in the vicinity heard two shots fired in Manning's office and then two more 15 minutes later.

Seen Between Shots.  
 Gillenwaters said that between the shots Manning was seen in the streets adjacent to the building by two friends of long standing. He was extremely nervous and failed to recognize either, the attorney declared.

The state lawyer said evidence had been collected to show that a gin bottle had been hurled into the alley from Manning's office at about 5:40 o'clock. This and the testimony of persons who saw the defendant shortly before the shooting will be presented to prove Manning was intoxicated.

Manning's voluntary call to the sheriff's office telling of the shooting and incidents of the arrest were quickly related to an overcrowded courtroom.

The testimony of E. O. Heinrich, criminologist, Gillenwaters said, would reveal from which of the two guns the four shots were fired and the direction each bullet took.

Defense Is Brief.  
 Roberts was even briefer than Gillenwaters in the opening statement for the defense. He gave the jury a short outline of the defendant's life in Klamath and Jackson counties and said the defense would disprove the allegations made by the state.

"We promise that evidence will disclose that Manning is not guilty and that what took place in the office will prove his innocence," Roberts said.

While Gillenwaters described the bullet wounds in Horan's body, Manning spoke briefly with his lawyers. Beyond that he sat in a relaxed position and without facial expression. He appeared, however, to be listening closely to the prosecution's statement.

# \$500,000,000 FOR PWA FISCAL YEAR IS DECIDED UPON

**WASHINGTON, April 18.**—(AP)—President Roosevelt and his aides decided today upon a \$500,000,000 appropriation for public works for the new fiscal year beginning July 1.

Secretary Ickes, the public works administrator, upon leaving the White House, told reporters that \$200,000,000 would be used for continuing during the coming year existing projects initiated under the \$3,300,000,000 program.

The remaining \$300,000,000 will be used for new projects. The \$500,000,000 will be earmarked in the general lump sum relief appropriation to be asked shortly from congress.

Secretary Wallace, whose department is in charge of public road construction, participated in the White House conference.

**PORTLAND, April 18.**—(AP)—Hope was expressed here today by those working on the proposal, that federal funds will soon be made available for the construction of a \$130,000 training school building for the Eastern Oregon Normal school at La Grande.
