

DENVER LAW AIDE WHO NABBED REED 'TAKEN FOR RIDE'

Detective Turner Known Here — Testified At Trial Of Albert Reed For Murder Of Ashland Officer.

Detective J. S. Turner of Denver, Colo., whose bullet-riddled body was found last week, was known here by Captain Lee M. Bown of the state police. Chief of Police Clatus McCredie and the former County Sheriff Ralph G. Jennings.

Turner arrested Albert Reed, who is serving life sentence in the Oregon state penitentiary for killing Victor Knotta, Ashland police officer. He attended the trial here, in 1932, and made many acquaintances while in the valley. Paul McQuade and Lee Jackson, pals of Reed, are still fugitives.

The Associated Press dispatch from Denver, concerning Turner's death, stated: "The body of Detective J. S. Turner, who has been missing since Monday, was found, bullet riddled, near Arvada today under circumstances which police said indicated he had been taken for a gangland ride. There was one bullet wound in the head.

The body was discovered in a field a mile and a quarter from where the detective's car had been found abandoned earlier in the day. Pending the arrival of the coroner, officers did not move the detective's body."

BAY CITY PLANES BESTOW JUNIOR CHAMBER WISHES

Greetings from the air were given to Oregon's Diamond Jubilee celebration upon the arrival in Medford yesterday forenoon of eight airplanes representing the San Francisco Junior Chamber of Commerce. The delegation included the huge Standard Oil company passenger plane, which, along with the other planes, attracted hundreds of visitors to the airport.

The San Francisco party, which was met by a local plane piloted by Henry Fluhrer at Montague, included Thos. F. Ryan III, R. H. Wellington, Thomas Jennings, Joseph Musto, Elton Tognazzini, Clarence Musto, L. B. Daniels, Bernard Mike, Doctor Crawford Cole, Ivar Aakelsen, Joseph Knowles and Walter Ryberg, chairman.

Ted Huggins of the San Francisco office of the Standard Oil company was in the party, accompanied by other executives of the company, which in numerous ways took an active part in the celebration. The planes are scheduled to leave this forenoon on the return trip to the bay city.

The arrival of the air delegation is deeply appreciated by the jubilee committee as a true gesture of the interest San Francisco has always had in southern Oregon.

HISTORIC GAVEL GIVEN JUBILEE OFFICERS BY PIONEER ASSN. CHIEF

George H. Himes, secretary of the Oregon Pioneer association, whose headquarters are in Portland, has sent to the Diamond Jubilee committee a beautifully turned gavel, along with an expression of regret that neither himself or Hon. Joseph Simon, president of the association could be present during the celebration here.

The gavel head, says Mr. Himes, was made from a piece of manzanita which he cut near Jacksonville in 1884. The handle was turned out of a piece of black walnut which grew from a nut planted in 1859 by William Barlow in Clackamas county, a few miles south of Oregon City. The nut was one of a bushel sent to Barlow in 1858. William Barlow's father, Samuel Kimbrough Barlow, was the leader in making the well-known "Barlow road" through the Cascade mountains in 1845-46.

In concluding his letter of greetings to the Jubilee committee, Mr. Himes says: "As representing the Oregon Pioneer association, organized in 1873, of which I have been secretary since 1886, together with Hon. Joseph Simon, president of the association, at this time, we extend our united greetings."

General Chairman E. C. Jerome of the Jubilee committee plans to place the gavel on exhibit at the chamber of commerce following the Jubilee.

TRIO HELD KNOX LAW VIOLATORS

Henry H. Dyne, 34, Cottage street, who was arrested Friday night for possession of moonshine liquor with the purpose of sale, was out on \$700 bail yesterday after appearing in Justice court. He sold a pint of the liquor to state police and was taken before Justice of the Peace W. R. Coleman. The arrests were made under the Knox liquor law provisions by state and city officers.

Dyne's wife, who was arrested with Dyne on charges of maintaining a public nuisance, was released on her own recognizance. The place was investigated after complaints had been filed that the Dyne was selling liquor in a house on Cottage street. After her husband allegedly sold a pint of moonshine to the officers, Mrs. Dyne ran to the room from which he had brought it and was followed by the officers, who found a small quantity of the liquor in a jug, she said.

W. W. Ireland, 42, arrested Friday at the Riverside apartments for the sale of liquor in a residence, who was taken before Justice court yesterday, was released on \$500 bail.

Ireland's arrest was made by city, county and state police, who report that an investigation is pending to determine whether charges of conducting a public nuisance will be filed against the owners of the apartment house.

ARMY RECRUITER ON LAST ROUND-UP

On June 11, Sergeant Jennings D. Lowman will make his last canvassing trip here in the interest of recruiting for the regular army. He will be here for a period of three days.

Due to the overstrength of the regular army and the heavy percentage of men re-enlisting within a few days after discharge, the army is forced to close some of its recruiting offices. The southern Oregon offices are to be closed this month.

During the almost seven months of operation the office at Medford has given the service approximately 80 good local men. In the contact that the recruiting service tries to maintain after the men are enlisted, it is found that many of these men are climbing upward, grasping the opportunities offered by the army.

For this coming trip the district recruiting officer at San Francisco has directed that, regardless of vacancies, and in regard that no men who have been contemplating enlistment in the regular army be disappointed, assignments be given to local men for both foreign service and domestic service.

The Smith deal was a real sacrifice for Byrnes, because the White House is so indebted to him he could command South Carolina patronage if he wanted to.

Administration forces are pointing out that if Mr. Roosevelt had passed out all the patronage at the start he would have nothing left now for such things as the Smith case.

The steel and automobile people have learned to speak General John



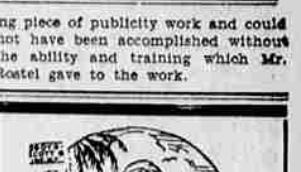
