WASHINGTON, D. C. June 13.—The Tugwell case was only a public skirmish to screen a real political movement underneath.

It was started by several conservative southern democrats, who are dissatisfied at heart with the way the New Deal is going. They do not like the NRA, AAA, or even the PWA spending, although they cannot afford to say so publicly as yet. They did not like the gold policy, but they have had to keep more or less quiet about that also.

The nomination of Professor Tugwell as under-secretary of agriculture gave them an opportunity to release some pent-up feelings without exposing their position. They jumped at it.

The senate agriculture committee hearing showed how they felt. They knew they could not defeat Tugwell's nomination and they did not care to. They merely wanted to talk about their own attitudes and they did.

No one went so far as to break with the New Deal, but only so far as to express displeasure with radicalism.

The whole show smacked of second-rate political vaudeville, involving stump speeches and sharp side remarks, much the same as in the Wirt hearing.

Tugwell handled himself rather modestly and quietly, as if he did not want to antagonize anyone. He was amply protected by the liberals on the committee, including Senators Norris, Wheeler and Bone. The crowd whooped and booed. The professor seemed to have the advantage with the ladies in the audience because he was younger and more handsome than the senators present.

Mrs. Tugwell was so bored she went home after the second hour. It was just that bad.

STEVEDORES' CHIEF AGREES TO DRAFT NEW CONCESSIONS

Attitude of Seattle, San Francisco Mayors and Gov. Meier Declared Hopeful—Employers Stand Pat

SEATTLE, June 13.—(AP)—Mayor Charles L. Smith predicted today that all Seattle shipping will be released from the longshore strike before tomorrow afternoon. He made the statement during a recess of a conference between union leaders and employers.

SAN FRANCISCO, June 13.—(AP)—Belief that the strike of Pacific coast longshoremen might be settled soon was expressed by Joseph P. Ryan, president of the International Longshoremen's association, after a conference with Mayor Angelo Rossi and other officials here today.

At the meeting with Mayor Rossi and other officials here today, Ryan left the conference after promising to prepare a written proposal of the best concessions the longshoremen would agree to in ending the strike.

"With the attitude shown by Mayor Charles Smith of Seattle, Governor Julius Meier of Oregon and Mayor Rossi of San Francisco, who are hopeful of settling the strike satisfactorily to both sides, the situation looks decidedly hopeful," Ryan declared.

"All other intermediaries," he added, "are trying to settle the strike in favor of the employers."

At the meeting with Mayor Rossi and other officials here today, Ryan left the conference after promising to prepare a written proposal of the best concessions the longshoremen would agree to in ending the strike.

FASCISM CLAIMED VISIBLE TREND OF RECOVERY POLICY

Member of Darrow Review Board Resigns—Says NRA Encourages Development Monopoly Capitalism

WASHINGTON, June 13.—(AP)—Saying that the development of NRA "day by day reveals more clearly a marked trend toward fascism in the United States," W. O. Thompson resigned today as a member of the Darrow NRA review board.

In his resignation, delivered at the White House, he asserted that "the trend of the National Recovery administration has been and continues to be toward the encouragement and development of monopoly capitalism in the United States."

"The only solution," the former law partner of Clarence Darrow said, "involves a change in class relationships. Only a government by the workers and farmers can plan production, produce goods for use and not for profit, eliminate poverty, and the standard of living for the entire population."

Thompson said he alone was responsible for the preparation and conclusions of the recent supplemental report of the board which recommended socialization of industry.

It was signed by himself and Darrow.

WASHINGTON, June 13.—(AP)—The senate today passed without debate, but later reconsidered and restored to its calendar, the Dill bill authorizing an annual appropriation of \$10,000,000 for apportionment to the states and territories for old age pensions.

The measure was passed by unanimous consent, but Senator Gore (D., Okla.) entered the chamber later and obtained reconsideration.

WILL OUTLAW TRY TO FREE HER?



Speculation over the likelihood of an attempt by John Dillingham, the nation's No. 1 outlaw, to free his sweetheart, Evelyn Frechette, arose after she was convicted in St. Paul of conspiracy to hide the notorious fugitive. Miss Frechette was sentenced to a prison term of two years and \$1,000 fine.

CHICAGO, June 13.—(AP)—Highways free of trucks and trailers loomed as a possibility today with the inauguration of a new type of freight service, attributable to the NRA.

Seven truck trailers were driven onto flat cars last night on the Chicago, Rock Island & Pacific railroad, for a ride to Davenport, Iowa, and the innovation was described as a boon to all concerned.

Jack Keeshin, operator of the Keeshin Motor Express company, said the trucker benefits under this new service because trailers can be carried on flat cars cheaper than they can be hauled over the highways under the higher cost of tires, gasoline and labor brought about by the national recovery administration.

"The railroad," he said, "benefits because we're paying 24 cents a car mile as compared with a cost of 14.5 cents a mile to the railroads, according to government figures."

"Shippers benefit because we are preparing a tariff of rates lower than is charged for truck hauling and lower than the railroads can handle less than carload business."

"And the motoring public will benefit by the removal of these trucks from the highways."

CONFESSION MADE IN MASS SLAYING OFFICERS DECLARE

SUSANVILLE, Calif., June 13.—(AP)—"He broke up my family. Now I have broke up his."

On this confession of motive, which authorities declared was given to them by Peter Aloisi, 45-year-old lumber mill worker, in the presence of a court reporter, District Attorney Grover C. Julian prepared to go to court today to charge Aloisi with stabbing to death three women and two men.

There were rumors yesterday an attempt to lynch Aloisi would be made, but Sheriff James Leavitt last night went into the Italian quarter and pleaded for orderly procedure. Community leaders sided with him and pledged support, and the sheriff returned to his office convinced there would be no trouble of that sort.

The sheriff who handled the case with Deputy Royce Baker, made public last night a confession which rivaled the grandest of Italian grand opera for passionate murders and unmitigated tragedy.

GROWERS, CANNERS GET TOGETHER FOR PLANS UNDER AAA

Price for Pacific Coast Bartletts and Regulations for Size of Season's Pack to Be Established

KLAMATH FALLS, May 13.—(AP)—Representatives of pear growers and canners in the northwest and California, meeting here in an effort to restrict this year's pack, had agreed today that all cull pears will be eliminated.

This was the first point discussed and the conference was to continue through the afternoon, taking up point by point the phases of the hoped for temporary agreement under the agricultural adjustment administration.

About twenty were present from Washington, Oregon and California. Klamath Falls was selected for the meeting because of its intermediate location.

Dr. F. R. Wilcox of the University of California was the presiding officer.

Edgar M. Burns, secretary of the Northwest Canners' association, announced that "considerable progress had been made."

The meeting here was to establish a price for Pacific coast Bartletts and to suggest regulations for the size of this season's pack.

Representatives expected the meeting would continue the rest of the day.

HINT SPY RODE IN TRAGIC PLANE

LIBERTY, N. Y., June 13.—(AP)—Federal authorities today took over the investigation of the tragic crash of the huge airplane, with a loss of seven lives, into the side of Montauk mountain.

The entire investigation, insofar as the federal government is concerned, appeared to center about papers that were in the possession of William B. Bader, of Buffalo, a chemist and one of the victims of the crash.

"Secret" naval documents had been reported found in Bader's effects salvaged from the plane.

LIVINGSTON MANOR, N. Y., June 13.—(AP)—All papers, documents and three bottles of chemicals, found in the luggage of William B. Bader, a victim of the American Airlines plane crash, were seized tonight by an intelligence officer of the U. S. navy.

HIGHLAND PARK, Ill., June 13.—(AP)—Preferring suicide together to a possibility that one of them might die on an operating table, Mrs. Alice King Bott, 63, and her daughter, Margaret, today tied their bodies together and swam into Lake Michigan. Later they were found on the shore and the daughter revived but the mother had died.

The daughter was taken to their home, where she told the story of the bizarre suicide pact.

The young woman said she had recently undergone two operations for mastoid trouble. A third operation, she said, had been ordered, and both she and her mother feared she would not survive it. They agreed to a suicide pact.
