

KIWANIS GOVERNOR SAYS CITIZENSHIP PARAMOUNT IDEAL

Arch A. Bernard of Eugene, lieutenant governor of Kiwanis for the southern Oregon district, was the principal speaker at Kiwanis yesterday. His subject was "The Place the Service Club Has in the Community."

He stated that the public had come to look too much on service clubs as charitable institutions and that too much of the time of the clubs was being used up in work that should rightfully be taken care of by established agencies.

Stressing the paramount ideal of Kiwanis as "citizenship," he urged the local club to concentrate its efforts along this line, and to take a continuing interest in politics and see that the public good are elected to office.

Lieut. Governor Bernard is making a hurried trip to all of the clubs in the district in an effort to stir interest in the coming Kiwanis convention at Wenatchee, Wash., August 19-21. He informed the local club that the Klamath Falls club had already signed up 16 members for the trip and hoped that the Medford club would have a good representation at the convention.

S. P. SEEKS RENT ON SHOVEL SPACE

The Southern Pacific railroad company yesterday filed suit against J. E. Norris, Taylor Bros. and company, and Fred F. Smith, for \$105, allegedly due for space occupied by a steam shovel since February 1, 1931, on the railroad right-of-way, near Rogue River.

The complaint sets forth that Norris purchased the steam shovel and it was agreed that he pay \$2.50 per month rent as long as the equipment remained on railroad property. It is averred 43 months have passed, and no rental.

It is further contended that Taylor Bros. and Co., and Smith have some claim to the steam shovel, but it is secondary to the railroad debt.

Judgment and the right to purchase same, at a foreclosure sale is sought by the railroad.

PEAR HARVESTING WILL REACH PEAK IN ENSUING WEEK

Harvesting of the pear crop of the Rogue River valley will start next week on its busiest period, with Booca, Comice, D'Anjou, Howells and late Bartlett, ripening and ready to pick, according to County Horticulturist Lyle P. Wilcox.

With all these varieties coming to the packing plants, and going to market, and storage, workers and machinery will be placed at a fast clip.

Many of the growers expect to start picking Booca and D'Anjou next Monday. Some of the D'Anjou will be picked the end of this week. Orchards are anxious to get the fruit harvested to avoid any storm. The Booca are now heavy and the afternoon breeze might blow them off. Some Howells are being picked this week.

This week is expected to see the final shipment of canner Bartlett. Up to last night, 345 cars of Bartlett have been shipped East. Most of the packed Bartlett have been placed in storage to await better market conditions—both domestic and foreign. Court Hall estimates that 80 per cent of the Bartlett crop went to the canneries at prices ranging from \$32.50 to \$35 per ton.

Packers, growers and fruit authorities have estimated that the returns from Bartlett will approximate close to \$600,000. This will enable the growers to pay off federal loans advanced for financing the crop. The loans aggregated approximately \$500,000, it is estimated.

According to Horticulturist Wilcox all varieties of pears are in good condition, of excellent size and grade, and free from blemishes and worms. Weather conditions have been ideal.

3 BALLOT THIEVES HAVE SERVED YEAR IN STATES PRISON

This week Walter J. Jones, former mayor of Rogue River; J. Arthur La Dieu, former business aide of L. A. Banks, local agitator, and E. H. Fehl, partner of Banks in turmoil making, have served a year in state prison, and all will be eligible next December for parole, when they will have served 18 months. One-third of their four-year terms for vote stealing, according to the district attorney's office. Their applications for parole are scheduled to be considered at the December meeting of the state parole board.

A year ago today Jones and La Dieu were sentenced and entered state prison a year ago next Thursday. Fehl was sentenced a year ago Monday at Klamath Falls, where a Klamath county jury returned a verdict of guilty against him in 12 minutes. Former Sheriff Gordon L. Schermerhorn, sentenced to three years and who entered prison three weeks ago with promise of a pardon in six months, was also sentenced a year ago.

The paroles are granted upon application of the prisoners and must have the recommendation of the sentencing judge, and in these cases the approval of the attorney general's office, plus good behavior.

Jones and La Dieu have been officers of prisoners. The ex-Rogue River mayor has been a machine shop door tender and La Dieu has been employed in a clerical position. Fehl is a cell-block janitor and Schermerhorn is employed on the prison farm, according to local authorities.

In all probability all the leading figures in the Jackson county ballot theft cases will be free by January 1, with the exception of Banks, serving life for second degree murder.

Thomas L. Brecheen, former Ash-

land realtor and politician, is scheduled to be released the end of the week. He has served a year Thursday of his 18 months' sentence.

The parole of Jean Conner, "the bright boy of Pinehurst," also expires this week. The leniency was extended by the court upon the condition that Conner refrain from radical utterances and remain outside of Jackson county for one year. Conner was last heard from in eastern Oregon, where he took a bride a year ago.
