

IDAHO GRAND JURY WILL INVESTIGATE EVAN CROW'S CASE

The federal grand jury for the Idaho district will consider the case of Evan L. Crow, bound over last Monday by United States Commissioner Victor A. Tengwald on a charge of uttering and passing a bogus postal money order on a Boise, Idaho, drug store, where a forged postal money order was passed May 25 last. The authorities say that McMahon identified Crow as the man who passed the forged money order and that previously McMahon picked out Crow from a group of prisoners in the county jail. McMahon came here from Boise on a federal subpoena. McMahon previously identified Crow from a department of justice photo, Postal Inspector D. R. Freeman testified at a previous hearing.

Crow, at the hearing before United States Commissioner Victor Tengwald last Thursday, and at its continuance last Monday, produced testimony of witnesses tending to establish an alibi, accounting for his presence in this city and Josephine county during the time the government alleges he was in Boise. Kin and friends testified that Crow left a mine on Galice creek, Josephine county, on May 22, where he was working, visited relatives at Merion on May 23, drove relative to a funeral at Grants Pass on May 24, and came to this city in the later afternoon of May 24, on an auto stage with his father. Witnesses at the hearing Monday testified to his presence in this city and vicinity on May 23 and 24, also on May 29, and in this city during the Diamond Jubilee week. The government contends that Crow's movements are accounted for only up to the late afternoon and evening of May 24; the defense that his whereabouts are established for the entire period, and that it would have been an impossibility to reach Boise from this section during the time in which the government alleges the crime was committed by Crow. The defendant holds that his movements are accounted for in all particulars, from the time of his release from the Oregon state prison at Salem January 15 last until the present.

The government also introduced samples of Crow's handwriting, voluntarily given, since his arrest and the postal money order. The government claims the money order is one of 100 or more stolen from the postoffice at Shaniko, Ore., on the night of May 17. The government does not charge Crow with the postoffice robbery. Crow is held in the county jail in lieu of \$5000 bonds.

NEW YORK, Aug. 23.—(AP)—The assertion of an administration spokesman that it is "squarely behind" the profit motive as the mainspring of business was construed in Wall Street today as an answer to the harassed executive's prayer. Some business and financial quarters had worked themselves into a rather bad state of jitters over rising costs of materials and labor, the prospect of increased taxes, and the continued urging of lower prices to the consumer. That the recovery program contemplated abandonment of the profit motive and its replacement by the motive of pure service, as contemplated in a state of complete socialism, was probably not seriously considered in many quarters. Nevertheless, business initiative does spring chiefly from the prospect of making a profit, and a feeling among executives that the likelihood of profit is all but ruled out, acts as a decided brake.

Business Hears Cheery Word on Roosevelt's Aim (Continued from page one) NEW YORK, Aug. 23.—(AP)—The assertion of an administration spokesman that it is "squarely behind" the profit motive as the mainspring of business was construed in Wall Street today as an answer to the harassed executive's prayer. Some business and financial quarters had worked themselves into a rather bad state of jitters over rising costs of materials and labor, the prospect of increased taxes, and the continued urging of lower prices to the consumer. That the recovery program contemplated abandonment of the profit motive and its replacement by the motive of pure service, as contemplated in a state of complete socialism, was probably not seriously considered in many quarters. Nevertheless, business initiative does spring chiefly from the prospect of making a profit, and a feeling among executives that the likelihood of profit is all but ruled out, acts as a decided brake.
