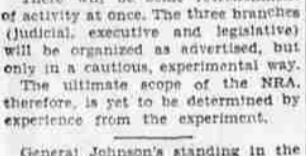

News Behind The News

 WASHINGTON, D. C., Sept. 13.—This rather indefinite NRA reorganization is really only a temporary poultice for the clawed-up black-and-blue eagle.



The announced purpose behind it is to heal existing open wounds in preparation for a thorough permanent health improvement program for the old bird in January. At that time President Roosevelt will submit to congress recommendations for permanent new industrial control legislation. You can depend on that.

There will be some retrenchment of activity at once. The three branches (judicial, executive and legislative) will be organized as advertised, but only in a cautious, experimental way. The ultimate scope of the NRA, therefore, is yet to be determined by experience from the experiment.

General Johnson's standing in the matter is not entirely clear, either to the general or anyone else. At the Hyde Park conference with the president, he was in an amiable mood. He was willing to do anything. Apparently he has sold the White House on the idea that industry is for Johnson. That may or may not be true. The way some industrialists talk around here, it is hard to believe.

Nevertheless, for that reason or others, the president is desirous of him having a fairly prominent position in the experiment.

Those who think they know the inside of the situation believe it is largely up to Johnson to determine his own position. He can either stay and help, or pass out of the picture. The only thing certain about it is that NRA is no longer to be a one-man organization and the reorganization is not going to be a one-man job.

Privately, the general is still plenty angry at Donald Richberg—and vice versa.

Johnson has an idea his ex-lieutenant sold him out and caused all his difficulties by going to the White House with the NRA situation before Mr. Roosevelt left for Hawaii.

Most of the innocent bystanders who know the inside on that matter agree Johnson's view may be natural. But it is hardly justified by the facts. At least, Richberg felt he was being loyal to the new deal, which certainly has a claim to his loyalty beyond that of the general.

A prominent peace-maker is now on the job to get these two to shake hands and forget it.

The ultimate disposition of Mr. Richberg likewise is uncertain. The general inner supposition is that he will remain in his present job as coordinator of the whole new deal. No announcement has been made yet, but Frank Walker probably will not return to that job, which he left last spring because his private business was suffering.

FURIOUS RIOTING BELIEVED INCITED BY COMMUNISTS

Government Orders All Known Radicals Held for Examination—American Legion Asked to Aid in Clean-Up

PROVIDENCE, R. I., Sept. 13.—(AP)—The arrest of every communist in Rhode Island was ordered at 9 a. m. today by Governor Theodore Francis Green. In announcing the arrest order, Green said he believed the furious rioting of the past two days in the textile strike was inspired by communists. Every chief of police in Rhode Island received this telegram: "Arrest immediately and hold for examination every known communist for possible connection with riots and disorders in this state."

Governor Green also asked the commanders of the American Legion and Veterans of Foreign Wars to supply 500 World War Veterans from each organization to be mustered into emergency service. They would be supplied with equipment from the state's military establishment.

HYDE PARK, N. Y., Sept. 13.—(AP)—President Roosevelt was ready today to send federal troops into Rhode Island if the need arises, but an official White House statement said none had been requested so far.

The official statement said: "The president is in complete and constant touch with the Rhode Island situation. It is, of course, hoped that disorders caused by irresponsible and disorderly individuals will terminate before nightfall."

"No orders have been issued for federal troops to go to Woonsocket or elsewhere."

Democratic politics tried hard to act as if they expected the Maine victory. They really did expect Governor Brann to win, but not by the majority he received. What knocked them off their chairs, however, was their victory in the first district, where republican stalwart Bredy went down to defeat.

NEW YORK STATE PRIMARY INTEREST CENTERS IN CITY

 New York—Nominations for state today for congress and state legislature.

Georgia—Re-nominated Gov. Eugene Talmadge yesterday, after his "Roosevelt and Talmadge" campaign stand.

Maryland—gave Gov. Albert C. Ritchie the lead for democratic re-nomination in yesterday's primary.

New York republicans and democrats made nominations in their primary election today for 43 representatives—the largest state delegation in congress—with many incumbents having opposition.

Most of the contests lay in New York city where only five democratic congressmen of 21 seeking re-nomination, were unopposed.

Gov. Eugene Talmadge won re-nomination yesterday in Georgia—where the democratic nomination means election.

Governor Albert C. Ritchie, democrat, obtained enough popular votes in a primary in Maryland to assure his re-nomination by convention for a fifth term. Harry W. Nice defeated Senator Phillips Lee Goldsborough and H. Webster Smith for the republican nomination.

George L. Radcliffe won the democratic nomination for senator. The race for the republican nomination by former Senator Joseph T. France, John Philip Hill and C. Wilbur Miller was close.

MEDFORD SCHOOL OPENING TO SHOW SMALL INCREASE

Registrations May Be Made Friday and Saturday—Book Lists Are Announced for Use of All Grades

All city schools, elementary, Junior high and senior high will open Monday, September 17th with an enrollment which promises to exceed slightly that of last year. Registration teachers will be on duty at the Junior and Senior high buildings Friday, September 13th from 9:00 a. m. until 3:00 p. m. and Saturday, September 14th from 10:00 a. m. until 12:00 noon.

Senior high school pupils who were not registered last spring (who were not in attendance at the close of school) are to report for registration Friday, September 14th. All senior high school pupils report to receive schedules and begin regular class work at 8:00 a. m. Monday, September 17th.

New Pupils to Report
 All 5th grade pupils and pupils in the 7th and 8th grades new to the Medford system are to present themselves at the Junior high school building between 9:00 a. m. and 3:00 p. m. Friday, September 14th. Pupils in the 7th and 8th grades who were in the Medford schools at the close of school last spring need not report until 8:20 a. m. Monday, September 17th at which time they will be registered and begin regular class work. All Junior high school pupils will report for regular class work Monday at 8:20 a. m.

All pupils who are 16 years of age or not later than October 26th may register.

Quintuplets Off In Weight; Medic Blames Weather

FALLANDER, Ont., Sept. 13.—(UP)—A drop of three ounces in the weight of Yvonne, one of the famous Dionne quintuplets, today was blamed by Dr. A. R. DaPoe upon weather conditions. Two of the others also lost a little weight.

Dr. DaPoe expressed a desire to have the babies moved into the special hospital built for them as soon as possible. The hospital is to be opened officially Friday, but the babies probably will not be removed into it then because it will require time for the building to be free of the smell of paint.

NO INDEPENDENTS FILE FOR PLACES COUNTY BALLOTS

Time for filing independent candidates for county offices expired yesterday, with none forthcoming at the clerk's office. Therefore, primary party nominees will go forth to battle in the November election without a third man in the races.

Earlier, a number of independent candidates were threatened, but the political pot never boiled up to the filing point. William N. Carle of the Applegate, at one stage, announced his intention of entering the legislative race as an independent, but changed his mind.

The candidates, all regularly nominated at the May election for the county offices are:

 For representative—Glenn O. Taylor, Medford, A. J. Brockway, Jacksonville, republican, both incumbents.
 A. Moore Hamilton, Medford, and William Greenbrier, Ashland, democrats.

For state senator—George W. Dunn, Ashland, (incumbent) republican.
 Judge E. K. Kelly, Medford, (write-in nominee) democrat.
 Circuit Judge H. D. Norton will be unopposed in the November vote for the circuit judgeship, as he was given a decisive majority over both opponents in the May primary.

Registration books for the November election close Saturday, October 6, a month before the election. Unless registered under Oregon law, no person can vote. The law prohibits the "sweating in" of voters on election day. Residents who have not voted within the past two years must register between now and the final date, in order to vote.

HUNTERS TO USE WOODS IS WORD

PORTLAND, Sept. 13.—(AP)—Assurance was given the state game commission today that Oregon forests will not be closed to hunters, providing camping regulations are complied with, and unless increased fire hazards makes it necessary.

A set of regulations for fire prevention have been adopted. Each person entering a state forest will be required to report to the nearest forest officer or fire warden, to ascertain where camping will be permitted.

Until general rains reduce the fire hazard, these regulations will be in effect.

MANY CANDIDATES GET BALLOT SPOT SANS PARTY HELP

Over One-Fourth in State and Districts Nominated After Primaries—More May Be Named by Petition

SALEM, Sept. 13.—(AP) Basing his action on the attorney general's oral opinion, the secretary of state today refused to accept the certificate of nomination of J. E. Bennett, Portland, as an independent candidate for congress. As a result Bennett's name will not appear on the November ballot.

SALEM, Sept. 13.—(AP)—More than one-fourth of the state and district candidates whose names will appear on the November 6 ballot in Oregon were placed in nomination after the regular primaries of last May. It was recorded at the close of filing here last night. Sixty-seven names were received either by nomination of assemblies, conventions or by central committees to the regular 191 nominees.

Possibility of several more which may be named by petition up to September 21 were listed. These would only be for district offices. It was indicated, since it was known no statewide petitions are in circulation. For state offices two per cent of the number who cast votes for the last presidential electors are required to nominate by petition while three per cent is necessary for district offices.

Mostly Independents
 Most of the new candidates are independents with the exception of a few.

No estimate of the loss was available. The plant was located at Second and B streets.

Six firemen suffered painful burns and one man was taken to a hospital after being overcome by smoke. The firemen checked spread of the flames in late afternoon without material damage to adjacent buildings.

HIGHWAY RANCHER BLOWS HEAD OFF WITH HEAVY RIFLE

Having committed suicide either Sunday night or Monday morning, the body of Richard Lawrence McDonough, 50, farmer, was found in his cabin on the Pacific highway one mile south of the Klamath Falls junction yesterday at 4 p. m. with the top of his head blown off from a bullet from a .30-30 Winchester rifle.

State police and Deputy Coroner Will Dodge of Ashland were notified by Archie Spence, a neighbor, who went to the McDonough ranch on a visit, discovering the body in a rocking chair with the gun clutched across its lap. There was no doubt in the mind of officials that McDonough had shot himself.

Opinion of state police and the deputy coroner led to belief that the tragedy had occurred Sunday night or Monday morning, due to the condition of the body, and the fact that McDonough was last seen Sunday afternoon.

Seen on Sunday, James Busch, one of the investigating state officers, said he had talked briefly with McDonough at 3 p. m. Sunday at the Klamath Falls junction. Spence, who lives near the highway a quarter of a mile north of

FORMER SENATOR LORIMER PASSES

CHICAGO, Sept. 13.—(AP)—Former U. S. Senator William Lorimer, 73, dropped dead today in the Chicago and Northwestern depot.

The one time republican political leader had collapsed on a train arriving from his home at Crystal Lake, Ill., and died in the rest room at the station.

Once recognized as the "blind boss" of Illinois republicans, he had served 12 years in the congress and then was elected by the Illinois general assembly in 1909 to the U. S. senate.

THREAT AGAINST LINER'S OFFICERS TOLD AT HEARING

Radio Operator Said He Would 'Fix the Mates' Is Testimony of Morro Castle Seaman at Inquiry

HAVANA, Sept. 13.—(AP)—Captain Oscar Hernandez, chief of the Havana port police, said today he had learned that the majority of the "Latin" members of the crew of the ill-fated liner Morro Castle were communists.

NEW YORK, Sept. 13.—(AP)—Geo. Alagna, second radio operator on the Morro Castle, told him he "would fix the mates," Robert Beresford, a seaman on the burned liner, declared today at a department of commerce inquiry into the disaster.

NEW YORK, Sept. 13.—(AP)—Another name was added today to the Morro Castle death list, bringing the total number of dead and missing to 134.

William Hassler, 71, died shortly before last midnight at Bellevue hospital. Hassler, a passenger, was taken from a rescue ship Saturday afternoon suffering from pneumonia.

Shortly after Hassler's death here two fishermen at Manasquan, N. J., came upon the body of Charles Hiss, 34, who also was a passenger on the cruise liner. He had been listed as missing.

Only yesterday hope was expressed that Elia, president of the Passaic, N. J., glass works, might have survived the disaster. His name was called in the court of common pleas at Patterson, N. J., for petty jury duty. There was no answer.

Still another Macabre note was struck when all that remained of the body of Captain Robert R. Willmott was brought ashore yesterday from the liner, beached off Astoria Park, N. J., and ordered held for examination by government chemists.
