By PAUL MALLON. (Copyright, 1934, by Paul Mallon) WASHINGTON, D. C., Oct. 27.—The bankers shook hands with the president, all right, but if you look behind it you will suspect that the president held out four fingers on them.

To all outward appearances, the affair was as inspiring as the Kentucky state emblem of two clasped hands over the motto: "United we stand, divided we fall." Everyone now seems willing to let it go at that and forget it.

The wiser heads among the bankers convened privately in a hotel room, which was not smoke-filled, soon after President Roosevelt concluded his speech. They agreed they had not received what they wanted from the president, and that they would have a job next day keeping the 3000 delegates pacified.

But this, they agreed, was a task which had to be done, so they performed some fast missionary work in discordant quarters. They were sufficiently successful to force the unanimous adoption next day of a compromise resolution pleading co-operation but demanding a balanced budget.

As far as history is concerned, it will be recorded that the bankers played a successful Romeo to Mr. Roosevelt's Juliet on the White House portico, but, backstage, the real scene bore some aspects of the rolling pin relationship of Jiggs and Maggie.

Bankers' eyes started popping when the president was introduced by Jackson Reynolds, renowned archbishop of rugged individualism. Bankers' ears went deaf with amazement when they heard Mr. Reynolds taking the side of the new deal.

One of Mr. Reynolds' friends on the platform nudged a companion during the address and said: "I'll bet Jackson doesn't believe a word he is saying."

As a matter of fact, they were all just about as dumfounded as you would be if Mr. Hoover suddenly should make an appeal for the new deal.

That feeling was increased by the fact that Mr. Reynolds was not an official of the convention. His name had not appeared on the program for the evening.

Investigation on the inside discloses that Mr. Reynolds prepared his speech hastily the afternoon of the meeting. Mr. Roosevelt also began the preparation of his speech between 2 p. m. and 3 p. m. the afternoon of the meeting.

Up to that hour rumors were current in the best informed quarters that the president's speech to the bankers would be confined to a few words of greeting.

It would not take a bank examiner to figure out what must have happened backstage on that. Apparently the White House did not intend to deliver a good one in return, a good one from an outstanding foe of the new deal.

The reason both sides were willing to go through under such circumstances is that the psychological result will be good. Conflicts are costly for both sides. Co-operation is more constructive.

Many of the bankers were still peeved about Mr. Roosevelt's reference in his previous radio talk to the way British bankers had co-operated with their government. The leaders of the convention, however, were determined to see that the best possible appearance of peace be preserved. They realized they could not get a balanced budget or currency stabilization now, but they had hoped for some of a promise that the president gave them. They concealed their disappointment with hopes that their ultimate objectives could best be served in that way.

The practical results are yet to be determined. That is, no one expects that the banks now are going to start lending money where they did not lend it before, as they express it. They are not going to finance fly-by-night promoters in speculative business schemes.

But, if for instance, the administration relaxes its credit examinations, there is a possibility that the banks will relax their lending restrictions commensurately. A step in that direction already has been taken. Loans marked "slow" by examiners formerly had to be called. Now there is another classification, "slow but good."

BUSINESS AGAIN URGES PRESIDENT TO STATE POLICY

Exactness Urged As Means To Establish Business Confidence — Definite Word On Money Plans Sought.

WASHINGTON, Oct. 27.—(AP)—Organized business, noting a growing rapprochement between the administration and industry, nevertheless renewed its request upon President Roosevelt today for a statement of his objectives.

The Chamber of Commerce of the United States placed particular emphasis in a fortnightly review of business developments on what it saw as encouraging signs that business men and the White House are finding a common approach to the problems of recovery.

There existed a "growing realization," the chamber said, that this peace "must come about through the revival of industry and employment."

But, it added, "further improvement is contingent upon the more explicit setting forth of administration aims in the legislation it will propose and the specific steps it will propose in carrying forward its program, when congress convenes."

Thus the chamber renewed its old time previously unfulfilled request for an exact statement of the Rooseveltian plans. Like its fore-runners, the repeated question is expected to go unanswered. Mrs. Roosevelt has made it abundantly clear that he has no idea of restricting his future policies on the currency relief methods and other vital questions by making definite commitments at this time.

The chamber saw indications of "a convergence of the general aims of business and the administration" in Mr. Roosevelt's speech before the American Bankers association, which was followed by professions of willingness to cooperate, expressed in formal resolution adopted by the delegates.

The convention, through its speeches and statements made by various representatives, bankers, brought out what apparently was a generally shared view that right at the moment business is picking up. There is a growing demand for bank credit and the volume of loans outstanding has been on the increase for the last month.

However, many speakers voiced the conviction that the chief problem of the day is still that of inspiring a feeling of confidence in the minds of the nation's business men which will lead them to expand their business operations.

DISCONTENT RIFE IN SIAM, AUSTRIA

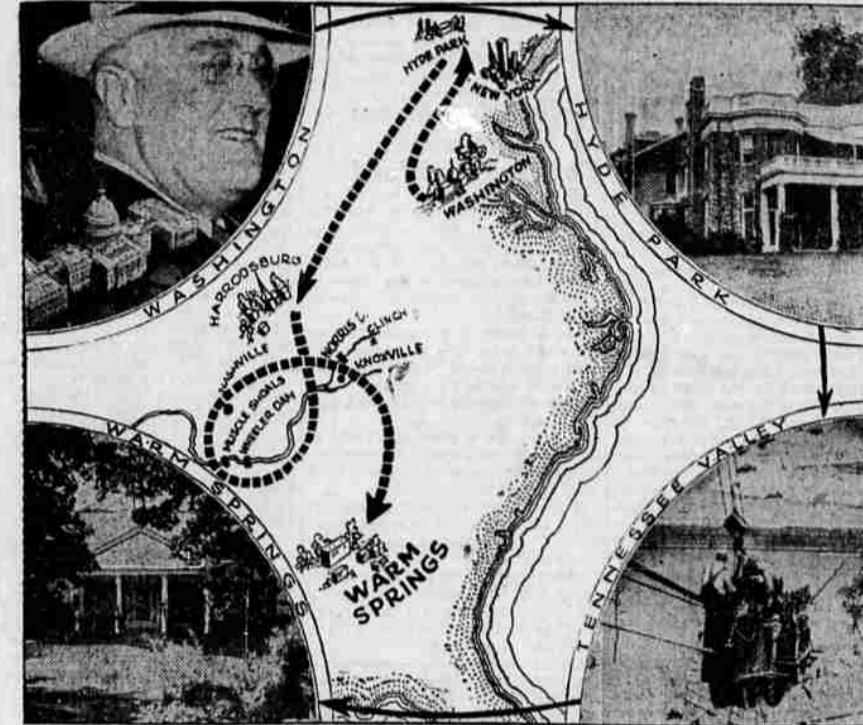
INSANITY WITNESS IS HELD CRAZY

PORTLAND POLICE CHIEF DISMISSED, NILES APPOINTED

Ousted Official Under Fire Since Waterfront Strike, And "Pay-Off" Charges From Chinese Gamblers.

PORTLAND, Ore., Oct. 27.—(AP)—Mayor Joseph Carson tonight announced the appointment of Police Captain Harry M. Niles as chief of the Portland police force to succeed Colonel B. K. Lawson who will retire December 1.

Chief Lawson, whose dismissal has been rumored for some time, has been under terrific fire since the summer waterfront strike. Chief Lawson has vigorously denied any knowledge of any "payoff" rumored in connection with continued operation of Chinese lottery and gambling dens.

In announcing the change in the department Mayor Carson paid warm praise to Colonel Lawson who was Carson's commanding officer in the army during the World war.

Captain Niles probably will take over the chief's duties some time before December 1. Mayor Carson said, Chief Lawson has vacation time due him and it is probable Captain Niles will take over the reins as acting chief about November 1.

Lieutenant John J. Keegan will be elevated to the rank of captain in place of Niles.

FRAUD CHARGE ON COUNTY OFFICERS BUSINESS HEADS

Seattle And Tacoma Men Indicted For Cheating On Sale Of Tractors And Failure To Deliver Wood.

TACOMA, Oct. 27.—(AP)—Three secret grand jury indictments charging 12 men—Pierce county officials and Tacoma and Seattle business men—with fraud and other illegal acts involving several thousand dollars, were made public today with the arrests of the defendants.

Those charged in the last group of indictments returned by the grand jury, which is probing governmental affairs are as follows:

County Commissioner R. Lester Kelly, Auditor C. H. Renschler, County Commissioner Cal Guthrie, County Treasurer John Murphy, John W. Hayes, treasurer American Plumbing & Steam Supply company; Joseph L. Long, president American Plumbing & Steam Supply company; Harold K. Munroe, vice president American Plumbing & Steam Supply company; Orrel R. Caldwell, Seattle Machinery salesman; Alfred J. Davis, president manager Pacific Fuel company; Kenneth Burnham, vice president Pacific Fuel company; Frank G. Bampton, secretary Pacific Fuel company, and M. A. Norman, vice president American Plumbing & Steam Supply company.

Both Commissioners Cal Guthrie and John Murphy, who are charged in previous grand jury returns, were named in two of the three of the last indictments.

The first indictment charges Davis, Burnham and Bampton of the Pacific Fuel company with defrauding the county out of \$1,089 by assertingly failing to deliver wood which had been paid for.

The second alleges that Hayes, Long, Munroe and Norman of the American Plumbing & Steam Supply company, and Caldwell, Commissioner Guthrie and Commissioner Murphy defrauded the county out of \$1,500 on the sale of two tractors.

Kelly and Renschler are co-defendants with Guthrie and Murphy on the third indictment, charging the illegal transfer of county funds growing out of the paying of a deputy auditor's salary from the three road districts.

REPUBLICANS JAB FARLEY APPROVAL OF 'EPIC' LEADER

G. O. P. Scoffs At Blaming Form Letter On "Dumb Stenographer" — Money Flows Jersey Campaign.

WASHINGTON, Oct. 27.—(AP)—Jumping into the administration mixup over the gubernatorial campaign of Upton Sinclair in California, Republican spokesmen today characterized Postmaster General Farley as "the world's leading expert on collecting dumb stenographers."

Referring to a form letter rubber-stamped with Farley's name, urging the election of the former Socialist, a G. O. P. statement asserted Democratic headquarters here had "concocted" an "alibi" by blaming the "mistake" on a minor employee.

"Democratic leaders made no immediate reply to this statement from the Republican senatorial-congressional committee, nor was there any denial of a solidifying opinion among observers here that the administration would withhold all support from Sinclair.

The mixup over Sinclair served to hide some of the other political developments of the day here. Some of them were:

A prediction by Representative Byrnes of Tennessee, chairman of the Democratic congressional committee, that Democrats would win both the senate and house by two-thirds majorities.

A return by Senator Kean (R., N. J.) reporting the biggest campaign fund of any candidate thus far, with contributions by himself of \$50,000 and expenditures of \$25,538 on exempt items, and \$19,432 for non-exempt outlays.

A statement by the Republican senatorial-congressional committee listing receipts of \$115,784 and expenditures of \$119,908 in the campaign.

A statement by the American Federation of Labor that 30 senators, who voted for the confirmation to the supreme court of Judge John J. Parker of North Carolina in the Hoover administration, were now out of congress.

The A. F. of L. has placed candidates for re-election on its blacklist. They are: Senators Fess, Ohio; Hatfield, West Virginia; Herbert, Rhode Island; Reed, Pennsylvania, and Walcott, Connecticut.

PORTLAND, Oct. 27.—(AP)—Because Portland merchants would not agree to close their stores all day Monday, Nov. 12, war veterans here have decided to hold their annual Armistice day parade in Vancouver where stores will be closed and where workers will be on holiday.

The commanders' council, composed of heads of various veterans' organizations in Portland and Multnomah county, reached this decision after the retail merchants' bureau of the Portland chamber of commerce and declared stores would be closed only one hour and a half on Nov. 12.

A meeting of Community Chest "shock troops" has been called for Thursday, November 1 at 7:45 p. m. in the south auditorium of the Jackson county court house, by General M. N. Hogan. Like the campaign of last year, the solicitation of chest funds will be made by workers organized in military fashion with five groups designated by colors and commanded by a captain and two lieutenants.

TOP GRID SQUADS KEEP UP WINS FOR NATIONAL HONORS

Two Southern Teams Lose — Minnesota Trounces Iowa — Louisiana Among Contenders — Eastern Prestige Jolted.

Title hopes of two powerful southern football arrays, Duke and Vanderbilt, collapsed yesterday in another all-star program marked otherwise by the continued advance of Minnesota, Illinois and Chicago in the Midwest; Army, Navy, Dartmouth, Princeton and Syracuse in the east; Stanford, Washington and Washington State in the far west; Alabama, Tplane and Louisiana State in the south, and Rice in the southwest.

Duke's Blue Devils, rated by most critics as the class of the southern conference, struck a Tarlar in their joust with Tennessee of the southeastern conference. The Volunteers, rallying from their defeat by Alabama of the week before, battled their way to a 14-6 triumph. Vanderbilt's Commodores, meanwhile, found themselves overpowered by Jones' Louisiana State Tigers, 20-0, and saw their chance of winning of sharing in the southeastern title go by the boards.

By its convincing victory, Louisiana State projected itself squarely into the championship race along with Alabama and Tulane, both of which won. Alabama, the defending champion, just about tore Georgia apart, 26-6, but Tulane was hard pressed to whip Georgia Tech, 20-12. Already a favorite for the Big Ten title, Minnesota became an odds-on choice as the Gophers showed tremendous power in crushing Iowa's Hawkeyes, 48-12. Remaining in the battle for the title was Illinois, which barely nosed out a fighting Michigan, 7-6. Chicago and Purdue, the only other teams undefeated in conference play, won from non-conference opposition. Chicago overcame stubborn resistance from Missouri to win, 19-6, while Purdue rolled over Carnegie Tech, 20-0.

Although the east suffered new joits to its gridiron prestige in Carnegie Tech's defeat and the 25-14 lacing Southern Methodist's Mustangs draw with New York university, there was one upset of major importance. Providence's 13-7 victory over Boston college.

In the southwest, Rice hurled another big obstacle in its drive to the title, whipping Texas, 20-9, while Texas A. and M. was breaking its losing streak at Baylor's expense, 10-7, and Texas Christian was bowing at Centenary, 15-0.

Ohio State, upset two weeks ago by Illinois, again showed strength in a 28-8 romp over Northwestern. Notre Dame easily topped Wisconsin, 10-0, while Temple stopped Marquette, 28-6.

OREGON TRIUMPHS OVER UTAH 8-7, VAN VLIET STARS

Tight Line Blocks Scoring Threats Often—Safety In Third Period Gives Victory Margin.

SALT LAKE CITY, Oct. 27.—(AP)—Spurred on by a howling crowd of 20,000 persons—the largest ever assembled for a football battle in this state—the University of Utah Indians battled a favored Oregon university eleven on even terms in an inter-sectional clash here today, but the Ducks won, 8 to 7.

The margin of victory was a safety which the Eugene team tallied in the third period, when its surging line broke through Utah's forward wall and another Glen Arnett's punt deep in Utah territory. The ball rolled over the Utah goal, giving the Ducks two points, which proved to be winning markers.

Rated the underdogs by two touchdowns, the Ute line played perhaps the greatest game an Ike Armstrong coached forward wall ever turned in. Time and again the Ducks fought their way to the shadow of the Indian goal, only to be held in check—except on one occasion.

It was two midget backfield stars—Newell Call of Utah and Maurice Van Vliet of Oregon—who furnished the fire of the large crowd. Van Vliet was a constant threat with his beautiful off-tackle and end runs, while Call, a sophomore, tipped off a 50-yard run in the final period to place Utah in scoring position.

The Webfoot center threatened early in the first period when a pass, Reichman, quarterback, to Van Vliet, placed the oval on Utah's 20-yard line. A series of line bucks carried the victors to the three-yard line, but Utah took the ball on downs. As the period neared an end, Van Vliet tossed a 40-yard pass to Reichman, who took the ball on the run and crossed the goal standing up. Reichman missed the attempted placement.

The Redskins marched down the field on a series of brilliant scrimmage plays in the second period, but the end of the half checked the drive on the Oregon seven-yard line.

A recovered fumble gave the Ducks the ball in Utah's territory early in the second half and they marched to the Redskin three-yard line, but Danny Savich, Utah's sensational player, stopped Van Vliet with a three-yard loss on fourth down and Utah took the ball. Arnett kicked out of bounds on Utah's 40-yard line, but the Ducks were offside and were penalized five yards. On the next play, Arnett's punt was blocked and a safety resulted.

After a somewhat hapless 10 minutes of play in the final period, Call, who weighs only 145 pounds, dashed off-tackle for his 80-yard sprint only to be brought down on the Oregon five-yard line. Joe Hinaldi, halfback, plunged through center on the third play to give Utah a touchdown, and Ed Sid Kramer, halfback, added the extra point with a perfect placement.
