

GOVERNOR RACE BURNING ISSUE BEFORE VOTERS

Interest Grows As Vote
Nears—Brown Comes Out
for Martin—General Hits
Dunne Promise Campaign

PORTLAND, Nov. 2.—(AP)—With a parade of candidates clamoring for the attention of the sovereign voter, Oregon's fall political disturbance today had reached that exciting stage sometimes described as "the crisis."

If the multitude of candidates takes a holiday on Sunday, as it probably will, tomorrow and Monday will tell the story. For on Tuesday next the voters, tolerant in the realization that they, after all, have the last word, will tramp past the ballot boxes.

Thus a new governor will be elected, three congressmen will be sent to Washington, a secretary of state will be selected, three measures will be acted on, a state legislature will be filled out, district attorneys will be chosen and a host of other officers will be assigned.

Governorship Is Hot.
Throughout Oregon, the burning question has been, "What of the governorship?" By comparison there has been little interest in the other issues before the voters.

Dunne, Martin or Zimmerman—whichever of the three? The voters have asked each other. And the three—Dunne the Republican, Martin the Democrat, and Zimmerman the "Fighting Progressive," have covered the state in their eagerness to supply the answer.

Complications set in as the crisis neared. Two defeated candidates for the gubernatorial nomination, James Brown and Sam Brown, stepped into the race for the governorship with words of advice to the voters of the state.

One of these, Sam Brown, Gervais farmer-legislator, who for years has borne aloft the banner of Republicanism, last night made the striking declaration: "I place loyalty to the state and to its people ahead of loyalty to party."

He left no doubt, without having actually said so, that Martin, the Democrat, is his choice for the governorship. Tonight, Willis E. Mahoney, mayor of Klamath Falls, who was beaten out for the Democratic nomination as governor by Martin, just as Brown was beaten out by Dunne, will take the radio over an extensive state hookup, to tell what he thinks of the situation. Not even the subject of his speech was revealed today. News-

paper advertisements disclosed the "Mahoney club's committee" was making arrangements.

At an enthusiastic meeting of the Willamette Democratic society here yesterday, Martin criticized what he characterized as ridiculous promises made by his opponents, and declared if it were necessary for him to tie his hands with promises which are impossible of fulfillment, he doesn't want the job.

Dunne Says He's Free.
Dunne, in an address last night, stated, "I am free—not a single promise. If he is elected, he said, 'an open door is assured any citizen of Oregon, whether he is in overalls or high hat, he will be welcome.'"

Zimmerman, the Independent, speaking in the municipal auditorium last night, assailed "the power interests," urged passage of the Grange Power bill as a means of preventing private exploitation of Bonneville, and put in a few words for his state bank plan.

JEFFERSON TITLE HOPE DASHED WHEN STAR DISCOVERED INELIGIBLE

PORTLAND, Nov. 2.—(AP)—The football title hopes of Jefferson high school were smashed into broken bits today.

After having gone through the season without defeat and without being tied, the Jeff team today had two game forfeitures smeared upon its record.

School officials took this action when they determined that Frank Budrow, substitute fullback, was ineligible because of age.

This left Washington high at the top of the pack with four wins, one tie, no loss and a 1,000 percentage.

The ironical part of the controversy is that Bel Ell, Jefferson's ace fullback, who had been suspended pending determination of his age, was not the cause of Jeff's shattered hopes. His suspension has been lifted, and the school lost no games because of it.

On the other hand, Budrow, groomed as Ell's understudy when it appeared Ell would be eliminated, finds himself the "goat."

Athletic regulations provide that no player may have reached the age of 20 before the school term opens. He may reach that year after the start of the school year without penalty.

The jolt to Jeff will not have any bearing on the Armistice day game in which Jefferson will play Washington high.

ROOSEVELT SETS LOW INTEREST ON BUILDING LOANS

ing act could be used to stimulate \$10,000,000 worth of home-building within a decade.

He stressed particularly the building of suburban or country homes for industrial workers on fairly large plots so they could raise much of their own food and thus become "partly independent of wages." It has been noted that Harriman's ideas in this respect closely resemble those of the Roosevelt administration.

Declaring such homes could be built by mass production for \$2000 or less, he told the National Paint, Varnish and Lacquer Association:

Huge Program Visualized.

"With an accumulated shortage of housing in this country now, and with the undoubted impetus there is to slum clearance, and to more adequate housing, I believe a housing program that would contemplate the construction of even as many as 750,000 houses a year for the next ten years is not impossible of attainment."

He calculated that each new home would mean the equivalent of the employment of two men for a whole year. Thus, if 750,000 houses a year were built, it would mean putting 1,500,000 persons back to work.

Harriman emphasized that the work should be done by private industry.

"The housing act would seem to afford an existing means for the execution of such a program as I have outlined," he said.

At present the housing act limits the total amount of mortgages on new homes which may be insured to \$1,000,000,000 but gives the president power to increase that sum if he deems advisable. Just now the loan insurance is limited to homes in or near urban communities.

Maximum Rate Set.
While the approved "basic interest" rate for loans for constructing one-family to four-family houses was set at 8 per cent, the maximum basic rate for refinancing existing homes will be 5 1/2%.

Mortgages calling for higher basic rates would not be insurable under the government's mutual plan. To the "basic maximum" for refinancing houses already existing must be added 1 per cent a year for insurance, and, in case there is a change of lender in the transaction, a service charge of 1/4 of 1 per cent.

"This is the first time in the history of finance," a statement by the housing administration said, "that a uniform basic interest rate has been applied to private capital in the United States."

Insured mortgages may range as high as \$16,000 each and may run for periods up to 20 years.

Uniformity Aim.

Moffett made public letters exchanged between himself and the president.

The president stated that he realized a uniform rate at the beginning might cause less response in some sections of the country, but declared "the national housing act should not foster the continuation of high interest rates on insured mortgages in any part of the country."

Exorbitant second mortgage rates were cited by the president with the statement that "these methods and practices in the field of home financing have been the opposite of commendable."

DUCK HUNTING REPORTED GOOD

Reports received in Medford from the few duck hunters who have recently made trips into the Klamath region, reveal that hunting continues excellent, with rains providing good weather conditions. Tule lake is said to rank as one of the best spots for pursuit of waterfowl.

The season has shown a decided decrease in the number of hunters who have gone out over the past two shooting periods, but it is expected that many will renew activities with pheasant season in the past. Today several hunting expeditions are starting into the eastern marshlands, while more will get away tomorrow.

Hunters are reminded by authorities that shooting is only allowed on Fridays, Saturdays and Sundays, and that purchase of a federal migratory bird hunting stamp, at the postoffice for a fee of \$1, must be made before any birds may be taken lawfully.

E. D. HILL, VETERAN OF CIVIL WAR IS TAKEN BY DEATH

Erwin D. Hill passed away at the home of his daughter, Mrs. Frank Hill, on the Butte Falls highway, near Eagle Point, Ore., November 2, 1934, at 1:15 a. m. after a serious illness of the past three days.

Mr. Hill was a veteran of the Civil War and served with the Fourth Ohio cavalry as a bugler. Mr. Hill's grandfather, Ira Z. Hill, served his country during the revolutionary war.

During the Civil War, Mr. Hill and his father, Dan Hill, led a campaign through the state of Ohio, electing for Abraham Lincoln in his second campaign.

He saw very active service during the Civil War and was mustered out at Louisville, Ky., and returned to his former home in the town of Marietta, Ohio, later removing to Napa, county, California, where he resided for many years. He also resided in Medford and Ashland with his daughter, Mrs. Frank Hill, of Eagle Point.

He was the last surviving member of Kit Carson Post No. 74, G. A. R. Mr. Hill played in the fife and drum corps of Medford and Ashland for many years. He was a man of fine Christian character and was beloved by all who knew him.

Erwin D. Hill was born June 21, 1842, at Lower Salem, Ohio, and was married to Mabel Elizabeth Babcock September 5, 1871. Mr. Hill is survived by one son and five daughters, all of whom reside in California, except Mrs. Carrie H. Hill of Eagle Point.

There are a host of other relatives who mourn his loss.
