

### SAM H. BROWN URGES VOTERS TO OPPOSE JOE DUNNE

#### Prominent Republican Declares Loyalty to State Should Be Held Above Loyalty to Party Machine

SEASIDE, Ore., Nov. 2.—(Sp.)—"I place loyalty to the state and to its people ahead of loyalty to party," said Senator Sam H. Brown, Republican, in a recent address here. He added:

"If by chance, men who are unprepared to receive the party's nomination, remember that your duty to your state and its people takes precedence over your loyalty to the party."

Supplementing his radio talk of October 11, the Republican senator from Marion county again assailed Joe E. Dunne, Republican candidate for governor, and some of his so-called "Four Horsemen."

He continued: "Party loyalty has taken on a different meaning to me after years of service as a member of the legislature."

"As I sat in the legislative halls by day and in the committee rooms by night and witnessed behind the scenes the working of the party bosses who are the leaders of this invisible government, I was seized by a revulsion of feeling that demanded that I take no part in the betrayal of my state."

"Behind locked doors these bosses meet and map out ways and means to exploit the state and its people. Despite the protests of loyal and honest members of the legislature, who really have the interest of the people at heart, these bosses pick out hirelings who can be relied upon to do their bidding and can nearly always muster up enough strength to carry out their wishes."

"From these meetings spring the oppressive laws against the interest of the people. "Under no form of government and under no party will there be good government unless, and until, the people select competent officials. A competent official is one who has the ability to understand his duties and to perform them efficiently. He must be honest, and he cannot be honest if his official conduct is guided by political bosses or political interest, either for himself or for his party."

"In the selection of our governor it must be remembered that he is practically one-third of the legislature, and on his shoulders rests the responsibility of helping to enact honest laws in the interest of the entire state. It is also his duty to veto vicious legislation that is against the interests of the people."

"He must be courageous, one willing to fight, one aggressive in the work of reform. If by chance men who are unfit happen to receive your party's nomination, men who never led or were a party to any reform movement, who never denounced graft, who always have been regulars and placed party organization above the public welfare, who are supported by a gang of political buccanniers, who see in the administration of government, not the welfare of the people but an opportunity to despoil for private gain—REMEMBER THAT your duty to your state and its people takes precedence over your loyalty to the party."

### SURVIVOR OF MODOC INDIAN WAR BURIED

ALTA, Cal., Nov. 2.—(UP)—Elsie Crooks, 77, well-known Indian woman and survivor of a battle between federal troops under General Crooks and Modoc tribesmen, was buried at Lodi today as her friends and relations wept beside her grave.

At the time of the Modoc battle, Mrs. Frie, wife of an Indian doctor, was only a child. Her father and brother were killed in the fighting. Indians from Stacoeal, Bieber, Lookout and other parts of the Modoc country attended the funeral.

### TRAINMAN KILLED WHEN TRAINS HIT

CLOVERDALE, Ind., Nov. 2.—(UP)—Two freight trains on the Monon route crashed head on near here last night, killing one trainman and injuring several others.

The conductor of one of the trains, identified only as Sackett, was killed and several of the crew of both trains injured, according to reports received here.

### BODY IN SLOUGH HAS ROCK TIED TO NECK

KELSO, Wash., Nov. 2.—(UP)—The body of a man, unidentified, was found in a slough two miles north of Woodland today. A large rock was attached to the man's neck by a rope. Officers believed it was a suicide case.

### VETERANS PAYING FASTER ON LOANS

BALEM, Ore., Nov. 2.—(UP)—Improved business conditions and operation of a county system of collections were ascribed today as reasons for a healthy boost in collections by the veterans' state aid commission.

Jerold Owen, secretary of the commission, reported collections during October totaled \$152,278.18, greater than for any corresponding month since 1931 and largest for any month since January, 1932.

The first 10 months of this year the commission collected \$1,304,285.60, or \$184,491.33 more than in the same period of 1933. Seventy-five per cent of the commission's property now is rented, compared with 65 per cent a year ago.

### RIVAL UNIONS IN PITCHED BATTLE; SCORES INJURED

WILKESBARRE, Pa., Nov. 2.—(AP)—More than a thousand miners—members of rival unions—fought a battle with stones and clubs at dawn today at the No. 7 colliery of the Susquehanna Coalieries company at Nanticoke.

Scores were cut and bruised, but none seriously hurt in the fight, which raged for two hours. The riot was precipitated by efforts of the newly formed Anthracite Miners of Pennsylvania to close the colliery in protest against the alleged dismissal of several of their members.

United Mine workers of America sought to keep the mine in operation. The fighting extended from the colliery entrance over an area of several city blocks and from the sides and culm banks, some of them 80 feet high.

Automobiles were overturned, sticks and stones were hurled and hand-to-hand fights broke out in a dozen places. Nanticoke police were helpless to stop the battle.

By 9 a. m. Nanticoke was quiet. The crowd dispersed after scores of the United Anthracite miners were routed.

### HUNDREDS KILLED IN ANNAM STORM

SAIGON, French Indo-China, Nov. 2.—(AP)—Between 250 and 400 persons were reported today to have been killed by a typhoon which devastated the coast of Annam October 25.

Five thousand houses were wrecked by the great wind. The incomplete reports which reached here said all the crops were destroyed along the 180 miles of the coast from Vinh to Bongha.

Eight inches of rain swept in with the typhoon. Donghol province was hardest hit.

to avoid coming back to Chicago and being prosecuted as part of a political campaign—purely."

The 74-year-old defendant admitted, waving his hand emphatically at the jury.

When he arrived in Greece, he had "somewhere between three and four thousand dollars," Insull told the jury.

"Have you any property?" asked Defense Attorney Floyd E. Thompson. "Not that I am aware of. I would very much like to find some."

"Have you paid me any fees?" Thompson asked. "No, sir," said Insull. "I haven't paid you a cent. I understand some friends of mine whose names I don't know, have provided the necessary funds for my defense."

Insull's story of his European trip started with his resignation in June, 1932, as a receiver for the Middle West Utility company, after he was told some of his actions as chairman of that company "might come under review of the courts."

### HIT RUN DRIVER HELD AS SLAYER

PORTLAND, Ore., Nov. 2.—(AP)—Police today arrested Chas. M. Deals on a charge of involuntary manslaughter and hit-run driving in connection with the death Wednesday of Frank Green in a traffic collision.

"I lost my head and fled," the officer-captain Deals told them. His bail was set at \$2,500. Police said he admitted having struck the motorcycle on which Green was riding. A door handle, recovered at the scene of the crash, was said to have fitted the door of Deals' automobile.
