MEXICO CATHOLICS STONE RED SHIRT QUARTERS; 5 SHOT

Bitter Church-State Conflict Grows More Grave As Riots Continue—Church Defies Socialism Edict

By CLARK LEE Associated Press Foreign Staff MEXICO, D. F., Jan. 9.—(AP)—Mexico's bitter church-state conflict grew graver today after five persons were shot during a demonstration against the radical red shirt organization...

A crowd estimated at 1500, most of them students, attacked the headquarters of the red shirts' group, sworn enemies of the church, and five fell before the defenders' fire. The demonstrators smashed windows and tore down the red shirts' flag...

Demand Resignation. The students gathered to demand the resignation of Tomas Garrido, founder of the red shirts and federal secretary of agriculture, whom they charged with responsibility for the slaying of five Catholics when they emerged from worship in suburban Coyacan two Sundays ago.

Police and firemen playing streams of water, dispersed the crowd. Reforming in front of the red shirts' headquarters in a downtown building, the students pelleted it with stones. From inside, where there were 26 members of the organization, came a number of shots which were answered from the crowd.

The church's challenge to the government was made in a pastoral letter written in San Antonio, Tex., by the cardinal, Cardinal Garcia, who instructed Catholics not to permit their children to attend schools in which socialist education is taught. Under a recent amendment to the constitution, socialism must be taught in all public schools.

MEXICO, D. F., Jan. 9.—(AP)—Seven persons were shot to death and four wounded in a battle between federal troops and alleged plotters against the government at La Placida, in the western state of Michoacan, dispatches said today. Soldiers trapped four suspected members of the regime in a house and killed them after a brisk gun fight. A soldier, a policeman and a passerby were killed by fire from the house.

The war department announced a number of rebels and several federal troops were slain in a recent fight on the boundary of the states of Durango and Sinaloa, which adjoin Michoacan. Reinforcements have been sent to pursue a strong force of insurgents.

U. S. SAARLANDERS GO HOME TO VOTE SAARBUCKEN, Saar Basin Territory, Jan. 9.—(AP)—Led by 3-year-old Katherine Oberst of Los Angeles, 386 American Saarlanders arrived today to vote in next Sunday's plebiscite. Defying the plebiscite commission's order against mass demonstrations, the Nazis' German front gathered 15,000 enthusiasts at the railway station to give the Americans a rousing welcome.

Of the 380, about 300 are eligible to vote. They entered the Saar Basin territory from Germany, where they were voted in Berlin and Hamburg. The Americans carried their suitcases for a half mile through a solid line of Saarlanders singing "Deutschland Uber Alles" and with their arms raised in Nazi salute.

REGISTRATION AT SONS UNCHANGED ASHLAND, Jan. 9.—(Sp.)—Registration at the Southern Oregon Normal school is approximately the same this term as last, reports President Walter Redford. Although he stated that an increase is expected before the period of enrollment ends on January 12.

A total of 315 students attended last term, with the same number again having completed registration, although the student body personnel had changed with withdrawals and new enrollments.

Two new music courses have been added to the curriculum, including harmony and orchestra directing. The first is taught by Miss Louise Woodruff, and Miss Lucile Landon in the instructor in orchestra directing.

LADIES WILL RUN RABBIT SOCIETY TALENT, Jan. 9.—(Sp.)—Administration of affairs of the California-Oregon Rabbit and Fur Breeders' association during the coming year will be in the hands of the lady members of the organization.
