FLEMINGTON, N. J., Jan. 25.—A guttural, but crisp "I did not" was hurled today by Bruno Richard Hauptmann to every detail of the state's charge that he kidnaped, murdered and collected ransom for Baby Charles A. Lindbergh, Jr.

"I never saw the Lindbergh baby alive or dead," he declared.

He denied each and every step of the state's case—the stealing of the child, its murder, the writing of the ransom notes, the construction of the kidnap ladder, the handling of the baby's sleeping suit, or the collection of the ransom from Dr. John F. (Jafale) Condon.

Says Money Fisch's.

He met the point he could not deny—possession of \$14,600 of the \$20,000 ransom money in his garage—by saying it was left with him in a box by the dead Lindbergh, and that it lay in a closet in his home from December, 1933, until August, 1934, before he discovered it contained money.

He had not completed his direct testimony at the luncheon recess, and just before that time he denied that he had paid for a theater ticket with a ransom bill on November 26, 1933—a date prior to the day on which he said Fisch gave him the money.

He had been so identified by Mrs. Cecile Barr, Sheridan theater cashier, never in theater.

"I was never in the theater in my life," he said.

He said the box given him by Fisch lay in a closet through which rats leaked, and that it was accidentally broken apart when he struck it with a broom. It was then, he said, he discovered it contained the money.

"She was practical falling apart," he said. "I guess it was four bundles in there. Dem bundles was mostly mesh up, but must be wrapped in paper, not in thick paper, in thin wrapping paper, brown newspaper. And there was newspaper in the box too. I guess they wasn't filled up at all. It was empty space. I took the money out, squeezed the water out."

"All right you took the money into the garage; what did you do with the money?" asked Edward J. Reilly, his chief attorney.

Knew Fisch Dead.

"Now, you know did you that Fisch was dead when you found this money?"

"I know it, yes."

"Now, after drying it, what did you do with it then?"

"Well, when I took it down, I took a few of them, I guess two or three I took out and put in circulation."

Hauptmann's testimony drew a packed courtroom, and the air was made stifling.

"Were you ever in Hopewell in your life?" Edward J. Reilly, defense chief attorney, asked.

"I was not," he said in his heavy guttural way.

He was deadly serious.

"On the night of March 1, 1932, were you on the grounds of Colonel Lindbergh's estate at Hopewell, New Jersey?"

"I was not."

"On the night of March 1, 1932, did you enter the nursery of Colonel Lindbergh?"

"I did not."

Answers Snapped

"And take from the nursery Charles Lindbergh, Jr.?"

"I did not."

The answers snapped.

Reilly called his attention to the original ransom note left in the nursery and asked him:

"You never saw it except in the court room?"

"Did you write it?"

"I did not."

"Did you leave it in the Lindbergh nursery?"

"I did not."

Tells Movements

Hauptmann said that on March 1, 1932, the day of the kidnaping, he woke up at 6 a. m., "took the wife down to the bakery," then went home, then to the majestic apartments intending to work. The superintendent told him there were no jobs for that day, he said, so he went on to two employment agencies and to Radio City in a futile effort to get a job. He returned home around 6 p. m.

He called for his wife at the bakery, her place of employment, at 7 p. m., he said.

"Tell us what you did there that night."

"I took the police dog out. I went to the corner of Boston road, went a little farther up. I met a gentleman. I guess he was putting gas in the machine station and he was talking about the—about the dog. And he was asking me where I get him."

Hauptmann said this was between 8 and 8:30 p. m. He returned the dog to the bakery and left with his wife after 9 o'clock.

"What did you do?"

To Bed Early

"I went home. We went home. Took the car in the garage. Went right away to bed."

He said they arose on March 2 at 6:00 a. m., and he took his wife to the bakery, went home and then to a subway.

"In entering the subway station," he said, "I read the paper and that is the first time I read about the Lindbergh case."

"You didn't know Colonel Lindbergh did you?"

"No, sir, I did not."

Colonel Lindbergh, at the prosecution table, was sitting bolt upright and watching Hauptmann intently.

Hauptmann denied categorically the writing of each of the 14 ransom notes, and declared the first time he ever saw Dr. John F. (Jafale) Condon, ransom intermediary, was in a Bronx police station after his arrest last September 19. Dr. Condon testified for the state that he twice met Hauptmann and paid him the \$20,000 ransom in a Bronx graveyard.

Denies Writing Notes

He was asked about each note, and each envelope separately, and he denied each of them it was in his handwriting or that he had sent it.

He identified the box of tools in the state's evidence as his.

Referring to an envelope addressed to Condon, Reilly asked him if he had mailed the letter on March 19, 1932.

"I did not," he said.

"Did you have anybody mail the letter for you?"

"No sir."

"Is that your handwriting?"

"It is not."

These denials were in the face of testimony by eight handwriting experts, one of whom had said that the handwriting evidence against Hauptmann was "irresistible, unanswerable and overwhelming."

Reilly took his client over each detail of the crime and drew a denial of knowledge for each and every one.

Reilly held up baby Lindbergh's sleeping suit.

"Did you take this sleeping suit off baby Lindbergh at any time," he asked.

It is some of the presidential powers. Shell had hurled a charge that the funds would be used for 1936 "as you used money last summer when you sent a million dollars into Maine for the simple purpose of influencing voters."

Make Dictators Jealous

Representative Treadway (R. Mass.) had said the bill would make Hitler and Mussolini "green with envy of the president and Stalin will have a fit of jealousy."

"Among the attempts that failed was a move by Representative McFarlane (Dem. Tex.) to attach to the measure the Patman bill to pay the \$2,100,000,000 bonus with new treasury notes. It was ruled out of order.
