

TEACHER BLAMES LOVE TANGLE FOR NAZI PROSECUTION

American Accused of Espionage Acquitted After Nine Months Spent in German Jails — Is Pitiable Sight

BERLIN, April 12.—(AP)—Richard Bolderer, pale, nervous, naturalized linguist, shouted his opposition to war and dictatorships today and was acquitted today of espionage charges by five stern Nazi judges of the people's court.

The session, open to the public, lasted five hours and 20 minutes and the judges deliberated for another 45 minutes. The warrant against the former Cleveland and Chicago man was quashed and the state was ordered to bear the costs of the proceedings.

Bolderer, who spent nine months in a Munich jail before he was transferred to Berlin for trial, was a pathetic figure. He was red-eyed and pale and his face deeply lined and pallid. His nose was scarred from a fall.

Accused Deathly White
The face of the accused was deathly white, his mouth twitched spasmodically, and his eyes nearly closed as the solemnly robed judges entered after their deliberations. The courtroom was tense.

Bolderer smiled when the verdict was read. He nodded continuously as Court President Springmann gave his opinion from notes, reading for ten minutes.

The language teacher had been specifically charged with taking notes on Nazi military matters, damaging to the Reich. The judges held that the prosecutor had not proved that Bolderer sent the damaging material out of the country, but that they still entertained strong suspicion against him.

The accused man told a dramatic story of a love triangle in which he expressed the belief he was betrayed to the authorities by the other man.

Love Competition Found
Bolderer told the judges, three military and two civil, that while giving instructions in languages in Munich, he became acquainted with Hans Wohlfahrt, another language teacher.

Wohlfahrt, Bolderer testified, subsequently fell in love with his (Bolderer's) fiancée, Margaret Siebert.

The three often met, Bolderer continued, for "very nice discussions of philosophy, art, books and so forth," despite "my landlady's advice to be a man and send Wohlfahrt packing."

Finally, Bolderer said, he concluded Wohlfahrt, although professing close friendship, was the agent provocateur who gave testimony against him after his arrest nine months ago.

He testified he received \$118 for two articles he succeeded in selling in the United States. He said that in them he praised the German fight against communists and unemployment.

During the short recess while newspapers were excluded, the judges carefully considered the notes for an article Bolderer said he intended to write.

The notes contained references to the Nazi storm troopers which were described as being bound together by "enavishness to a bad cause and leaders."

BARRAGE OF EGGS STARTS RIOT ON CHICAGO CAMPUS

Orderly, organized and with a touch of the joyous humor and enthusiasm of the old-fashioned football rally, students of the University of Oregon, Northwest Christian college and the Eugene high schools Friday made their "demonstration against the war method" as a substitute for the nation-wide collegiate strike against war which is communally suspended.

About 1000 people, off and on, of whom 500 were fairly stationary, listened to fiery student orators who denounced international munitions profiteers, compulsory training, the increase in armament expense, and the naval maneuvers scheduled for the North Pacific this summer.

There were about 500 people in cars and marching on foot, bearing banners against war when the parade through downtown Eugene moved away from the campus. From the sidelines a mocking chorus of deep-throated "kidders" kept saying: "We want war! We want war!" But nobody got excited and peace governed the demonstration for peace.

SAN FRANCISCO, April 12.—(AP)—A one-hour strike against war was planned by students in several Pacific coast colleges today as part of a nation-wide demonstration.

At campuses where a ban has been placed on such demonstrations students planned to hold off-campus meetings.

At Stanford university, President Ray Lyman Wilbur was to address a general student assembly. Student speakers also were to be heard.

A general assembly was called at San Diego State college and President E. L. Hardy said the students could discuss any subject they wished.

President Robert Gordon Sprout of the University of California said no demonstration would be allowed on the campus. Students planned to meet outside Sather gate, one of the main campus entrances.

Police were prepared to preserve order at the University of California at Los Angeles, where several campus organizations have announced they will try to stop any demonstration being planned by Miss Celeste Strack, once dismissed from the school for asserted radical activities but later reinstated.

CORVALLIS, Ore., April 12.—(AP)—Classes were held as usual today at Oregon State college, and not a single "peace striker" put in an appearance at the zero hour of the national student "strike against war."

Immediately it was indicated there probably will be called another conference of the big powers to work out the details of such a pact as suggested and sign it.

The official communique said that the conference had completed its discussion of the French recourse to the League of Nations, had also discussed the Austrian situation, and, in part, the proposed air pact.

Premier Mussolini of Italy and Prime Minister Ramsay MacDonald of Great Britain were represented as being in complete agreement with Laval on the procedure of action to be taken at the council, which was called into session on representations by France that Germany, by rearmament, had violated the military clauses of the Versailles treaty.

France Gives In.
Previous to the announcement agreement, France had agreed to

refrain from asking the council to condemn Germany, in return for a British blessing on the French idea of regional European pacts within the framework of the league.

A French spokesman said the agreement had been reached on "measures" to be applied against Germany or any other power which violates treaties in the future.

The spokesman further said that Great Britain and Italy also had agreed to support France's protest to the League against such treaty repudiation as had been made by Reichschancellor Hitler thus far. He

added, however, that any motion eventually to be adopted would be left to the league council.

France already had prepared a resolution of condemnation of Germany's rearmament as in violation of the military clauses of the Versailles treaty, and this was to be submitted to the extraordinary council session at Geneva next week.
