

MERCHANT MARINE SUBSIDY MEASURE PASSED BY HOUSE

Would Foster Development Capable Carrying All Domestic and Half Foreign Commerce of the Nation

WASHINGTON, June 27.—(AP)—The Bland-Copeland bill, designed to build up the American merchant marine by subsidies, was passed today by the house and sent to the senate.

The vote was 194 to 186. Supporters of the measure contended it would foster the development of a merchant marine, owned and managed by Americans, capable of carrying all domestic and half the foreign water-borne commerce of the nation and providing an adequate auxiliary for wartime.

The central feature of the bill is a provision for federal subsidies equal to the differences in costs between domestic and foreign ship construction and operation.

In addition, it would increase ship owners' liability for death or injury to passengers at sea.

Contending the legislation was vicious and unworkable and tending to perpetuate rather than correct abuses that developed under ocean mail contracts, opponents proposed a torrent of amendments. Most of them were rejected.

The measure was written after President Roosevelt on March 4 sent a special request to congress for subsidy legislation.

The house bill would set up a new federal maritime authority to perform much the same functions for sea transportation that the interstate commerce commission does for the railroads.

DRESS GRANTS PASS STREETS, BUILDINGS FOR EAGLES CONFAB

GRANTS PASS, June 27.—(Sp.)—With decorators working day and night, the streets and building fronts of Grants Pass are taking on a festive appearance for the Eagles' state convention, to be held here July 4, 5 and 6.

Large banners will adorn the buildings, while streamers and flags in eagle and shield design will welcome the thousands of Eagles' delegates and visitors to the city during the convention.

A new attraction, "Donkey Baseball," in which players are mounted on burros—at least a part of the time—has been added to the long list of entertainment features arranged for the convention and Fourth of July celebration.

Twelve entries have been received to date for the Rogue river water carnival, "Venetian Nights," to be staged at the Grants Pass Riverside park on the night of July 4.

BLAST INJURIES FATAL FOR LAD

BAKER, June 27.—(AP)—Daniel Wells, 16, of Baker, injured Tuesday at the family home on Pine creek by an explosion of blasting powder, died Wednesday afternoon.

Wells and a friend, William Wilcox, were preparing to split wood with the powder when the accident occurred. As Della poured some powder into a bottle part of it spilled onto the ground. Wilcox, standing some distance away, struck a match to light a cigaret and the flaming match head broke from the match and fell into the powder on the ground. The resultant explosion ignited the powder in the bottle held by Wells and the second blast tore and seared the youth's flesh and set his clothes afire.

Unable to extinguish the flames by rolling on the ground after he was thrown through the door of the woodshed, Wells pulled off his clothes.

The young man is survived by his father, J. E. Wells, four sisters and four brothers.

REED CLEMENCY PLEA MADE BEFORE BOARD BY ATTY. G. NEWBURY

Presentation of the pardon plea of Alvin W. Reed, of Denver, Colo., serving a life sentence in the state prison on conviction of the murder of Victor Knott, Ashland policeman, on the night of November 18, 1931, will be made today before the state parole board at Salem by Attorney Gus Newbury of this city.

Briefs asking executive clemency by Gov. Charles F. Martin, and an opposing brief from District Attorney George A. Codding were filed with the governor 10 days ago.

Attorney Newbury will present arguments before the parole board, as a matter of record. Action in the case rests with the governor.

The clemency plea for Reed is based upon two main contentions—the discovery of new evidence, and the claim that the court erred in the admission at the trial of evidence of a burglary in California.

The testimony of Roy Laymon, Ashland policeman, and only eye-witness of the murder is also attacked. Misconduct of a woman juror is also alleged.

Paul McQuade and Lee Jackson, companions of Reed, also indicted for the murder, are fugitives from justice now.

Reed has been confined in the state penitentiary since March, 1932, and has been a model prisoner.

He was found guilty by a Jackson county jury, after 19 hours' deliberation.
