BITTER BATTLING EXPECTED BEFORE ACTION IN SENATE

House Approves Administration Measure 282 To 96—End Of Session Depends On Senate Speed.

Oregonians Favor WASHINGTON, Aug. 5.—(AP)—All three of Oregon's congressmen voted for the president's tax bill which swept through the house today.

Representative Pierce was among 254 democrats voting for the measure while Representatives Ekwall and Mott joined with 16 other republicans in helping pass the bill and sending it to the senate.

A bitter controversy in that branch appeared certain before the measure upon which the time of congressional adjournment depends, is voted on.

SENATE CONCURS IN BUS AND TRUCK REGULATION BILL

WASHINGTON, Aug. 5.—(AP)—The senate today concurred in house amendments to the administration bill for federal regulation of motor bus and truck transportation of freight and passengers in interstate commerce.

The bill now goes to the White House. Representing several years of effort, the bill is one of a series advocated by President Roosevelt for regulating all forms of transportation and concentrating the task in the interstate commerce commission.

The measure places both common and contract carriers by motor under commission control as to rates and services. It generally exempts private trucks.

Under house amendments concurred in today, trucks hauling farm products and owned by farm cooperatives and individual farmers would be exempted from regulation, as well as trucks transporting newspapers and fish.

All of the exempted trucks, however, would be subject to commission safety and maximum hour regulation.

ROSEBURG, Aug. 5.—(AP)—Fifteen months in the state penitentiary was the penalty meted here by Circuit Judge Wimberly to D. H. Whitford, of Myrtle Creek, who pleaded guilty to a morals case involving a minor girl of Myrtle Creek, where he formerly lived.

ACCUSED NEGRO LYNCHED BY SOUTHERN MOBSTERS

PITTSBORO, Miss., Aug. 5.—(AP)—Bodie Bates, a negro accused of attempting to attack a 22-year-old white woman of Pittsboro Saturday night, was lynched by a mob which stormed the Calhoun county jail last night, it was reported here today.

The mob, made up of white citizens, turned after the negro had been arrested and overpowered an officer at the jail, taking the keys to the jail from him and seizing the prisoner.

Bates was taken to a sparsely settled section of Calhoun county and was hanged from a bridge over Yallopia river where officers found his body today.

SISKIYOU OFFICERS NOT KEEN TO NAB VICTIM'S LYNCHERS

Court Apathy Blamed For Action Of Aroused Citizens—Search For Miller Lags, Escape Almost Sure

SACRAMENTO, Aug. 5.—(AP)—Belief that higher authorities should "step in" if officers of Siskiyou county fail to take proper steps in the investigation of a lynching at Yreka on Saturday was expressed today by Governor Merriam.

The governor's statement followed a telephone interview with W. H. Whitford, news editor of the London Daily Mail, who talked with the state executive for five minutes from the offices of the English publication.

YREKA, Calif., Aug. 5.—(AP)—Search for Robert Miller, companion of Clyde L. Johnson, who was lynched near here early Saturday morning after Chief of Police F. R. Daw of Dunsmuir had been slain in a gun battle with Johnson, lagged today as Siskiyou county officials expressed their belief he had escaped from this district.

Likelihood that no determined steps will be taken to identify or prosecute members of the mob that dragged Johnson from the county jail and hanged him to a pine tree three miles from Yreka was seen through Siskiyou officials joined with citizens of this sparsely-populated mountainous area in condoning the act.

Courts Blamed. District Attorney James Davis was particularly outspoken in placing the blame for the mob's action elsewhere. He insisted the "apathy" of the courts was the real cause of the lynching.

Davis cited the case of George Hall, who was convicted of killing a highway patrolman and a deputy sheriff here. Hall was sentenced to hang in

FRENCH STRATO PLANE CRASHES

PARIS, Aug. 5.—(AP)—France's first stratosphere airplane was wrecked in a test flight today, killing its pilot, Marcel Cagno, 28.

The plane, which had been three years in construction, was undergoing a final test when it crashed near Bonnières.

A few spectators saw the plane gyrating wildly as without a pilot, then plunging to the earth. This gave rise to the theory the pilot fainted in the rarified upper air.

KELLAHER DRAFTS REPLY TO BANKS BARGAIN CHARGE

Former Parole Officer To Be Cited In Court For Alleged Pact With Medford Slayer Is Announcement.

PORTLAND, Ore., Aug. 5.—(AP)—Dan Kellaher, former state parole officer who was accused of bargaining to help release L. A. Banks from the Oregon penitentiary for \$50,000, said today that he still was preparing a statement to give the public the facts of the case.

He did not indicate when the statement would be ready.

SALEM, Aug. 5.—(AP)—Information against Dan Kellaher, former state parole officer, charging him with malfeasance in office as a result of the reputed agreement he signed with Llewellyn A. Banks, in which he was to receive \$50,000 if he could obtain Banks' release from the penitentiary, was expected to be filed today in the Marion county circuit court by William H. Trindle, district attorney.

Trindle was in conference with Circuit Judge L. H. McMahan today, and he stated he may file information against Kellaher later in the day, and prepare his case during the month for the grand jury early in September. He had not definitely decided the exact nature of the charge but believed it would be malfeasance.

Exposed at Hearing. The alleged agreement was exposed during the hearing before Governor Martin late Friday when Deputy Attorney General Ralph Moores presented photographic copies of the contract, which was obtained from Banks

TALMADGE TAKES NEW SHOT AT F. R.

DAWSONVILLE, Ga., Aug. 5.—(AP)—In a new blast at the national administration, Governor Eugene Talmadge said today he would support President Roosevelt for re-election in 1936 if he quit "his course of communism" and let American industry and agriculture out of the "hospital."

The Georgia governor, whose recent activities have been interpreted as meaning he might make a bid for the presidency himself, added that unless the present policies in Washington are changed he will make a "coast to coast" fight to "put Americans there who will stand by the constitution and by the 'principles of Jeffersonian democracy.'"

Scoring the national administration Talmadge said American industry "is making some strides in spite of the new deal."

BELLINGHAM MILL STRIKERS RETURN

CHICAGO, Aug. 5.—(AP)—Judge P. McCarthy in felony court today issued a warrant charging Manderville W. Zenge, 26 year old Missouri carpenter, with the emasculation-slitting of his love rival, Dr. Walter J. Bauer.

Judge McCarthy made the warrant returnable tomorrow. Charles S. Dougherty, assistant state's attorney, said he would go before the grand jury tomorrow and ask that a murder indictment be returned, a slitting charge was mulctated and fatally injured last Wednesday, was expected to go before the grand jury. Dougherty said the Zenge had been served with a subpoena.

Zenge's nerves failed to break in despite 48 hours of constant examination and a dramatic meeting under police eyes with Mrs. Bauer.

The widow, who hurried here from Cleveland by airplane after the funeral of her husband, was led into a room where Zenge, her former suitor, sat manacled, unshaven and half asleep. Zenge had been given no information she would face him.

C., said Director Cammerer of the national park service "has expressed regret to Senator McNary that a party of Georgia school teachers was turned back at Crater Lake park because of rules concerning exclusive privileges for sightseeing buses."
