

SEN. BORAH FACES STRENUOUS FIGHT TO RETAIN PLACE

Conflicting Statements Are Published on New Deal's Attempt To "Get Veteran Solon" Next Year.

WASHINGTON, Aug. 5.—(AP)—Washington, Aug. 5.—(AP)—Conflicting statements on whether the new deal will try to "get Borah" next year today apparently left unchanged Idaho's expectation of a lusterous battle between the veteran senator and Democratic Governor C. Ben Ross.

Ross, lanky ex-cattle man who rose from the farm through a half dozen political offices to the governorship, already has announced he will oppose Borah in 1936. To some Idahoans it appeared the most formidable threat to Borah since he first was sent to the senate by the legislature in 1907.

BARTLETTS GIVEN LAST IRRIGATION

Final irrigation of Bartletts, to "size up" the fruit for picking scheduled to start between August 15 and 20, is now underway in the orchards of the Rogue River valley. County Horticulturist C. B. Corby estimates that picking will start August 15 in the earlier orchards, and be general by August 20. Some of the packers estimate that general picking will not be underway much before August 25.

Last year the picking of Bartletts started July 23—a month earlier than this year. Picking of valley peaches is predicted by the count horticulturist to start the last week of September. Picking of the bumper tomato crop is also "heduled" to start during the same period. The tomatoes are now in the "coloring stage."

MANDATE FILED IN WATSON SUIT

The mandate of the state supreme court in the suit of Dan Watson against George L. Jantzer, holding that Watson is entitled to a decree, and neither side is entitled to costs or disbursements, has been received and filed with the county clerk.

Filing of a petition for a re-hearing of the case with the supreme court is contemplated by the district attorney's office, but no definite decision has been reached. The suit involved the sale by the county to Jantzer, a sawmill operator of the Prospect district, of a timber claim belonging to Watson, for delinquent taxes amounting to approximately \$150.

JAPANESE RESENT YANKEE CARTOON

WASHINGTON, Aug. 5.—(AP)—Lampooning the emperor of Japan in the current issue of Vanity Fair brought from Secretary Hull today an expression of regret that the caricature had been misunderstood in that country.

Upholding the dignity of his emperor, Hiroki Saito, the Japanese ambassador, made representations to the state department against publication of the cartoon, conceding it was derogatory to the emperor and to the Japanese people. After conferring with Secretary Hull the ambassador indicated to newsmen that American officials regretted the incident but had emphasized that the United States government exercised no censorship over the press and was in no way responsible for anything published here.

SECOND POLICE SCHOOL IS OPENED AT CLATSOP

The second annual state police school opened at Camp Clatsop today and will remain in session all through August, according to the state police office here. The Medford delegates will not go until the third week, at which time the school will be under the personal supervision of Captain Lee M. Bown of Medford. All members of the state police organization must attend the school each year, and must receive a passing grade. Drill, marksmanship, first aid and other police subjects are taught, and keep the men well informed on all police matters. Captain Gurdane is in command of the school this week.

was a sworn officer of the law, at the time of the ballot theft. A number of local people including many who have known Schermerhorn for 30 years, have interceded in his behalf.

Federal checks for the first payment of 1935 Corn-Hog contracts, amounting to \$2200 have been distributed by County Agent Robert G. Fowler, among the 63 Jackson county farmers who signed the AAA contracts. The checks were mailed to the recipients, or they called at the county agent's office for them.

HOP PICKING TO START AUGUST 15

Hop picking will soon start in the Grants Pass district. One of the first yards to be harvested on the Pacific coast is the Hilton yard of 233 acres, about seven miles down the river from Grants Pass. The Hiltons are old-time residents of Jackson county, and well known by many valley people. In their yards picking will begin about August 15 and they will need around 700 pickers.

The pickers they hope to recruit from Jackson, Josephine, Douglas, Coos and Curry counties. People interested in securing work should write to the Hilton Hop yards, Grants Pass, at an early date. Picking prices are set at a cent a pound, with a bonus of a quarter of a cent to those who stay throughout the season. Pickers in the Hilton yards furnish their own tents and other equipment, wood and water being furnished by the yard owners. The camp grounds are along the banks of Rogue river, and in conjunction with the grounds is a well

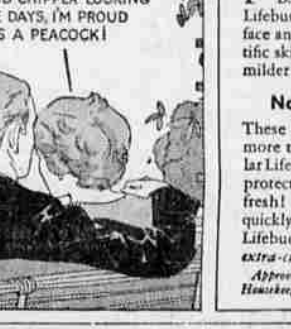
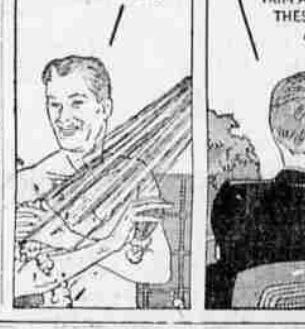
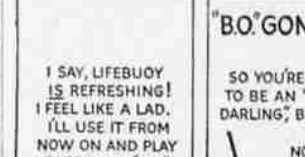
FRANK CLUTE RITES TUESDAY AFTERNOON
