Most of them will not have told their best friends that not only is Mr. Grimm a Republican, but so is his helper, which is about as bad a thing as can be said against anyone in the heat new deal circles.

Would-Be Assassin Riddled by Bullets Of Kingfish's Guard

WASHINGTON, Sept. 9.—(AP)—The office of Senator Huey P. Long said today it had just been notified from Baton Rouge that the senator's physicians were "very pleased" about the condition of their patient following a consultation.

Don Devoil, Long's assistant secretary, said he had talked with Earle Christenberry, the senator's secretary by telephone. Christenberry told Devoil that the doctors gave the senator "better than an even chance to recover."

BATON ROUGE, La., Sept. 9.—(AP)—Senator Huey P. Long, seriously wounded by a political foe after a session of the special legislature called to further strengthen his "dictatorship" over Louisiana, was resting satisfactorily today in a Baton Rouge hospital.

The assailant, 30-year-old Dr. C. A. Weiss, Jr., of Baton Rouge, was shot to death by Long's bodyguards last night.

While physicians said "no important information" will be available for about 72 hours, the hospital reported the senator was gaining strength after a blood transfusion and operation.

The state capital was in a future. Details of state police, from other parts of the state, arrived early today. Troops were mobilized in New Orleans. Trucks were ready to transport them here at a minute's notice.

Heavily armed guards stood at the doors of the Louisiana house of representatives. Men with sawed-off shotguns and rifles were in front of the governor's office where Long was wounded.

Scores of other plainclothes men were at the statehouse entrance and in the basement. Persons entering the building were searched for arms. The assault on the senator was as dramatic as many of his own appearances before the public and in the legislative halls of Louisiana and Washington.

The legislature had just recessed for the night. The senator strode from the assembly hall, accompanied by his ever-present bodyguard and the Supreme Court Justice John B. Pournet.

"Everybody be here in the morning," he said.

PACKING PLANTS WILL RUN NIGHTS TO CLEAR PEARS

Packing plants plan to work nights until the peak of the pear harvesting season is passed, several announced today. Packing and packing of boxes and pears are now at their height with Comice picking starting today.

In several orchards, including the Hollywood orchard—the largest Comice block in the land.

Packing house managers reported plenty of labor today and that a number of orchards reported they were working with a full crew of workers, where last week they were short-handed.

Shipment of Bosc pears started the end of the week, with 18 cars dispatched Sunday, to eastern and export markets. Those shipped east will be held in storage, until the end of the month.

Due to the three varieties all being picked at the same time, the capacity of the packing plants to handle the pears has been taxed to the limit, but no serious congestion has resulted. Orchards are anxious to get their crop picked early to get the possibilities of storm, and threatened labor troubles in coast ports.

Shipping of canners Bartlett's is tapering off. Sunday and four cars were shipped, under this head. Packed pear shipments for the same day totalled 40 cars.

The total pear shipments to date is 782 cars—430 canners Bartlett's, and 352 packed pears.

SEVEN INJURED IN THREE AUTO SMASHUPS

T. W. SCOTT PINNED BENEATH MACHINE ON J'VILLE ROAD

Seven were taken to local hospitals, two injured seriously, as the result of three automobile smashups in this vicinity over the week-end.

When a Ford, having as a passenger T. W. Scott of route 1, box 493, overturned on the Jacksonville highway shortly before 7 p. m. yesterday, Scott was pinned beneath the wreckage, suffering serious injuries, and William Murphy of Griffin creek, a passenger in the car, sustained a serious bruise on the forehead. Although witnesses said Scott had been at the wheel, he stated today at the hospital that he was unable to recall whether or not he was driving.

According to state police who investigated the car was travelling toward Medford and failed to make a turn a quarter mile after leaving Jacksonville. The machine skidded in the gravel on the left side and turned over in the center of the highway, throwing Murphy clear. Scott was pinned to the pavement for nearly half an hour before a Medford

EIGHTEEN INJURED IN SERIES OF CAR ACCIDENTS, SALEM

SALEM, Sept. 9.—(AP)—Eighteen persons were suffering today from injuries received in five separate automobile accidents in this vicinity Saturday night and Sunday.

Police were on the lookout for a hit-and-run driver who side-swiped the automobile containing Mr. and Mrs. Peter H. Ernston, both about 60, on the Pacific highway south of here yesterday. Ernston suffered a probable skull fracture and his wife a fractured leg. Their condition was reported as not immediately serious at the Salem hospital today.

Six persons were injured in a crash between automobiles driven by Mike Schwindt of Stayton and Gordon Shields of Jordan Valley, near Stayton last night.

A head-on crash between cars driven by Carl Reiss of Gervais and David McCallister of Brooks, on the Wasco highway early Sunday, resulted in five people being taken to the hospital with injuries.

Katherine Shorey, Walter Wendgenoth and Artie Skiles, of Woodburn, and Alice Woodward, Portland, received injuries when their machine ran into a horse. Miss Shorey was taken to a hospital with severe throat and head injuries. The others were reported as only bruised.

Roy West, West Salem, was injured when he was run over by a car driven by Virgil Trick.

SHOOTING OF LONG TOPS BRITISH NEWS

LONDON, Sept. 9.—(AP)—The shooting of Huey Long took precedence here today in the press over the Italo-Ethiopian situation.

Papers recalled that Great Britain had no similar incident for more than 100 years. The Baton Rouge accounts were featured with pictures of Senator Long and the Louisiana capital building under such captions as the following:

"Huey Long Shot."

"Dyer Likely Rejoice."

"Gun Battle in Senate House of Louisiana."

Olson, who was accompanied with Olds in the lumber company. Death came at Sheboygan, Mich., where he had been making his home for the past several years.

WILLAMETTE AND STATE AGREE ON PRICE FOR SITE

SALEM, Sept. 9.—(AP)—Agreement on the purchase price for the Willamette university campus as additional grounds for a site of the new capitol was reached here today after the city of Salem bridged the gap by pledging vote on a \$100,000 bond issue as a donation to the state.

The city's proffer was made today after 10 members of the city council in special session had approved the plan unanimously. The entire proposal will be submitted to the state legislature, which has the final decision exclusively.

Governor Martin announced a call for the legislature to convene would await assurances by the federal government that the applications for grants would be approved.

The price asked by Willamette was \$750,000 for the campus and buildings and \$75,000 for purchase of the new proposed site in Bush's pasture. The campus' 18 acres would be joined to the six acres now owned by the state.

The proposal will be submitted to the legislature by the board of control. At the same time Governor Martin, speaking for the board following a conference with members of the special trustees committee of Salem citizens, announced that the board would also make application to PWA for a loan and grant on a tract of approximately 95 acres on a hilltop immediately south of the Salem city limits.

"Priority will be given to the Willamette site proposal by the board in making application for a PWA site grant," said Governor Martin, "but it must be understood that all sites proposed to the board will be submitted to the legislature when it is convened."

Solons To Decide
"With the cooperation of the board of control I will collect all available data on all proposed sites and submit them to the legislature with my recommendations. The legislature will make the decision."

Under the provisions of the compromise agreement reached this morning Governor Martin will make application today to PWA for a loan and grant of \$750,000 requesting a grant of 45 per cent of that amount, with the understanding that the entire \$750,000 is to be expended in the construction of new university buildings on a site in Bush's pasture to be provided by the city.

The state will be asked to provide \$385,000—the same it would have been required to contribute under the board's original purchase offer of \$700,000.

City Pledges Aid
The difference between \$385,000 and the 55 per cent loan portion of \$750,000 or \$275,000, is pledged by the city to the state, of which \$25,000 was pledged by private parties.

In addition, the city pledged itself to provide out of the funds of a special bond issue \$75,000 required for the purchase of 94 acres in the Bush tract for a new campus for Willamette.

Ten of the 14 members of the city council, meeting at the call of Mayor V. E. Kuhn this morning, gave their unanimous approval to the proposal and pledged themselves to submit the proposal of the necessary bond issue to the voters of Salem at a special election.

The special committee representing the trustees of Willamette agreed to the plan and asked only as a further condition that the university be allowed the use of its women's dormitory building, Lausanne hall, for a period of five years. This exception will not be written into the PWA application, but both Governor Martin and Secretary of State Earl S. Bell agreed to the condition as a board of control concession and separate gentlemen's agreement.

SALEM, Sept. 9.—(AP)—The hundreds of friends of Frederick L. He is survived by his wife and two sons, Frederick Jr., and Robert. Funeral arrangements have not yet been announced, but a complete obituary will appear in this paper tomorrow.

TOWNSENDITES BACK WIRTH AS CANDIDATE FOR SEAT IN SENATE

About 600 enthusiastic supporters of the Townsend plan, meeting for speeches and a picnic in the Ashland Lithia park yesterday, unanimously decided to support H. E. Wirth of Medford for U. S. senator, and urged him to become a candidate for that office. Wirth ran independently for governor of Oregon in the last primaries, but retired in favor of Peter Zimmerman at the last moment.

Speakers of the day, including Wirth, were Judge J. J. Jeffries of Portland and Ernest Rhoads of Grants Pass. Judge Jeffries outlined the advantages of the Townsend plan for social security, while Rhoads spoke of the fireman and policemen pension plan. He is a retired fireman on a \$150 per month pension, and likening his own pension to the Townsend one, sketched the working of the plan and the advantages to be derived from it.

He scorned the social security bill of the president, calling it a "dole" of \$37.50, which was not forthcoming unless the applicant be 65 years of age, and a pauper.

The Townsendites voted to endorse only those men for office who are enthusiastic and sincere supporters of the plan.

COQUILLE OUSTS LABOR AGITATORS

MARSHFIELD, Sept. 9.—(AP)—An attempt to "organize" Coos Bay mill workers failed last night when nearly 200 business men and skilled workers hustled three carloads of unionists out of the town of Coquille where the organization meeting was to have been held.

Several fist fights broke out on the streets of the town and there were shouts of "tar and feather them."

In three automobiles the union officials went to the meeting hall. Coquille workers who had been asked to attend, failed to rally. The "vigilante" group then ordered the unionists out of town. When they failed to move direct action was taken.

Charles Granby, secretary of the Coos Bay central labor council, was said to have been roughly handled by the crowd.

S. P. FREIGHT STAGES SPECTACULAR WRECK

RED BLUFF, Cal., Sept. 9.—(AP)—Six cars of a north-bound Southern Pacific freight train jumped the track at Cottonwood last night, demolishing a 50,000 gallon water tank and endangering the driver of an automobile.

The cars, one of them an oil carrier, piled up in the spectacular wreck, and damaged the rails for a considerable distance.

LAWSON LITTLE WINS OPENING ROUND 3-1

THE COUNTRY CLUB, Cleveland, Sept. 9.—(AP)—Lawson Little, Jr., San Francisco, rallied superbly this afternoon to turn back the challenge of Rufus King, a former trap shooting ace, from Wichita Falls, Texas.

The defending title holder started his title defense with an uphill 4 and 1 victory that furnished the main fireworks of the U. S. amateur golf championship's opening round.

MARION McDUGALL IN VAN EARLY FINISHERS

CHICAGO, Sept. 9.—(AP)—Marion McDougall of the Waverly golf club of Portland, Ore., shot a 38-43-81, two over par, to take the lead among the early finishers in the first round of the women's western derby at the Northmoore country club here today.
