

PROGRAM MARKS ENTRANCE OF 30 TO CITIZENSHIP

Patriotic Service Is Held By Legion And D. A. R. As Large Class Takes Oath Of Allegiance In Court.

Thirty southern Oregon residents were today enjoying the rights and privileges of American citizens and recalling the brief but impressive patriotic service held in the federal court yesterday afternoon immediately after they had become naturalized citizens. With the approval of their friends, the oath of allegiance was administered by Judge James Aker Fee.

The patriotic program was sponsored by the D. A. R. and the American Legion, with Col. W. H. Fair as acting chairman, as representative of the latter organization.

Pointing out that the American government is based on the Christian religion, Col. Paine called upon Mrs. E. A. Moore, chaplain of the D. A. R., to read the George Washington prayer.

In a brief address, City Attorney Frank P. Farrell, past commander of the Medford post of the American Legion, reminded the naturalized Americans of the rights, privileges, duties and responsibilities of citizens, and urged them all to take an active and intelligent part in the governmental affairs of the country, the state and their communities.

Congratulations Offered. Member of the D. A. R. then led the assemblage in repeating the American creed, after which flags were presented to each naturalized citizen by Mrs. G. D'Athill, Col. Paine brought the program to a close by asking all present to bestow their congratulations upon the new citizens.

BORAH MOVING NEARER PRESIDENTIAL RACE IS WASHINGTON POST IDEA

WASHINGTON, Oct. 16.—(AP)—The Washington Post says Senator William E. Borah was "moved a step closer toward entering the Republican presidential fight" with the declaration that he intends to do everything he can to rally public sentiment against eastern domination of the party's coming presidential campaign.

A Post correspondent who obtained an interview with the Idaho senator at Boise, said: "Senator Borah is determined to break up the strategy of Charles D. Hilles, New York Republican national committeeman, and other eastern leaders. They are encouraging favorite sons and selection of uninstructed delegates in the hope of being able to negotiate at the convention and pick the candidate. The way to prevent this, Senator Borah believes, is to carry the fight to the public and go to the convention with delegates pledged to presidential primaries."

CORNELIUS COLT HEADS RED CROSS STATE ROLL CALL

Cornelius C. Holt, senior vice president of the First National Bank of Portland, long active in Red Cross, Boy Scout and Y. M. C. A. welfare work, has accepted the appointment of chairman of the Oregon State Roll Call committee for the American Red Cross. A. L. Schafer, manager in the Pacific area, informed Oregon Red Cross chapters today.

As State Roll Call chairman, Mr. Holt calls upon all citizens to rally to the Red Cross flag, enrolling during the annual membership campaign which will be held from Armistice day to Thanksgiving, November 11-28.

Preliminary to the actual enrollment of members six regional Roll Call conferences will be held in Oregon at which Chairman Holt of the Oregon committee and Douglas H. Moore, director of Roll Call for the Pacific branch Red Cross, will be the principal speakers.

Thirty-four Red Cross chapters in Oregon have set as their objective the enrollment of 55,800 members as this state's quota of the national objective of five million members. Chairman Holt says the Oregon membership now is 44,214 or 4.54 per cent of the state's population. The national honor flag is held by the state of Nevada, which enrolled 6.79 per cent of its population in the Red Cross in the Roll Call last fall.

Achievements of the Oregon chapters will be narrated during the Roll Call conferences and emphasis placed on the national Red Cross program for the establishment of first aid stations on the principal highways and for the prevention of accidents in the homes and on the farms.

Red Cross records show that 11 of the 34 chapters handled a monthly average of 1,335 cases dealing with the problems of veterans or their families. Fourteen chapters had a monthly average of 1,648 cases in which they extended relief to civilian families.

In the field of Public Health Nursing the nurses made 2,230 visits to or in behalf of patients, school or pre-school children inspected by doctor or nurse numbered 1,507. Physical defects found in such inspection numbered 2,183. Children treated for one or more defects numbered 516.

Ten of the Oregon chapters completed classes in Home Hygiene and Care of the Sick and issued 590 certificates to persons taking the instruction. There are fourteen active instructors.

In the field of First Aid to the Injured the 34 chapters issued certificates to 8,033 persons who completed the course of instruction. There are 385 qualified first aid instructors in the state.

Twenty-three of the Oregon chapters certified 818 persons who qualified as life-savers. Since 1914, the Oregon chapters have enrolled 8,243 persons who qualified as life-savers. There are 137 life-saving instructors in the state.

Special volunteer service in 16 chapters included the production of 8,792 garments for needy and distressed families, the production of 1,686 surgical dressings and 2,777 pages of Braille transcriptions for the blind.

Twenty-six chapters enrolled 28,805 Junior Red Cross members in 154 schools of the state. Oregon chapters participating in the Red-Cross program include Jackson county.

SERGEANT YORK READY SHOULD RIFLE AGAIN IF AMERICA ATTACKED

PALL MALL, Tenn., Oct. 15.—(AP)—Sergeant Alvin C. York said yesterday he is through with foreign fighting, but if the United States is attacked, the world war hero declared he will be "fitting right there on the seacoast with my rifle."

It was five from his rifle in the Argonne just a little more than 17 years ago — October 8, 1918 — that caused General Pershing to describe York as "the greatest civilian soldier of the war."

The official records say that, "practically unassisted," the tall, red-headed Tennessee routed a machine gun battalion, killing at least 25 Germans and capturing 132 prisoners, including three officers.

"Ethiopia is entitled to some assistance from her sister nations around her and some of them should step into the conflict," said York, "but it's no affair of ours. I think we ought not to interfere in any other nation's troubles so long as they let us alone."

"I don't want any more European fighting and I don't think any of the boys who were over there last time want to go back, but I'm absolutely ready to enlist if somebody attacks this country, and I think all the other boys are, too."

PHONE EARNINGS IN BIG ADVANCE

NEW YORK, Oct. 15.—(AP)—American Telephone & Telegraph Co. reported today consolidated net income applicable to its stock of \$79,882,071 for the eight months ended August 31, equivalent to \$4.28 a share. This compares with \$71,946,518 or \$3.85 a share in the first eight months of 1934.

The report covers net income of American Telephone and its 34 Associated Bell companies and is after depreciation, interest, federal taxes and all other charges.

Walter S. Gifford, president, reported that the Bell system made a net gain of 297,000 telephones the first nine months of the year in contrast with net gain of 227,000 in the 1934 period.

CAPITOL BUILDING SANS BOND ISSUE IS HOLMANS IDEA

Oregon can build a new \$3,500,000 capitol without a bond issue, Rufus C. Holman, state treasurer, this week informed Gov. Charles H. Martin, and without increasing the general fund deficit or taxes, except as contemplated under the six per cent limitation. Mr. Holman's plan was submitted following a board of control meeting at which time ways and means of financing Oregon's

share of capitol construction was discussed. With FWA acceptance of Oregon's application for an outright grant of 45 per cent on \$3,500,000 for capitol building purposes, the state will spend \$1,925,000 which can be divided in three annual installments of \$650,000 for 1936 and 1937 and \$625,000 for 1938, he pointed out.

With the federal government giving the state almost half of the cost of its new capitol, proponents of an adequate capitol site pointed out, very little if any increase in levies would be made in an appropriation passed by the legislature for the acquisition of Willamette campus for site purposes. Several methods for financing the purchase of additional land have been brought out. One of these, purchase of the site by Salem and the state jointly, is gaining in popularity as time goes on for the special legislative session set for October 21 grows closer, sources close to official circles reveal.

Governor Martin is announcing the call for a special session came out strongly for an adequate site for the state new capitol saying he was "unintentionally opposed" to placing the capitol back upon its narrow strip of land 331 by 690 feet. He declared that he would recommend to the legislature acceptance of the Willamette trustee's offer for their campus which with the old site would give the state the approximate average site of all other capitols in the 48 states, which is 23 acres.
