



### KENNASTON VICTIM OF OWN DROPKICK PINNED BY HOLLIS

Mr. Robert Kennaston, U. S. M. C., prominent Gold Hill citizen and erstwhile mean wrestler, is resting as comfortably as could be expected at his home today recovering from injuries sustained as the result of a collision, shortly before 10:30 last night, with feet driven by Kenneth Hollis of Little Rock, Arkansas. The accident occurred near the corner of the southeast ring post and the maple floor, at the Army on North Bartlett street.

"Contributory negligence" the police said after the collision, and referred to file charges against Hollis, even though he had been seen driving on the wrong side of the ropes on several previous instances, and had been involved in numerous other collisions. "Kennaston had been driving all evening without any headlights," police said, adding "and now he hasn't a lug to stand on."

Kennaston kicked not wisely, but too well, just before the collision, losing in the third fall when he lunged a terrific jolt of feet at Hollis' face, missed, lurched out of the ring, and cracked his neck and head on the ring strings and the floor, rendering himself useless although he did manage to crawl back into the ring, only to be pinned for Hollis' second fall.

Hollis took the first with body punches, eye-gouges and four dust-stirring body slams, followed by a body press, with Kennaston steadfastly refusing to swing his fists although the Arkansas dragon-slayer entertained no such reluctance.

After talking to his father at the intermission after the first fall, Kennaston raged out of his corner at the

### bel and kicked Hollis silly with seven beautifully timed and hard-driven double dropkicks, diving on the mean one, and then tying him up in his Gold Hill crab for the fall in exactly 37 seconds.

The last frame went not so easily, however, as Kennaston tried vainly to again kick his opponent into submission. The bout was replete with flying fists mostly thrown by Hollis, kicking and gouging, as well as a spot of friendly choking (using the top ring rope as a choking lever), and the large nose filed out afterwards some-what awed.

In the middle event, while not actually killing Lea Wolfe, Shinuchi "Killer" Shikuma went about as far in that direction as was possible, commensurate with keeping out of the clutches of a coroner's jury, when he flopped the long Texan in three minutes with a flying strange hold on Wolfe's juu jitsu jacket to take the second fall, and then returned and repeated the performance in the third frame to take the match, two-out-of-three.

Wolfe won the opening canto, catch-as-catch-can, in 13 minutes with his now famous figure-4 scissors, rolling the big Nipponese black-belt champion on his back, but in the juu jitsu bouts he didn't fare so well. Completely unaccustomed to that type of hart kar, Wolfe was the constant victim of twists and blows that paralyzed his muscles or galvanized him into letting go a good hold.

In the final round the only resource Wolfe had was to seize one of the Japanese' big toes and twist it, which he did with a commendable, if futile, enthusiasm.

Opening the bouts were Frankie Peck and Rex Mobby, in a return bout which offered wild excitement with good wrestling, with Mobby taking his second fall in the fifth round of the Australian system match, after Peck had taken the first on headlocks and the second and fourth rounds had seen no falls. Mobby took his first fall on an Indian deathlock.

The bouts, which seemed to please the big crowd more than any held here in recent months, will be the last until after the holidays, Promoter Lillard said today.

### GUPTILL AND WALKER IN FEATURE FIGHT ON ELKS CARD THURSDAY

Howard Guptill, 145 pound boxer of Camp Gasquet, will meet Herb Walker, 145, Prescott, in one of the feature events on the Christmas card at the Elks temple Thursday evening.

Walker took a close decision over Guptill on the last card here and the Guptill boy has asked for a return match. "I've been training each day," he writes in a letter to the district athletic officer, "I've been doing a lot of roadwork, bag work and sparring, paying particular attention to a fast start in the first round. I believe that was what cost me the decision in my match with Walker."

"I've tried to remedy that fault and will promise plenty of action in my next appearance. Naturally, I should like to fight Herb Walker a return match and if it can be arranged, I will be out to win it."

A new fighter, Fred Kinney, of Elk Creek, will make his appearance on this card, probably against Jess Sawicki, light-weight champion of South Park. Kinney fought for three and a half years in the U. S. navy and had 24 fights. He was known as "The Shadow," and is said to be a fast, elusive fighter in the ring.

There won't be any more wrestling matches in Medford now until after the Christmas holidays, Mack Lillard announced today. There must be some, whose hearts were permit, too much excitement, who will breathe a sigh of relief at that statement. We overheard a gentleman remark after the matches last night that each week he has promised himself that he's going to lay out the next week and quit coming, but "Damn it all, I'm back here every week." The true wrestling fan seems to thrive on the weekly battles held recently.

The best part of a wrestling match is to watch the fans, not the wrestlers. There are generally a few daisies who aren't quite sure they're liking the rough stuff, and their faces are a study in mixed emotions. Then there is always the little clerk or bookkeeper who sits in the balcony and howls for one of the behemoths to "Pull it off!" "Break his leg," or "Kill him," men, who in ordinary life would have an acute repugnance at popping off a chicken for the Sunday dinner.

Then there is the "witty" type wrestling fan whose sallies during the cooler moments of an engagement, when one grapples is pulling a hammer-lock, help to maintain the interest while the rest are waiting for the carnage to begin again. These classics generally run along the line of "Hey, you guys, you're not wrestling for a loving cup; you're mad at each other." (Laughs—sometimes.) "Not so many laughs! Then there are always the irate fans, who get highly indignant when one musclemen begins to haul on the disfigured prophecies of an opponent, and stands in his seat and howls at the referee to put a stop to such nonsense, and then howls at the referee if he does so.
