VAST FOOD ARRAY REQUIRED TO FEED MEMBERS OF CCC

Oregon, Washington Boys Require 87 Carloads of Food in 30 Days—Many Gain Weight in Camps

PORTLAND (Sp.)—The question "What do they eat?" is answered this week for the CCC of Oregon and Washington with a tabulation of food items prepared by regional engineer James Frankland in charge of CCC work for the U. S. forest service.

Work consumed by the CCC in the two states during a typical 30-day period, according to Frankland, includes 93,750 pounds of bacon; 477,500 pounds of pork; 25,437 pounds of beans; 468,750 pounds of beef; 750,000 pounds of butter; 11,720 pounds of cheese; 93,750 pounds of chicken; 750,000 eggs; 562,500 pounds of flour; 30,000 pounds of lard; 51,724 cans of evaporated milk; 46,675 gallons of fresh milk; 93,750 pounds of onions; 468,750 pounds of potatoes; 28,125 pounds of rice; 2,737 cans of syrup; 234,750 pounds of sugar; 11,718 cans of apples; 4,210 pounds of baking powder; 118,420 cans of string beans; 2,625 cans of cinnamon; 2,812 cans of cocoa; 93,750 pounds of coffee; 75,000 cans of corn; 1,875 bottles of flavoring extract; 15,925 cans of jam; 30,000 pounds of lard substitute; 1,218 pounds of macaroni; 8,358 cans of peas; 75,000 cans of peas; 7,500 cans of pepper; 237 gallons of pickles; 30,000 cans of pineapple; 2,000 cans of apricots; 56,250 packages of rolled oats; 23,437 pounds of salt; 2,344 pounds of tea; 15,000 cans of tomatoes and 937 gallons of vinegar.

Frankland points out that approximately 25,000 CCC boys now in Oregon and Washington camps are fed and clothed under the War Department administration. A month's food supply requires 87 carloads, according to the forest engineer.

Director Robert Fechner, national head of the CCC, recently outlined the procedure followed by the War Department in making sure that each of the 2,436 CCC camps in the country is supplied daily with wholesome meats, dairy products of suitable quality, fresh fruits and vegetables, season, and other items which go into the CCC man's daily menu.

It is pointed out that the monthly consumption of beef, eggs, sugar and other food items for camps in Oregon and Washington conforms closely with the national figures, showing that the average enrollee eats approximately 1 1/2 lbs. of beef, 7 1/2 pounds of pork, 7 1/2 pounds of chicken and bacon per month, a 1 1/2 lbs. of sugar per month and an average of an egg a day.

CCC enrollees normally put on several pounds of weight during their stay in camp, according to Frankland, this fact being attributed to regular and wholesome meals and vigorous out-of-door exercise.

Sidney M. Gordon, CCC enrollee as Camp Prescott, today shed additional light upon the Chicago baby who was named Medford in tribute to the Rogue valley peers of the other enrollee who was in the hospital.

While the child was in the hospital, a letter to the Jackson County Chamber of Commerce by Marion Gordon, sister of Mr. Gordon, Mother of the baby is the sister of Miss Gordon and Mr. Gordon.

Medford is the son of Mr. and Mrs. S. Feldman of 4937 North Whipple street, Chicago, Mr. Gordon related. The baby was born in a Chicago hospital December 7 and was named December 15. Its full name is Medford Dale Feldman.

Further naming of the baby has aroused interest in Oregon, the parents are not likely to visit Medford in the near future, Mr. Gordon said. He added, however, that when he is discharged from the CCC he himself is likely to settle out here. "Many CCC men from the east have become interested in the west," he said.

Work Goes On NILES CENTER, Ill., Jan. 2.—(AP)—Snow and freezing weather can't deter Niles Center of its cut in the WPA funds allotted to Illinois. The townfolk put up a circus tent over a 5,000-gallon reservoir construction project, put in electric lights and furnished stoves so 80 workmen could proceed.
