



DEFENSE NEEDS TOLD VETERANS BY LT. WILCOX

Adequate military preparedness as a preventive of war was urged by Lieut. Lyle P. Wilcox, president of Rogue Valley chapter, Reserve Officers' association, in a talk before the Veterans of Foreign Wars at their regular meeting last night.

Lieut. Wilcox appeared before the veterans in connection with the "National Defense Week" program sponsored by the Reserve Officers' association.

"Past history shows us that wars of aggression have always been waged by the strong against the weak. If we do not wish to invite aggression from a hostile nation, we must be adequately strong in our defense," he said.

"America is not concerned with waging outside wars, but we must maintain defenses which will assure us against invasion. The United States is most favored from a geographical and economical standpoint, but with progress in aviation it will be only a short time until our shores will be so vulnerable to attack as those of any other nation."

Lieut. Wilcox outlined the provisions for defense which were made in the national defense act of 1920, but which he said have not been carried out due to failure by congress to appropriate the sums necessary to maintain the army and navy at their minimum strengths consistent with adequate defense.

He urged the veterans and others interested in defense to insist that their congressmen and senators support legislation which will bring America's military forces to the standards outlined by the national defense act.

FANDOM AT RANDOM

"It's a ——— lie. I never said anything of the sort, and I'm going to sue the Associated Press," George "Wildcat" Wilson, ex-University of Washington footballer and now a professional wrestler, hotly replied last night in answer to a query as to whether the university had started paying him that \$10,500 the A. P. said he claimed they owed him for giving up a professional football career in 1925.

"Every time I say something, somebody misquotes me," Wilson said. He told us what he did say as this: "In 1925, while I was playing football at Washington, we got a bid to play in the Rose Bowl, against Alabama. I had a pro football contract calling for \$10,500 for the season, and didn't want to play that Rose Bowl game. The school and the committee promised to reimburse me for the loss if I played, but didn't say how much. They did give me \$225 or \$250, at Pasadena, but my hospital expenses were more than that."

Regardless of how good he may be at high finance, it is undeniable that the incomparable George possesses one of the most amazing flying tackles in wrestling. And he is beginning to know enough not to launch it when there isn't much chance of connecting with his opponent. Last night he shuttled back and forth across the ring like an express train, with Duke Pettigrove frantically keeping out of his way, but he didn't dive until he knew where he was going to hit.

He looked a lot more like a sprinter than a wrestler on those trips, but when he finally straightened out in that a-o-n-n-e-n-berg he looked like the great football player he was a few years ago. Wilson is 10 years older than he was when playing under Washington's colors, but if he hit the line any harder than he hit Pettigrove, it is little wonder they called him "Wildcat."

After last night's wrestling matches, Frankie Peck admitted that Ken Hollis hit him harder with his bare fist than he had ever been hit with a club, "and I've been swatted with a few pretty hard clubs in my day."

People can't like the Ken Hollises of the world, or of the ring, but we must admit this Hollis is about as tough a cookie as we ever clamped a sore eye upon. Any guy who can survive the battering of a whirlwind of black-jacks, by men who aren't fooling when they swing them, to say nothing of a wallop from the edge of a folding chair, is plenty tough. Too tough, almost, for Peck.

Before that match, Peck had decided to slug it out with Hollis. But after bouncing a few short "hook punches" (his own term) off the Hollis jaw and getting no reaction other than bruising his knuckles, he went back to his head-locks, an effective if not particularly thrilling way of subduing the Oaxak Coaf's enthusiasm.

Like practically everyone else, we want to see Hollis get a real thrashing before he leaves here. Not the technical kind that finds him with his back on the mat, but the kind that leaves him battered and dazed, possibly with a few teeth missing.

As a matter of fact, that prospect is so appealing that we are willing to take a crack at him ourselves, in the main event, semi-windup, curtain raiser, or out behind somebody's barn. Lillard can arrange the match for anytime. We're ready now. The only concession we want granted is this:

Hollis is to enter the arena prepared to go at it "no-holds-barred." That's all he'll have to do. We, however, are to be armed with long steel spikes on each shoe, a beer-bottle full of lead in each hand. There is to be a nine-foot steel mesh fence between us, the meshes to be not larger than one-foot square. And lastly, we are to have four men, each armed with a high-powered rifle, sitting at each corner of the ring, ready to shoot—to kill—the first time Hollis moves out of his tracks. We're ready to start as soon as he is. We think he's a big slazy.

PECK OUTLASTS PUNISHMENT TO DEFEAT HOLLIS

By grace of ability to absorb almost unbelievable punishment, and the fact that Ken Hollis took too much for granted, Frankie Peck today stands as the only man who ever defeated the "Olar of the Oaxaks" in a Medford ring. Peck emerged on the long end of the count in the main event on the Armoory card last night when he woefully applied a back body drop to the surprised Hollis who seemed to have the affair "in the bag."

Hollis took the first fall in three minutes with slugging, eye gouging and three surrounding body slams. Peck took the next with head-locks when he abandoned his avowed intention of slugging Hollis silly in favor of the gruelling skull embrace. Only once in the entire match did the San Francisco cut loose with his powerful right arm jabs, and then only to hit the Arkansas with short blows which did little good. In the last frame, Hollis was again beating Peck about the ring with rabbit punches and knee kicks, but underestimated the rugged Peck's ability to "take it."

With Hollis clamping Peck's own head in a tight lock, Peck threw him off against the ropes, dropped to the floor and raised under the riotous Hollis to seize him in a back-body drop, fall on Hollis' face with his own shoulders, and pin him for the count. Hollis protested violently, refusing to return to the Medford ring until a new referee was procured. "I'm tired of licking the wrestlers and the referee too," he said after the match.

The middle bout was one of the shortest ever seen here, when George Wilson set Duke Pettigrove up against the ropes and then slammed him through the hemp with pile-driving sonnenbergs. Pettigrove was unable to return, and a doctor was needed to revive him. The bout took two minutes.

The opening fiasco went to Ted Christy, Los Angeles meanie, in almost as short order as he and Wayne Long mixed in a whirlwind encounter. Long took the first fall with a flying head butt after Christy had slugged him around for several minutes. In the next fall, Christy let him start another butt, and then raised up under his flying body with both fists to knock Long clammy and apply a body press.

Christy took the deciding tumble with a leg strangle in one minute and a half. A shower of cigar butts greeted his departure to the dressing room. One of the largest crowds of the season witnessed the card, which was over at 9:45, earlier than any recent bouts.

Note that I got from trees from the streets of Ashland and Eugene were very poorly filled. I think nuts raised here on planted trees would be better to plant than those brought from the east. I am raising almonds, filberts and Prunette walnuts successfully on my ranch at the Nell Creek schoolhouse.

Local Politics vs. Townsmentites

To the Editor:

I want to comment on two Townsment items that are different and yet closely related.

Last week I attended the Townsment dramatic incident was the reading of Senator McNary's answer as to his stand on the Townsment plan. We had looked forward for that answer for weeks and when the moment came and during the reading, and for a few seconds after, you could have heard a pin drop anywhere in the large assembly, and then 700 delegates and visitors broke out in a simultaneous, low, very emphatic "boo." I'll never forget it.

Senator McNary must have lost a lot of sleep over that letter, and I will venture to say that he wishes he had it back. It can only mean that the entire Townsment will be against him. But here is where the rub comes: The Townsmentites are definitely instructed to let politics strictly alone, and every Townsment club has a potential senator. I know of a half dozen already who have shown aspirations that way, and there will be more. Now, if these are all going to be allowed to run it will divide the Townsment vote into so many pieces that McNary will win the nomination anyway—so much for that.

The other item is the letter from national headquarters, printed in the last issue of the "Times," giving the order that no Townsmentites were to take part in local politics, that all effort was to be centered on the U. S. congress so as to get the Townsment plan enacted into law.

Now, I want to ask, what in the world are we going to do with a Townsment law if there is no attention paid to ways of enforcing it? And who are going to enforce it if it is not the local political aspirants all over the country, especially the judicial and law enforcement side of politics.

We have the 18th Amendment to our Constitution now. It is there and always will be, but what has become of it? Nobody enforced it.

PARAGUYAN VETS OUST PRESIDENT IN BRIEF REVOLT

Medford, Feb. 18th.

Paraguayans with full guarantees. The rebels, headed by Colonel Smith and Colonel Reclade, veterans of the Chaco war, emerged victorious from a series of street battles yesterday with loyal forces.

President Ayala, whose police and sailor defense forces surrendered before the superior strength of the rebel forces last night, took refuge aboard the tugboat Paraguay in the Paraguay river.

Foreign Minister Luis Riart, arrested by the revolutionaries, was held prisoner in the aviation school, the members of which—like the majority of the military forces in Asuncion—joined the rebels.

Colonel Franco, Chaco war hero who was dismissed from the army and exiled by the previous civilian government in connection with alleged communistic activities, was at his seat of exile in Buenos Aires, Argentina, and was expected to return soon.

With President Ayala aboard the gunboat was General Jose Felix Estigarribia, the commander of the Paraguayan army during the Chaco war.
