

### THORPE'S COUNSEL PLANS REOPENING OF ASTOR HEARING

and her daughter from this complete bondage and from being at the mercy of Dr. Thorpe, this fight was instituted.

"We also demanded that Miss Astor's diary, the contents of which have been so wrongfully used and without knowledge and consent, be turned over to the court and impounded and sealed. This demand was finally acceded to."

**Returning Funds**  
"Dr. Thorpe is returning to Miss Astor approximately \$5000 in negotiable securities which she had been forced to turn over to him in April of 1935 as a security."

"Miss Astor gallantly conceded to discontinue the annulment proceedings on the urgent insistence of the opposition."

Anderson said he would also petition the court to determine if it was contempt of court for Mr. Woolley to prepare in advance of the decision a typewritten copy to be handed out immediately after the decision. Anderson, asked if he would try to have Miss Astor's famous purple-inked diary brought into the case, replied:

"We thought Woolley had been acting in good faith. Now, with this statement prepared in advance by him, we don't feel at all secure."

"If he did not act in good faith, we may as well go through and air the entire facts in order to let the world know what we were up against and what we were willing to do to avenge the reputation of all parties mentioned in the diary."

**To Surrender Diary**  
Dr. Thorpe agreed to surrender his former wife's diary to the court. This is the diary in which Miss Astor kept a log of her thoughts and deeds and formed the basis for a sharp cross-examination during which Anderson quizzed her regarding her relationships with several prominent men.

Of the diary, Judge Knight said in approving the settlement:

"It is, therefore, an order of the court that the diary be possessed and sealed and placed in a depository for safe keeping. This depository cannot release the diary without an order of the court."

"Let neither parent feel that either has gained an advantage over the other." Judge Knight read from the bench, "for if there is any victory in this ending of a most unfortunate controversy, it lies in the fact that an innocent child has been spared the further likelihood of future grief and humiliation."

Judge Knight, father of several children, one of them a girl the same age as Marilyn, declared:

"This proceeding has from the very first been obscured by morbid sensationalism and by a tangle of publicity damaging to both parties. The chief victim, however, is a little child, whose inherent rights and welfare have seemed to escape adequate attention."

**WHEAT SUPPLIES HELD SUFFICIENT**

WASHINGTON, Aug. 14.—(AP)—Total wheat supplies in the United States were said today by the agriculture department to be "large enough for the usual domestic requirements."

In its mid-summer wheat outlook, the department predicted that shortages in red spring and durum wheat would require continued imports of these types.

The shortages were attributed to the drought and the department forecast a possibility that mills using spring wheat for the 1936-37 season might use a larger percentage of hard red winter and Pacific northwest wheat than last year.

Largely due to the soft red winter wheat in making bread flour might reduce imports of milling wheat, the department said.

The prediction was made in the survey that wheat prices in this country would continue to average higher than world wheat prices at Liverpool.

**Railroad Loading Slumps For Week**

WASHINGTON, Aug. 14.—(AP)—The Association of American Railways reported today loadings of revenue freight for the week ending last Saturday totaled 728,293 cars.

This was a decrease of 19,288 cars or 2.6 per cent, compared with the preceding week; an increase of 140,716, or 25.1 per cent, compared with a year ago, and an increase of 124,525, or 20.6 per cent, compared with two years ago.

"But I am sick of it all. If I live through this I'll live to be a thousand." Under Kentucky law, all persons convicted for rape, as is the custom in several southern states, those persons must be hanged in the county in which the crime occurs.

The sheriff, as the county's ranking peace officer, is assigned to direct the hanging whether he or she actually springs the trap.

**Watched From Auto**  
Mrs. Thompson, who had said she did not believe women and children should attend hangings, observed the execution from an automobile parked about 50 yards from the gallows. She drove away a few minutes after the hanging.

Davies county's woman sheriff kept secret until the time of the hanging the identity of the person to spring the trap. She had consulted with her priest and other clergymen whether it would have been proper for a woman to conduct the hanging.

Throughout the night the spectators pushed into choice positions to watch Bethea die for the ravishing of Mrs. Elza Edwards, 70, on June 10. Several women fainted in the crush after the hanging.

About half of those who fought and shoved to get closer to the enclosure were women, young girls and children. Babies in arms and toddlers by the score clung to their mothers.

**Cry for Victim**  
Towards 5 o'clock as the sun rose, a crimson disk, partly shrouded by the Ohio river's mist, men's voices, and women's began to be heard, crying:

"Where's the nigger?"

### Apple Better Orange As Vitamin A Source

BOSTON, Aug. 14.—(AP)—Science made the orange take a back seat at the international apple shippers convention here.

Science reported the orange, commonly believed to be a good source of vitamin A, contained only about one-half as much of the vitamin content as some varieties of apples.

Dr. Ira A. Manville, director of the nutritional laboratory at the Oregon medical school, and a noted scientist in the field of nutrition, said:

"Many varieties of apples have been found to be good sources of vitamin A, although some of the leading works on nutrition have credited apples as having only a moderate vitamin A content."

"Actually the vitamin A value varies with the variety, and while it is true that some varieties may be poor sources of this vitamin, the Spitzenberg, yellow Newtown, Wine-sap and Arkansas Black have from 24 to 36 units per ounce while the orange, commonly believed to be a
