

ST. MARY SCHOOL, HOME OF SHERIFF, MENAGED BY FIRE

Gym And Storage Room Destroyed In Saturday Blaze — Garage Burns.

Fire of undetermined origin yesterday afternoon destroyed the gymnasium, woodshed and storage room of St. Mary's Academy on South Holly street between 11th and 12 streets.

The home of Sheriff Syd J. Brown across the street at 504 South Holly street was threatened when burning cinders lit on the roof. A hose line, however, had already been run to the roof and the cinders were put out as they fell.

The firemen, assisted by 14 trained volunteers who answered the general alarm, put up a stiff battle to keep the fire from the school. They were aided by a favorable wind which was blowing away from the academy.

Damage was estimated at well over \$1,000. The loss was covered by insurance.

Apparently, Chief Roy Elliott said, the fire started in the storage room and spread to the gymnasium at 2 o'clock the flames had jumped across an alley to the gymnasium and both buildings were burning furiously when the firemen arrived. It took an hour and a half to put the fire out. An electric light pole at the curb was badly charred by the burning flames.

Electricians from the California Oregon Power company were on the scene to cut all wires so as to avoid death by electrocution and the company was commended for its cooperation.

There was no electric wiring in the woodshed and storage room and as a result the fire could not have started in the blaze, Chief Elliott said. He noted that rubbish had been burned in a metal barrel near the building in the morning and doubted whether sparks from it could have started the fire.

Sister Superior of the academy said she had no idea what started the blaze, she stated she had been unable as yet to calculate the actual damage and added that rebuilding plans would not be considered for several days. She praised the firemen for their work in saving the academy.

A large crowd gathered to witness the fire. The two buildings were frame structures.

It was the third serious fire of the week, the first general alarm blaze of the year.

Garage Burns. Fire destroyed a private garage and an automobile damaged two houses late Friday afternoon. Quick action by the fire department saved the dwellings. Chief Elliott said the fire was probably caused by a short circuit in an automobile parked in the garage.

The fire started in the stucco garage in the rear of the house at 115 Willamette avenue. The dwelling is owned by the Northwestern company and occupied by Mr. and Mrs. Robert D. Herriott. Mr. Herriott was at home asleep at the time. He had parked the car in the garage about noon.

The automobile was completely ruined and the garage gutted. The smoldering flames leaped to the Herriott house and burned part of the roof and window trim.

Damage to the house and garage was estimated from \$200 to \$400 by W. E. Thomas, Medford representative of the Northwestern company. He said the loss was fully covered by insurance.

The fire jumped to the adjacent house at 113 Willamette avenue, owned and occupied by Ernest W. Winkle. The upper part of the southeast corner was burned, the flames burning through a window and drenching the inside of one room. The damage was estimated by Mr. Winkle at \$300. The loss, he said, was fully covered by insurance. It was the second time the Winkle home had been damaged by fire.

The prospect alarm was sounded at 3:30 and the recall at 4:10.

FIRE RAGING IN OLD BURN BUTTE FALLS DISTRICT

State and COC crews were last night fighting a 30-acre fire on Ottinger creek about three miles southeast of Butte Falls.

The fire had been raging since 6 o'clock Thursday afternoon when it was discovered by Mrs. Ira Tunigale at the Prodenburg Butte lookout station. Widow of the state forest patrolman, Mrs. Tunigale is believed to be the only woman lookout in the forest service.

Crews were called immediately from Camp Prescott and Wimer to augment the state patrol. Another crew of 25 men from Camp South Park under federal forest service jurisdiction, helped to fight the blaze Friday night. About 100 men were on the job yesterday. Crews had been working continuously in 10-hour shifts since Thursday.

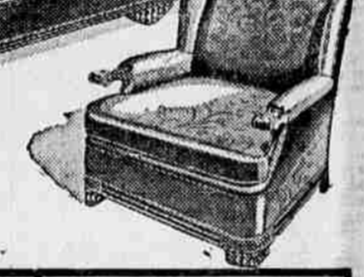

COLLEGE EXPECTS 3500 TO ATTEND

CORVALLIS, Aug. 29.—(AP)—Heavier advance applications from new students and transfers from other colleges have brought predictions from college officials that registration at Oregon state college may reach 3500 in the fall term which opens September 21, an all-time high mark for a single term if it materializes. Applications have fluctuated during the summer and acceptance now are more than 100 above the figure on the same date last year. More than 200 applications are still pending and many are being received daily. Added to the expected freshman class increase will be a probably heavy expansion in upper class totals as larger lower classes of the past two years move up.

Large increases in science, home economics, agriculture, and secretarial science are noted in freshman applications accepted. A larger increase in women students than in men is also indicated. Enrollment in the fall term last year reached 3186 credit students and for the entire year 3448.
