# YANKEES WIN 13-5 IN BATTING ORGY



**News Behind The News**

WASHINGTON, Oct. 6.—The Japanese have been marching and counter-marching up and down the Yangtze River valley where Britain's major interests in China are located. The British are worried. They did not much care when the Japanese took Manchuria in 1931. Their trade stood to gain by abolition of Chinese rule and misrule there. At that time, they could not get interested in former State Secretary Stimson's threats against Japanese aggression.



Now that the problem has moved right up against the British pocket-book, the situation is different. American newsmen in London lately have been obtaining unofficial interviews at the foreign office suggesting that Britain would like to use "strong pressure" on the Japanese in Shanghai and on up the Yangtze.

The significance of these London dispatches was not lost here. State Secretary Hull has found similar unofficial ways of letting it be known quietly that this time, he is not interested.

It means that any prospect for Anglo-American-Chinese-Russian cooperation against Japan is fast. Everyone will have to look out for his own pocket-book in the far east. Time marches—back.

Note—President Roosevelt's now fully developed far eastern policy is based on that of T. R. without much change. Advocating an independent foreign policy in Asia, Mr. Roosevelt, the first, once said: "I believe that our future history will be more determined by our position on the Pacific, facing China, than by our position on the Atlantic, facing Europe."

When the whole inside story of the monetary negotiations comes out eventually, you will find other evidences that the general popular suspicion of another Anglo-American understanding is not justified. Mr. Morgenthau's fancy rescue of the pound from degradation and despair was appreciated in London, but not in the way you surmised. The British would really have liked to have let the pound slide to get a "world trade advantage." Some say they wanted to stabilize it at low as \$4.40 or \$4.50. At any rate, Mr. Morgenthau and the British are far from an agreeable figure.

Many inner signs have hinted that we have a gentlemen's agreement with Britain on naval matters, but

## 7 RUNNERS CROSS PLATTER IN NINTH INNING OUTBURST

Yankees Wind Up Series With Assault On Giant Flingers — Gomez Turns in Good Performance

POLO GROUNDS, NEW YORK, Oct. 6.—(AP)—The Yankees won the first all-Manhattan world series in 13 years by four games to two today, crushing the Giants again in record-breaking sixth game final, 13 to 5, before a crowd of 38,427, the smallest of the series.

The battering American leaguers, winning the 20th series for their circuit against 13 for the National league, climaxed the day and the series by scoring seven runs in the ninth, breaking their own record for ninth inning rallies, set at six in the second game.

The Yankees' terrific power smashed four homers today, starting with unlicky Fred Fitzsimmons, just as it slaughtered five pitchers in the record-breaking 18 to 4 assault in the second game. Never before in world series history has a team gone down twice by such decisive margins.

The Yanks belted Fitzsimmons, Clyde Castleman, Dick Coffman and Harry Gumbert for 17 hits, including a home-run by Jake Powell, hitting star of the day with three safeties, and a tremendous triple by George Selkirk. Only Bill Dickey and Frank Crosetti failed to hit safely in the rising bombardment.

The Yanks touched off the day with two runs in the second on Fitzsimmons, unlucky loser of a four-litter in the third game, one in the third, and chased him 'o the clubhouse with another two-run assault that brought in Castleman in the fourth. The young right-hander got along nicely, giving up only one run until removed for a pinch hitter in the eighth. The last seven were a final salvo at Coffman, who allowed three hits and a walk while getting one man out, and Gumbert, who stayed on to the bitter end, allowing

## FRED L. TRAVIS DIES OF HEART ATTACK AT WRESTLING MATCHES

Death visited the wrestling matches at the Armory last night when Fred Lewis Travis, 63, a resident of Medford for the past three years, succumbed to a heart attack in the excitement of the opening bout between Prince Mihailakis and Billy Burns.

Death came to Mr. Travis shortly after he had told his son-in-law, Dale Friend, that in the excitement he was finding breathing difficult.

He slumped over backward and was immediately rubbed to the open air, but was dead before a doctor could be summoned. He was not a regular attendant at the wrestling matches, and his son-in-law said that he had been having trouble with breathing for some time, although none of his family suspected that he had a weak heart.

The dead man was born at Plainville, Mo., November 5, 1872. He had been a farmer most of his life and came to Medford in 1933 to live with his daughter, Mrs. Dale Friend of route 2.

Besides his daughter he leaves one sister, Mrs. Fay Brinkman of Fairbury, Neb. Funeral services will be announced later from the Peck Funeral Home.

## BURNS BOY KILLED IN HUNT ACCIDENT

BURNS, Oct. 6.—(AP)—Southeastern Oregon chalked up its first hunting fatality of the season with the death of Arthur Jones, 18, Burns. The youth died in a hospital here a few hours after a bullet from his accidentally discharged gun shattered his right shoulder.

Jones, a mill employee, was hunting with a group of friends on Emigrant creek, 45 miles northwest of Burns. He died last night.

## SHIMODA TO COLLECT ON NOTE BY DEFAULT

An order of default was signed yesterday in circuit court in the suit of Kametchi (Shorty) Shimoda against Isao (John) Kado, for the collection of 4000 yen loaned in the "Eighth Year of Showa," and secured by several shares of California-Oregon Power company stock. The loan was made in 1934 by Shimoda to Kado, and past due, the complaint stated.

Kado, former well-known member of the local Japanese colony, is now in Japan. A summons sent to Tokyo was returned marked "not found."

The amount involved is about \$1500 American money.

## MULTNOMAH BOURBONS REGISTRY INCREASED

PORTLAND, Oct. 6.—(AP)—Multnomah county Democratic pulled up to within 855 of the Republican total when the registration books closed here Saturday night. The G. O. P. had a registration of 89,621 as compared with 88,766 for the Democrats.

## 3000 WELL-TO-DO SLAIN BY MADRID EXECUTION SQUADS

Refugees Say Bands of Bloodthirsty Young Murderers Repeating Horrors of French Revolution

HENDAYE, Franco-Spanish Border, Oct. 6.—Reliable advices brought here by refugees from Madrid, today state the Spanish capital's extremist "execution squads" had killed well over 3,000 middle and upper class citizens.

Bands of "bloodthirsty young murderers," the refugees said, are responsible for the executions. The travelers described the death squads as the Spanish counterpart of the French "sans-culottes" of 1789, who, with bloodsoaked tumbria, daily fed "Madame Guillotine" with aristocrats.

While the municipal morgue squad's figure for corpses collected on the outskirts of Madrid reached a record one-day low of 15 early in September, it soared to 82 in one day a fortnight later.

Party Friction Blamed  
One explanation of the increase, the advices said, might be found in new friction over political concessions between the revolutionary Socialist government and the syndical-

## FIRE AID QUOTA OVERSUBSCRIBED

Residents of Jackson county appealed to aid by the Red Cross for the homeless residents of fire-stricken Bandon responded by subscribing substantially more than the \$450 quota. George Frey, Jackson county chairman, announced today. A remittance of \$618.50 was sent by the county committee to San Francisco headquarters today. Frey reported.

Reports from other Oregon county chapters indicate the same sort of whole-hearted aid is being given throughout the state, with many counties going over their quota. Bandon people are facing consequences of the catastrophe philosophically and going about reconstruction of a model city, reports from there state, but will need the help of all sorts which is being extended by other Oregon citizens if they are to live comfortably during the winter months.

## Democrats Show Big Baker Gain

BAKER, Oct. 6.—(AP)—Registration in Baker county increased by 2228 during the period from October 11, 1934, to October 3, when registration books for the November election were closed, according to figures released at the county clerk's office today.

The Republican registration increased by 850 voters and the Democratic registration increased by 1591 voters, increasing the lead of the Democrats over the G. O. P. to 1414.

## Fire Precautions Remain In Effect

PORTLAND, Oct. 6.—(AP)—Although the forest fire menace has materially diminished, forestry officials said fire prevention precautions were still in effect.

In all forests but Mount Hood, Willamette and Shalal fire permits will be required except as specifically designated camps, smoking will be barred while traveling on all but paved highways and all persons entering the territories must have shovel, ax and bucket in their camping outfit.

## LIVESTOCK SHOW LURES NEAR RECORD THROGS

PORTLAND, Oct. 6.—(AP)—Clear weather and one of the largest entry lists on record continued to bring out record or near-record crowds at the Pacific International Livestock exposition today.

Officials said Monday's attendance of 7,000 was the largest recorded for any corresponding day total for the first three days well over 80,000.

## LONDON ATTACKS 'CENSORSHIP' AS F. R. HOLDS FIRE

G. O. P. Nominee Says Hopkins Has Shut Off News — Labor Leader Tells Roosevelt of Support

WASHINGTON, Oct. 6.—(AP)—President Roosevelt announced today that he would open his western campaign with a major speech Saturday night at Omaha, Neb.

Beyond that one engagement, the president would give no further details of the itinerary for the remainder of his political swing, on which he will depart Friday from Washington. Nor would he disclose the topic of his Omaha speech. White House officials indicated the full itinerary might be made public tonight.

While their supporters came to verbal blows, Gov. Landon attacked asserted "censorship" in Washington, but President Roosevelt temporarily held his fire today, devoting himself to conference before going to the front line campaign trenches once again.

Asserting "They're afraid of the waste and extravagance that publicity would reveal," Gov. Landon, Republican presidential nominee, said in a Topeka press conference today that Harry Hopkins, WPA administrator has "shut off the source of news."

Record For Public  
The governor went on to say that "Censorship of the source of news is just as bad as censorship of the news." He said WPA cost records and payrolls were public business and they should be available to the newspapers.

President Roosevelt returned to Washington from Hyde Park, N. Y., after a series of conferences with supporters. One of them, President William Green of the American Federation of Labor, reported that labor was "90 per cent" for the president.

Green said "Humanitarian policies under the administration ought to be continued and by those who inaugurated them."

Another caller, Frank Murphy, Democratic candidate for governor of Michigan, pointed to "industrial gains" Murphy said the automobile industry had been stimulated by wider distribution of purchasing power.

Knox Flails Away  
Flailing away at the administration, Col. Frank Knox said at Boston last night while President Roosevelt repudiated communist support he failed "peculiarly enough" to explain "why the communists want to see him re-elected."

Another attack on the new deal came from a Democratic former senator, James A. Reed of Missouri, who said at Newark, N. J., that its social program was "complete and absolute tyranny" leading to "enslavement of all people."

Joseph P. Kennedy, former chairman of the securities commission, upbraided the president in a New York speech and declared that it was legislation to regulate the securities business which first provoked hatred against Mr. Roosevelt.

On the other hand, Joseph B. Ely, former Democratic governor of Massachusetts, assailed "the Wallaces, the Licks and the Tugwells" as "socialistic." He said "I am for driving them out of government."

A dispute over relief methods continued. Harry L. Hopkins, relief administrator, said a demand of John G. Stutz, Kansas emergency relief administrator, for publication of WPA records, was "another one of those red herrings."

## SWEDISH AVIATOR ON FIRST LEG OF FLIGHT TO HOME

NEW YORK, Oct. 6.—(AP)—Kurt Bjorkvall, 31-year-old Swedish flier, hopped off from Floyd Bennett field today on the first leg of a projected trip to Stockholm.

Bjorkvall, who rejected the proposal that Baroness Eva Von Blixen-Flecken accompanied him, left the ground at 7:35 a. m., eastern standard time.

He planned to fly to St. John's, Newfoundland, where he will refuel for the Atlantic hop to Ireland and thence to Sweden.

"I hope I make the flight," was all the aviator said as he entered his plane.

The weather bureau said excellent weather conditions prevailed to Newfoundland with mild cross-winds but that off Cape Race a cold, westerly wind was blowing, sending the thermometer down to freezing.

The baroness, who had hoped to make the ocean journey, waved goodbye but expressed disappointment.

Bjorkvall's red and green monoplane has a wireless receiving set, but no sending apparatus. He planned to obtain weather reports at regular periods.

## AGED MAN KILLED BY FREIGHT TRAIN

EUGENE, Oct. 6.—(AP)—James W. Rector, 81, was killed instantly early this morning when struck by the engine of a southbound freight train at Halsey. Mr. Rector was said to be crossing the tracks to deliver papers, and is believed not to have heard the train, due to bad hearing. Rector was city marshal of Halsey and was well known in that community. For years he had had the morning paper route there and had turned the lights off and on since Halsey first had electricity.

## SILENT STEVEDORES MUST PAY PENALTY

SALEM, Oct. 6.—(AP)—The four defendants convicted of contempt of court for refusal to testify in the riot charges against Art Shearer, an outgrowth of the Portland longshoremen's strike in August 1934, must serve their six months' sentences, the state supreme court ruled today in an oral denial for rehearing of the case.

Paul Jennings, C. N. Abbott, Arthur Ruat and Karl Tigrert refused to answer questions as witnesses in the Shearer trial holding that their testimony might incriminate themselves.

## Rose M. Doda Dies At G. Pass Home

GRANTS PASS, Oct. 6.—(AP)—Rose Margaret Doda, 85, wife of William M. Doda, died at her home here yesterday. Funeral services will be held Saturday at 2 o'clock at the L. B. Hall funeral home.

Besides her husband, she is survived by a daughter, Doris Luana Doda.

## DOUGLAS TOWNSENDITES LIMIT ENDORSEMENTS

ROSEBURG, Ore., Oct. 6.—(AP)—Reaching a decision to limit endorsements to candidates for legislative offices, following a series of conferences on the question, the Douglas county council of Townsendites has endorsed Willis Mahoney as candidate for U. S. senator from Oregon and J. W. McAn as congressman from the first district, according to an announcement today by Clyde S. Shaw of Roseburg, district manager for Townsend clubs of Douglas, Coos and Curry counties.

## CAGE PLUMMETS 900 FEET WHEN CABLE SNAPPED

Bodies Badly Mutilated by Hundreds of Pounds of Broken Cable Plunging Through Cage at Bottom

MULLAN, Idaho, Oct. 6.—(AP)—Nine miners plummeted 900 feet to their deaths in the Morning mine, a property of the Federal Mining and Smelting company, near here, early today.

The men were just going off shift at 1 a. m., and were being loaded into a cage, or mine elevator. The steel cable snapped as the cage was only partly loaded, survivors said.

Only four of the badly mutilated bodies were identified by noon today. They were:

Andrew Kesse, 54, unmarried, a show-eler, Mullan.  
Peter Mihalakis, 28, unmarried, a miner, Mullan.  
Harry Phelan, 28, married, timberman, Wallace. His widow and four-year-old daughter survive.  
Cleo Purcell, 28, married, miner, Mullan; widow, two children, six and eight years old.

Bodies Badly Crushed.  
Positive identification could not be made until after the entire night shift had been checked. The remaining five bodies were crushed beyond recognition, and mine officials refused to give out more names until the shift roster had been checked again.

Jack Jameson, a miner, said the cage door had been opened, and he had started to step inside when the cable snapped, dropping the cage and its human cargo from the 3,000-foot level. He said he barely saved himself from plunging after it.

All nine bodies were taken to undertaking parlors at Kellogg and Wallace, nearby towns.

News of the tragedy was withheld by mine officials until about 8 o'clock and newspaper men who visited the plant were not permitted to enter. Even relatives of the miners did not learn of the tragedy for several hours.

A preliminary investigation indicated the cable broke about 1,000 feet above the level from which the cage was being loaded. Thus hundreds of pounds of cable crashed through the cage when it stopped at the 2,100-foot level after the 900-foot drop.

## Man Hit By Auto Scorns Medics To Attend Grappling

Wrestlers tough Phogey Medford has a citizen that is so tough that he got run over by a car last night, was taken unconscious to a hospital, came to in a chair at the infirmary, showed attendants made his way about to the weekly grappling matches, and through the carnage there, walked home, and not until then, did it occur to him that he was not in the old pink, whereupon he grudgingly turned into the bay for a couple of days.

The iron-man is Chester I. Parker, former restaurant owner, now living at 511 South Grape street. He was going to the wrestling arena last night when he stepped off the curb at Main and Barlett streets, crossing Main. A model Ford touring car, driven by Edward T. Jones, 15, struck him, knocking him over another car, according to city police. He was knocked unconscious and was taken to the Community hospital.

Dr. Russell Sherwood, who is now attending his brules, announced with incredulity today that he could find nothing wrong with Parker other than a few blisters.
