News Behind The News

WASHINGTON, Oct. 8.—The inner attitude of the crowd around President Roosevelt has changed perceptibly within the last week. Old & p r e h e n s i o n s about the election are fading. They may be fooling themselves, but they are going to be the most surprised politicians in the U. S. if the Literary Digest poll is right.

These boys are too old to believe in speeches. Their trust wisely rests in such practical matters as organization.

What makes them feel good right now is the accumulation of such carefully planned organization maneuvers as these:

The Minnesota deal, forming an alliance with the Farmer-Laborites; the Couzens conversion in Michigan; the split of Republican electors in Delaware; the personal drafting and nomination of Governor Lehman in New York; the John L. Lewis alliance and its possible effects in West Virginia, Illinois and Pennsylvania; the LaFollette alliance in Wisconsin; the ditching of Governor Davey in Ohio.

These are not all, but they are enough to explain why the White House coterie now feels better. If there is anything else they can do, they have not discovered it yet.

Treasury Morgenthau exuded an icy stare when the news came that Mussolini had devalued. There was no cheering, no comment.

It is always advisable not to make up your mind about events in Italy until you receive the text of official statements, and sometimes it is not even possible then to conclude what has happened.

There is an additional reason why officials here first considered any new monkeybusiness on the part of Mussolini or Hitler as irrelevant, if not immaterial. Mussolini has a greater variety of assorted lire than the average candy shop has different kinds of chocolates. They were not permitted to be exported or used freely in international exchange. Hitler has even a stronger ban on exportation of marks or gold.

WORLD COURT NAMES KELLOGG'S SUCCESSOR

GENEVA, Oct. 8.—(AP)—Dr. Manley O. Hudson of Harvard university, tonight was elected to the world court of international justice, succeeding Frank B. Kellogg, former United States secretary of war.

Dr. Hudson, fourth American to sit on the bench of the world court, brings comparative youth to the international tribunal.

A jurist of proven capacity, he is but 50 years old. The average age of world court judges is 66.

A native of St. Peters, Mo., Professor Hudson has had wide-wide experience in complicated judicial problems.

BOMBARDMENT BY LAND AND AIR TO FOLLOW REFUSAL

Air Fleet Shows Capital With Circulars Calling On Populace to Recognize Provisional Rebel Govt.

PARIS, Oct. 8.—(AP)—Dispatches received tonight from Talavera, Spain, said 300 persons were killed in an insurgent aerial bombardment of Aranjuez. Several bombs fell on a loaded troop train, the dispatches said, and a railroad station and section of track were destroyed, breaking communication between Madrid and Alicante.

BURGOS, Spain, Oct. 8.—Fascist insurgents, pressing their smashing drive to within striking distance of Madrid, demanded today immediate surrender of the Spanish capital.

The fascist ultimatum, served on the government as the insurgent high command announced capture of town after town almost in the environs of the capital, threatened destruction of Madrid by bombardment from land and air unless surrender were offered.

At the same time, an air fleet showered the city with circulars calling on the populace to show allegiance to the fascist provisional government, asserting that further resistance was useless.

Four columns of Generalissimo Franco's 120,000 men on the south and west fronts rolled back the harassed government defense line. In the immediate Toledo sector, a long awaited assault was launched on the city.

YREKA, Cal., Oct. 8.—(AP)—A prison term of from one to 50 years today faced Clifford Palmer, 19-year-old negro, convicted in superior court here of criminal assault on a four-year-old Mexican child at Dunsmuir.

District Attorney James Davis and Judge C. J. Luttrell said they would recommend to prison officials that Palmer be sterilized.

Shirley Temple Sued by Discoverer and Trainer

HOLLYWOOD, Oct. 8.—(UP)—John Hays, Hollywood producer and trainer of juvenile actors, today filed suit for \$500,000 damages and an accounting of the earnings of Shirley Temple, child actress.

He named in the suit the seven-year-old "child genius," Mrs. Gertrude Temple, her mother, G. F. Temple, her father, the Fox Film Corporation, 20th Century-Fox and California bank.

Hays declares in his complaint he discovered the child actress, trained her for pictures and developed her into a "\$5,000,000 personality, internationally recognized."

He said he entered into a contract January 23, 1932, to train Shirley in dancing, singing, voice culture and drama.

AGREE ON SETTLEMENT OF INSURANCE CLAIMS IN KLAMATH TRAGEDY

The civil suit of Anna M. Avery, executrix of the estate of Laurence Lister, former Klamath Falls butcher, slain February 1, 1935, against the Massachusetts Protective association for \$5000, on an accident policy, and \$2000 attorney's fees, was settled out of court this morning, by agreement between counsel and the federal court jury impelled to hear the case was excused. The amount involved in the settlement was not made public.

Miss Marion Meyerle, of Klamath Falls, charged with the slaying of Lister, as the climax of a romance, was acquitted by a Klamath county circuit jury.

A deposition from Miss Meyerle, now a resident of San Francisco, relating events that led to the fatal quarrel and shooting of Lister, was read to the jury yesterday. The deposition followed the testimony of Judge Moyrhan.

HONOLULU GREETED CLIPPER CARRYING FIRST PASSENGERS

Hawaiian Girls Hang Leis About Necks of Five Newspapermen in Inaugural Pacific Plane Service

By Charles E. Harner Associated Press Staff Writer HONOLULU, Oct. 8.—(AP)—With 17 hours and 48 minutes actual flying time behind us, the China Clipper alighted here shortly after the scarlet dawn amidst songs, and hand-claps of greeting.

Great leis were hung about our necks by Hawaiian girls as we stepped out on the landing float after the 2,400-mile flight. Officials followed with congratulations on the completion of the preliminary passenger flight to Honolulu, en route to Manila, from Alameda, Cal.

Welcomed by Planes Our approach to Hawaii was signaled by the appearance of army and navy planes which flew close to our wings.

Rapidly we approached the great island of Oahu on which Honolulu is situated, circled once across the city and then, turning in gradual descent,

ENGLAND SPURRED TO SWIFT ACTION BY SOVIET THREAT

Secretary Eden Cuts Vacation to Direct Policy After Ultimatum From Russia Against Aid to Rebels

BERLIN, Oct. 8.—(AP)—The propaganda ministry today emphatically denied Soviet Russia's charges Germany is delivering war material to the Spanish insurgents.

"We have adhered strictly to the non-intervention principle," a communique asserted. "We have delivered neither airplanes nor any other such materials mentioned in the Russian statement."

MOSCOW, Oct. 8.—(AP)—Informed sources said today Soviet Russia hopes Great Britain and France will abandon their "indifference" to alleged violation of the Spanish neutrality pact and take an equally strong position as the Bolsheviks.

Today, authoritative sources said, the Kremlin was withholding further action, awaiting moves by Great Britain and France.

Japs Stirred by Dud. HANKOW, China, Oct. 8.—(AP)—A "jud" bomb, tossed into a Japanese book shop in the former British concession, spurred Japanese naval authorities to take drastic "precautions" for the protection of Japanese life and property today. Whoever threw it escaped.

LONDON, Oct. 8.—(AP)—Great Britain turned a swift diplomatic hand today to patch a menacing break in the wall of European non-intervention in Spain.

Stirred by a flat Soviet Russian ultimatum threatening to aid the Madrid government if fascists do not "stop" helping the insurgents, allegedly with guns, planes and other kind of war, Foreign Secretary Anthony Eden broke off his Monaco holiday and turned toward home to presumably direct British policy.

In the wake of the Moscow warning came reports that other countries, as yet unnamed, would question alleged breaches of the "hands-off-Spain" pact at tomorrow's London meeting of the European non-intervention committee.

The reason, he declared, was that a truck went through the negro quarter a half hour before time for the rally, bearing the sign:

"Jesse Owens has left town; meeting called off."

TANANA MUTINY MAY HALT ALASKA STEAMER SERVICE

SAN FRANCISCO, Oct. 8.—(AP)—Alaska ship operators will lay up their vessels as rapidly as they reach Seattle, unless the labor dispute over the steamship Tanana at Dry Spruce Bay, Kodiak Island, is settled. At once, T. G. Plant, chairman of the coastwise owners' negotiations committee, advised the maritime commission at Washington today.

Plant informed the commission that "union action has made continuation of operations to Alaska utterly impossible."

T. B. Wilson, vice-president and general manager of the Alaska Steamship line, immediately announced cancellation of scheduled sailings of the steamships Oduna and Northwestern from Seattle.

"These sailings will be resumed when we have practical assurance they can be maintained without constant strikes and the tying up of vessels by the crews," Wilson declared.

BANK OF FRANCE CUTS RATE ON DISCOUNTS

PARIS, France, Oct. 8.—(AP)—The Bank of France, decreasing its discount rate to its lowest point during the regime of the socialist Blum government, disclosed today a 7,000,000 franc (\$25,242,000) rise in the value of its gold reserves.

The gold increase was announced in the first weekly statement of the bank since the devaluation of the franc. It was coincident with a decrease of from 2 to 3 1/2 per cent in the discount rate, in keeping with France's new easy money policy.
