News Behind The News By PAUL MALLON (Copyright, 1936, by Paul Mallon.) WASHINGTON, Oct. 27.—This week, Mussolini is holding out the olive branch. Last week, it was the bayonet. Next week it will probably be both. His talk is indicative only of the fact that world statesmen alternately talk peace and war with no real intention of having either.

Mr. Mussolini's current olive branch is stuffed with the usual promises. His anti-fascist opponents are calling it an incipient Italo-German alliance in preparation for the next war.

The Mussolini-Hitler perfidy resolves itself down to the most pressing question confronting world peace. How far are Messrs. Mussolini and Hitler going together? The answer may be more encouraging to peace than you would surmise at hand.

Next, there is the personal factor. Two Babe Ruths never play well on the same team. Babe Duce copyrighted this modern dictation business, and all diplomats will agree that he is the biggest man—that is, all will except Hitler. Babe Duce has let insiders suspect in many little ways that he considers himself the peer of the great international fence-buster, Mussolini will not like that.

SHACKLES BROKEN BY BRITISH JUDGE IN BRIEF HEARING

Mrs. Simpson On Stand Only 14 Minutes — Three Letters Presented — Husbands Misconduct Alleged

IPSWICH, Eng., Oct. 27.—(AP)—Mrs. Wallis Simpson, fascinating Baltimore-born friend of King Edward of England, won a divorce in a brief hearing at historic Ipswich assizes today.

Justice Sir John Anthony Hawke announced a decree nisi after hearing a few minutes of formal testimony. Costs of the case were charged to the defendant, Ernest Aldrich Simpson, who did not contest the divorce.

Hearing Short The whole hearing lasted just 17 minutes. Mrs. Simpson was on the stand for just 14 minutes.

She was questioned carefully by her attorney, Norman Birkoct, to bring out the facts of the most celebrated divorce case in the United Kingdom since the stirring days of Henry VIII.

She produced three letters, which she handed to the judge. Her evidence alleged that her ships' broker husband, a subject of the king, was guilty of misconduct at the Hotel de Paris, at Bray, near Maidenhead, Berkshire, at the end of July.

A bellboy, a waiter and a clerk identified the hotel register to show the alleged misconduct.
