

INSTITUTE DRAWS SCHOOL TEACHERS FROM 4 COUNTIES

700 May Attend Conference in Ashland Tomorrow and Saturday — Many Noted Specialists on Program

Teachers of Lake, Klamath, Jackson and Josephine counties will join tomorrow and Saturday with the Southern Oregon Normal school in what is expected to be the largest educational conference ever held in southern Oregon.

Under the law, each county must hold an annual teachers' institute, but may combine with other counties in doing so. The four counties have taken advantage of this arrangement to pool their resources with the Ashland Normal school and bring to

southern Oregon an outstanding group of educators.

The attendance at the meeting may reach 700, some of the teachers from the central Oregon county traveling as far as 300 miles to attend, officials said.

The program is arranged to be of vital interest to all types of teachers and of specific interest to several large groups. The speakers include Dr. F. W. Hart of the school of education, University of California; a national figure in education; Dr. E. C. Sisson, professor of philosophy; Reed College, reputed to be one of the northwest's ablest speakers and thinkers; Dr. C. L. Chambers, professor of learning and behavior problems; Dr. C. A. Howard, well-known superintendent of public instruction; E. F. Carleton, secretary of the Oregon State Teachers association, editor of the Oregon State Teachers' Journal and long a prominent figure in Oregon education; Frank Branch Riley, Portland attorney, writer and public speaker whose descriptions of the Oregon county are known nationwide; Miss Bertha Kohlhaugen, state supervisor of home economics education in Oregon, who will present the newly-made courses of study; and Miss Grace Forrester, considered one of Portland's most efficient primary instructors.

Plans are also completed for a banquet to be held tomorrow evening in the dining room of the Ashland Elks temple, which is expected to be attended by 300 to 500 teachers and the visiting speakers.

The executive committee in charge of the conference is composed of Dr. Walter Redford, president of Southern Oregon Normal school; County Superintendent Hazel Murphy, Lake county; County Superintendent Fred Peterson, Klamath county; County Superintendent Alice Bacon, Josephine county, and County Superintendent C. R. Bowman, Jackson county.

NEGRO PREACHERS GIVEN CHECKS BY G. O. P. CHAIRMAN

Remitted of Obligation to Support Ticket of London and Knox — Campaign Treasurer Remains Silent

BALTIMORE, Oct. 28.—(AP)—The Rev. J. Mitchell said today he had mailed \$5 checks to a number of negro pastors with letters reminding them "of their obligations to support" of the London-Knox ticket.

The negro minister, superintendent of the Washington conference of the Methodist Episcopal church (negro) and chairman of the clergy crusade circle of Maryland for London and Knox, said he sent out about 400 letters but not all contained checks.

Asked about the letters, Mitchell said:

"I sent out the letters. I reminded our pastors of their obligation to support the ticket of London and Knox. We took care of the expenses of any man who made any speeches for his time and trouble."

"We left it up to the pastors whether or not they would go to their churches or to themselves."

The checks bore the signatures of William P. Lawson, chairman of the Republican state central committee, and Henry Lay Duer, Republican state campaign treasurer.

FALL ART EXHIBIT DATES ANNOUNCED

The Southern Oregon Art association announces its regular fall exhibit to be shown free of charge at room 3, 107 East Main street November 18, 19, 20 and 21. All artists of southern Oregon are invited to exhibit their works, and are asked to have exhibits in place not later than noon, November 17, after which time nothing can be accepted. In addition to the local work, there will be presented a splendid exhibit of modern American paintings, which will be of interest to all art lovers.
