EXAMINER ADVISES DENIAL OF PERMIT FOR 81-MILE ROAD

pect of developing and marketing the timber and mineral resources of the area was too remote to justify a finding by the commission that the present and future public convenience require the construction proposed.

The examiner also said if the proposed line can earn the returns predicted by the municipalities, "it would seem that funds from private sources should be readily obtainable notwithstanding the inability of previous sponsors to secure such aid."

The report added the Southern Pacific railroad would have entered the area years ago if "it believed prospects were as glowing as depicted by the applicants."

Governors Favor The governors of Oregon and California have recommended the development, the latter asserting, according to the report, that the area between Grants Pass and Crescent City contained more lumber and mineral resources than any other area of like size in the United States.

The proposed railroad line was first surveyed in 1905 but was dropped when the San Francisco earthquake of 1906 destroyed the resources of its early sponsors. Grants Pass finally invested \$200,000 in building 10 miles of the line out of Grants Pass in 1913, but the war and subsequent financial difficulties prevented further development.

The area includes about 3,000,000 acres of timber, 116,947 acres under cultivation, and 1,265,513 acres of arid land.

SALEM, Nov. 10.—(AP)—Frank McCulloch, public utilities commissioner, said today the report received by the interstate commerce commission recommending the commission deny construction of 81 miles of railroad connecting Grants Pass and Crescent City, Calif., was not his report, but that of an examiner to whom the testimony was referred by the commission.

McCulloch said he represented the commission at the recent Grants Pass hearing, only to direct the taking of testimony and to transmit the full proceedings to the commission. He made no recommendations, although he had no recommendations, although Governor Martin urged construction of the line "should the commission find it feasible."

The public utilities commissioner said that interested parties, including the two cities, the utilities commissioner and the governor, would receive copies of the "proposed report" to the commission, after which they have 30 days under the law to file exceptions.

street and west on Main street to the starting point. All World War veterans will march together this year with their flags and organization banners at the head of the column. They will be followed by their auxiliary units and other affiliated organizations. All patriotic, religious, educational, fraternal, social, civic and service organizations have been invited to participate in the parade and many attractive entries are anticipated.

Martial music will be provided by a number of bands and drum corps throughout the line of march. Ashland Co-operating Ashland post of the American Legion is co-operating with Medford this year in staging one big Armistice celebration and will be represented by their colorful kiltie band and a large delegation of Ashland Legionnaires and auxiliary members.

Game at 2 P. M. Following the parade all veterans will be guests of the Medford Legion post at a free feed and open house at the Legion "Dugout," opposite the Roxy theater. Starting at 1 o'clock and continuing the rest of the day and evening, the unique "Dugout," reminiscent of the wartime era, will be open to the general public. In the afternoon there will be the annual gridiron battle between Medford and Ashland high schools and holiday programs at the local theaters, as well as roller skating at the armory roller rink. The special Legion strip tickets will be good November 11 at any theater matinee, the football game, roller rink, "Dugout" or the Armistice dance.

After the football combat, there will be free entertainment at the "Dugout" continuing until the dinner hour. This will not be restricted to ex-service men but will be open to the public.

In the evening the Armistice ball and floor show will draw hundreds to the Oriental Gardens, where the Legion has arranged a most entertaining all-star program combined with five hours of dancing from 9 p. m. to 2 a. m. by special arrangement, Medford post secured the popular orchestra and floor show which scored such a success at the "Streets of Paris" recently featured at the American Legion state convention. This is the first time a "big time" floor show has been presented in connection with a local dance and it is expected that scores will attend for the entertainment features which are said to be well worth the price of admission alone.

the legislative enactment is constitutional.

Evidence Lacking "A temporary injunction should not be granted on grounds of unconstitutionality unless a clear and convincing showing that property rights of the plaintiffs are in jeopardy, or that a multiplicity of suits will be prevented by granting such injunction." He held no such showing had been made.

Judge Skipworth added to his opinion that the situation should "remain in status quo until the case is decided on its merits."

Campbell said the matter now rests with the unemployment commission, but it was expected no legal action will be taken against the packing companies for refusal to make payments until the main case is decided. He anticipated the matter would come before Skipworth in about a month.

Attorney George M. Roberts, representing the packers in the suit against the state unemployment commission, said today, the next step in the suit, would be filing of an answer to the complaint by the state board.

The packers in the suit contended they come under the agricultural exemption clause of the jobs insurance law, on the grounds their work is seasonal, and a large portion of their employes are transient workers, residing outside of Oregon.
