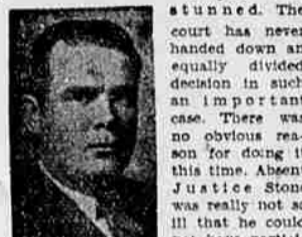

# GERMANY, JAPAN SIGN ANTI-RED PACT

WASHINGTON, Nov. 25.—The supreme court took the west way out in that New York state employment insurance decision.



Lawyers were stunned. The court has never handed down an equally divided decision in such an important case. There was no obvious reason for doing it this time. Absent Justice Stone was really not so ill that he could not have participated in the urgent decision. Even if he was, the court could have waited a few days until he got better.

But that course would have publicized the division of the court. It would have meant another 5 to 4 decision, with lengthy argumentative majority and minority opinions. Editorial commentators could have pounded their smoking typewriters until the judgment of all, including the commentators, was apoplexiated.

This way, there is nothing to comment about. No opinions were offered. Not even the actual division of the court was made public. And the state insurance law stands upheld, as it would have stood had there been all the fanfare of a customary decision.

Thus did the court demonstrate not only judicial, but executive, capacity. No inside information is needed on the division of the justices. The way they voted was obvious to any close follower of the court. But if anyone had obtained any inside information, it would have shown the following line-up:

Furthermore, if Justice Stone had been polled at home, he would have been found with the upholders of the employment insurance act, thus creating a 5 to 4 majority for the state law.

Some will say this line-up means a shift within the court. They will interpret the vote of Justice Roberts as an indication that he has left his four dissenting compatriots and created a majority out of the minority formerly composed of Justices Hughes, Brandeis, Cardozo and Stone.

This is assuming too much. Roberts voted with his new associates in the New York milk case and several others last season.

## NARCOTICS PEDDLER RECEIVES STIFF JOLT

PORTLAND, Nov. 25.—(AP)—Ten years in prison and a \$3000 fine will be the price David E. Bow, 33, must pay for selling narcotics. The prisoner, who claimed he once was a guard of honor for President Wilson on a visit to France, sought leniency because of a war record.

"I appreciate any man's war record but in view of this man's long criminal record, there is no room for leniency," said Federal Judge James Fee. Bow pleaded guilty.

## WILL COOPERATE AGAINST SPREAD OF COMMUNISM

Two Powers Bound for Five-Year Period—Other Governments Invited to Join for Concerted Action

MOSCOW, Nov. 25.—(AP)—The first Soviet-Japanese military clash since conclusion of the Japanese-German alliance against communism was reported today in an official Russian communiqué.

Several Japanese and Manchoukuo soldiers were killed yesterday in a far-eastern border clash with Soviet frontier guards, the communiqué stated.

Germany and Japan strengthened the world alignment against communism today, charging the "internationalism known as the Komintern" as a "threatens world peace at large."

At Berlin the long reported alliance between Germany and Japan directed against the world communist organization, with headquarters in Moscow, was formally signed before the assembled diplomatic corps.

In Moscow, where previous reports of the accord had drawn the charge that it was a military alliance against the Russian government, Joseph Stalin, secretary general of the communist party, prepared to present the new Russian constitution to an assembly of 2,000 elected delegates.

To Oppose Internationalism  
The accord binds the two powers for a five-year period to take strict measures against persons who serve the communist internationalism and cooperate in an international campaign against communism.

## AGED MAN DROPS DEAD WHILE HOUSE BURNING

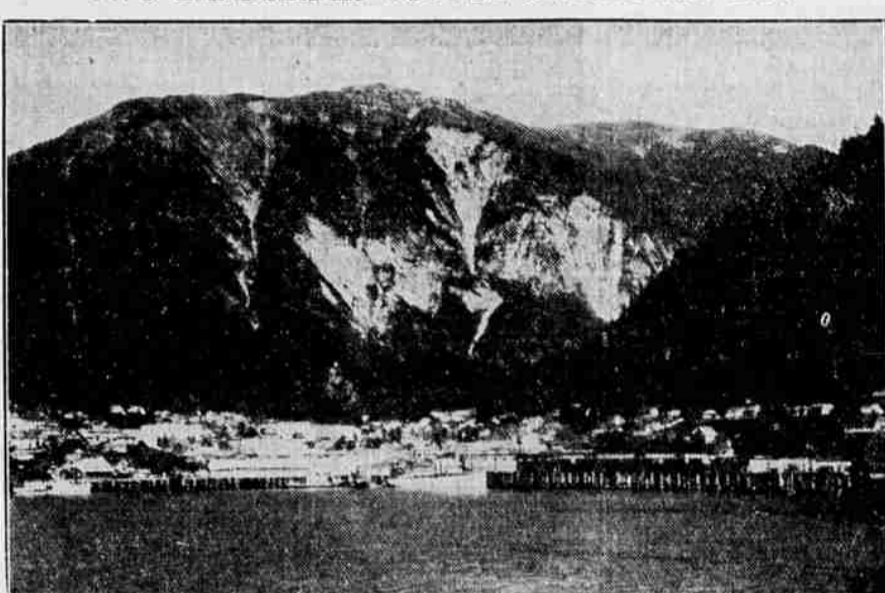
HILLSBORO, Nov. 25.—(AP)—The attempt of an 82-year-old man, Carl Linder, to save his home cost him his life.

## LINDBERGH CAUSES FEAR FOR SAFETY

LONDON, Nov. 25.—(AP)—Col. Charles A. Lindbergh landed at 4 p. m. yesterday at the Royal Air Force airbase at Sealand, near Chester, and drove away without a word. It was established tonight.

That settled definitely a day and a night of near-panic resulting from absence of any report of the colonel's arrival following a three-hour flight from Ireland.

It was presumed Lindbergh had gone to his home, "Seven Oaks," in Kent.

Even before his whereabouts were established, anxiety had been eased by the terse assurance, "The colonel is quite safe," from a woman at the flier's country house.

## GALLI CURCI GIVES LISTENERS NERVES

CHICAGO, Nov. 25.—(AP)—A voice once hailed as the greatest of the coloratura "sounded last night in Chicago's Pink and Gold opera house. A packed house listened in agonized suspense. Then the critics gave their verdict:

Galli-Curci, the magnificent, had faltered in her comeback—but there still was hope.

Listeners remembered that Mme. Galli-Curci was making her first professional appearance since an operation for gonorrhea 15 months ago.

Edward Barry in the Tribune said the famous singer gave herself, her audience and the critics "one of the most fearfully nervous evenings in operatic history."

## HIGHWAY PEDESTRIAN VICTIM HIT RUN AUTO

HILLSBORO, Nov. 25.—(AP)—A call to the sheriff's office that a "drunken" man was wandering on the highway west of here, led to the discovery of a body identified as that of J. J. Doyle, a visitor from somewhere in Wisconsin.

Examination indicated the man had been struck by a hit-and-run driver, but not the motorist who was apprehended. The neck was broken. Doyle came to Cornelius, three miles west of here recently to visit friends and was apparently walking to Cornelius when he was killed.

## BLAZE THREATENS MONTEREY'S FISH CANNING INDUSTRY

Worst Fire in Years Destroys Delmar Canning Plant—Loss Goes Over Million—Neighbor Towns Helping

MONTEREY, Calif., Nov. 25.—(AP)—Fire departments of Monterey, Pacific Grove, Carmel and Salinas battled today to save Monterey's half million dollar sardine industry from destruction in one of the worst fires here in many years.

The Delmar Canning company plant, where fire started early today was destroyed, and combined efforts of the four fire departments was being devoted to halting spread of the flames to other plants.

Loss at the Delmar cannery was estimated by officials at between \$1,000,000 and \$1,500,000. The loss included two reduction plants, a canning plant and warehouse and many thousand sacks of fish meal and cases of fish.

PORTLAND, Nov. 25.—(AP)—Shifting winds removed a fire threat today from the coast resort of Oceanside but elsewhere over Oregon winds continued strong and U. S. forest service officials said the potential danger of major conflagrations was "extreme."

## NEGRO USED FOR TARGET PRACTICE

DETROIT, Nov. 25.—(AP)—Dayton Dean told a jury in recorder's court today that Billie Coleman, negro World War veteran, was shot to death in May, 1935, because Harvey Davis, Black Legion colonel, wanted "some target practice."

Davis and four others on trial for murder, glared in silence while Dean who is under life sentence for the Black Legion killing of Charles A. Poole, testified as the state's principal witness.

The other defendants are Charles Rouse, who had been Coleman's former employer; John Banerman, Ervin D. Lee and James Roy Loran. Banerman, Davis and Lee also are under life sentence for the Poole murder.

## PROTEST PLANNED ON MILK PRICES

PORTLAND, Ore., Nov. 25.—(AP)—Plans to file petitions demanding the state milk control board rescind its order increasing milk prices in Portland went forward today under the sponsorship of a housewives' committee.

At a protest meeting last night presided over by Mrs. Charles G. King the 150 in attendance were told 15,000 signatures would be obtained on the petitions by the end of the week. A large share of those at the meeting were producers and distributors.

Speakers in the main stressed their major interest in the controversy was to see that children were enabled to obtain milk.

## THREE YEAR SENTENCE BAD CHECK OPERATOR

ROSEBURG, Ore., Nov. 25.—(AP)—The long fight of Frank Harper to avoid the Oregon penitentiary ended today when he was sentenced by Circuit Judge Carl Wimberly to three years in the state prison after pleading guilty to a charge of attempting to obtain property by false pretense.

## 9 DEAD, 65 HURT WHEN ELEVATED TRAINS COLLIDE

Victims of Chicago Wreck Trapped in Wooden Coach As Heavy Steel Car Plows Through—Blame Unset

CHICAGO, Nov. 25.—(AP)—The worst elevated train wreck in Chicago history left nine dead and at least 65 in hospitals today. Little hope was held for the recovery of two other victims.

## AUTOIST KILLED BY CRASH INTO STALLED TRUCK

EL CENTRO, Cal., Nov. 25.—(AP)—Two men rolled out of danger from under a truck they were repairing a few seconds before an automobile struck it, killing the driver of the car.

An inquest was called today at Yuma, Ariz. in the death of Oscar Franzen, 85, Stirling City, Cal., driver of the machine that crashed into the truck.

E. Snyder, driver, who with his mechanic was under the truck, told Lewis Mitchell, California highway patrolman, that Franzen's car knocked down five warning flares before it hit the truck.

Deputy Coroner Frank Roney found three unopened checks in Franzen's clothing, signed by William von der Hellen, a general contractor of Medford, Ore. There was also a notice of termination of employment.

Franzen's body had to be cut out of his car. The truck was overturned by the impact.

## PAIR ARRESTED AS GEM SMUGGLERS

NEW YORK, Nov. 25.—(AP)—The arrest of a Bronx couple as suspected participants in a diamond smuggling ring operating between New York and Antwerp, and the seizure yesterday of \$130,000 in gems was announced today by customs officials.

The woman, described as Mrs. Pearl Josephine Weinberg, was arrested when she disembarked yesterday from the Normandie. Gregory W. O'Keefe, supervising customs agent said, and the diamonds were found in the false bottom of a suitcase.

Her husband, Isaac, was arrested when he met her at the pier. O'Keefe, who said the seizure was one of the largest made by customs officials at this port, said the couple would be arraigned before United States Commissioner Garret W. Coster.

## LEGION TO STAND WITH UNION LABOR

TAMPA, Fla., Nov. 25.—(AP)—Harry W. Colmery, American Legion commander, told the American Federation of Labor convention today the Federation and Legion would stand "shoulder to shoulder" against encroachments on American liberties.

Although the Legion opposed "cheap and sandy nationalism," Colmery asserted, it would be "vigilant" in its guard against communism, fascism, nazism or any other governmental philosophy that would abridge freedom.

Revolution flourished, Colmery said, only where liberty was strangled.

1. Your breathing comes more difficult.
