

4-DAY VACATION FOR STUDENTS OF CITY'S SCHOOLS

Senior Leaguers Distribute Thanksgiving Day Feast Supplies — Junior High School Stages Pageant

With the close of school this afternoon, students and teachers throughout the city will be relieved of classroom worries for four days during the Thanksgiving holidays. A large number planned to attend the Medford-Eugene high school football game tomorrow in the university city and many Medford residents will join the students in the trek north.

Thanksgiving activities at the senior high school were concentrated on the distribution of food baskets to needy families. The project is sponsored annually by the boys' and girls' league and is under the girls' league social service committee headed by Betty Jane Pennington and directed by Miss Maurine Carroll, dean of women. Baskets containing approximately a week's supply of food were sent to 18 families, ranging in size from 2 to 8 persons in each. Milk, butter, bread and meat were purchased by the girls' league treasury and other articles were contributed by the student body as a whole, each one bringing some article of food. Twenty students worked yesterday afternoon assembling the food which was distributed by ten cars. The project has been carried out for the past several years and is considered one of the most worthwhile activities of the school. Contributing to the project this year were Gateway stores, giving 20 pounds of coffee, and S. M. Tuttle, manager of Southern Oregon Sales, Inc., who gave Omeice pears.

The next activity of the social service committee will be the annual Christmas party for under-privileged school children of the city. Observance of the holiday at the Junior high school was made this afternoon as assembly when a Thanksgiving pageant was presented by seventh grade pupils and the English department, under Miss Annette Gray and Carl Boswell.

The program included a play by 7th grade pupils and a pageant depicting the sentiment and significance of Thanksgiving. The school orchestra presented several numbers in addition to the other features.

Many teachers whose homes or families are out of town will take advantage of the holiday to visit relatives and friends. Among them will be Mrs. Gertrude Gates, Miss Carin Degermark, Miss Helen Winters, Miss Gertrude Ahlstrom and Miss Maurine Carroll. All of whom will motor to Portland.

Others going north will be Alice Spurgin and Laura Phillips, who are driving to Eugene, Freda Schneider who will visit in Woodburn and Dorothy Young, who is also going to Portland.

MEDFORD CCC CAMPS TO EAT 4500 POUNDS OF VALLEY GOBBLERS

Four thousand, five hundred pounds of southern Oregon turkey will be consumed in CCC camps of the Medford district tomorrow, according to figures available at local headquarters.

Although turkey appears frequently on the camp menus for Sunday dinners and special occasions, every one of the 24 Medford companies will build its Thanksgiving dinner around the traditional bird, said Captain Herman J. Meiring, district quartermaster. All of the turkeys for the camps have been purchased in southern Oregon.

Typical of the camp menus is the Thanksgiving bill of fare planned for headquarters detachment here by Capt. Albert T. Anderson, commander, and Richard W. Fry, mess sergeant. It follows:

- Fresh oyster soup with crackers;
- roast young Oregon turkey with fresh oyster dressing; snowflake potatoes; candied sweet potatoes; buttered whole corn; shrimp salad; giblet gravy; celery hearts; ripe olives; extra fancy apples; cranberry jelly; oranges; Parker House rolls with butter; mince pie; coffee with cream; candy and cigarettes.

Families of detachment men will be guests of the organization at the Thanksgiving dinner tomorrow.

COUNTY OFFICIALS FOR HIGHER SHARE STATE ROAD COIN

State Association Goes On Record for Plan to Divert Highway Revenue for Improvement County Roads

PORTLAND, Ore., Nov. 25.—(AP)—Harmony as to road fund allocations and a vigorous demand for an increased works progress quota marked the close of the state association of county officials today.

Judges and commissioners went on record unanimously favoring a plan to ask the state highway commission to divert to them for county road improvements 15 percent of the revenues accruing to the state highway commission—thus increasing county receipts from that source from \$1,500,000 to \$2,000,000.

Commission Favors The \$400,000 increase was proposed by Wallace Wharton, executive secretary to Governor Charles Martin, after the county officials had suggested the amount be boosted \$50,000.

It was understood the highway commission would join with the judges and commissioners in asking legislative permission for the change. Adoption of the resolution demanding that the works progress administration rescind its latest order to bar from WPA jobs all those over 65 years of age and asking that it raise its state quota from 14,800 to its one-time total of 22,000 followed a talk by state relief administrator, Elmer County.

All four county groups—judges and commissioners, clerks and recorders, engineers and treasurers—closed their annual session with a banquet last night. The first three organizations named officers at their concluding business sessions.

Day Re-elected Frank Shull, Multnomah county commissioner, was re-elected president of the judges and commissioners' association and Judge Earl B. Day of Medford was re-elected vice-president. Roy S. Nelson, Marion county commissioner, was chosen secretary-treasurer.

The judges and commissioners named to their executive committee: district 1, Judge Charles E. Baird, Baker county; district 2, Judge Geo. D. Grizzle, Klamath county; district 3, Judge George A. Potter, Sherman county; district 4, Judge Earl B. Day.

Jackson county: district 5, Judge Fred Pike, Lane county: district 6, Judge Donald T. Templeton, Washington county.

Treasurers elected as president, Homer G. Parrott, Yamhill county; vice president, J. R. Johnson, Wasco county; secretary, Naomi Van Gilder, Sherman county.

SHADDUCK URGES OARP ENTHUSIASM

PORTLAND, Nov. 25.—(AP)—A plea to "build up enthusiasm until the national plan is ready" faced Oregon Townsendism today.

Dr. Ralph I. Shadduck, state area manager, at a pre-legislative session here last night, urged continued membership work, stayed "attempts to spend the country's way to recovery," said the "Democrats will get fat and lazy and corrupt like the Republicans," and declared he had almost finished writing a memorial for the state legislature.

COUNTY COURT PLANS SESSION ON FRIDAY

Members of the county court, in attendance at the Oregon County Courts convention in Portland, will return tonight and hold a session Friday. There was no session today, the regularly scheduled date.

Principal business at the Friday session will be the formal and official signing of the county budget for 1936. The budget was passed and approved at the public hearing last Friday.

The budget will be turned over to the county assessor at once for extension on the tax rolls and fixing of levies.

VIOLA BECK LOSES DRIVING LICENSE FOR SPEEDING CAR

Mrs. Viola Wood Beck, charged with reckless driving, had her driver's license suspended for one year and was fined \$50 and costs in Justice of the Peace William R. Coleman's court this morning when she entered a plea of guilty.

"It is a matter of common knowledge among a great many people, that your driving has been very bad. You have been a menace on the highways, not alone to yourself, but to the life and property of other people," Justice Coleman said. "This is your second appearance in this court. I warn you now if you appear again, you will receive no leniency from this court."

Mrs. Beck, who appeared in court with a bandaged head, as the result of an auto mishap, solemnly assured the court: "I will never drive again."

A state trooper testified Mrs. Beck drove south on the Pacific highway at a high speed and "I had to go the limit of 75 miles per hour to catch her." The two cars went through Phoenix at 65 miles per hour, the officer said. Mrs. Beck was overtaken near the county farm.

Mrs. Beck claimed that she was speeding to reach her husband, ill in a Klamath Falls hospital. Rutherford Burchard Hayes Pierce of Grants Pass, was sentenced to 30 days in the county jail for driving an auto when his driver's license was revoked. Pierce figured in an auto mishap near the overhead crossing in Ashland several weeks ago. His case has been found a not true bill. The justice court charge was then filed by the district attorney.

Alvin E. Reinking of Jacksonville, and Bert Ellis of this city were each fined \$5 and costs for exceeding the speed limit on the Crater Lake highway. They are logging truck drivers, and were following each other, traveling at 45 miles per hour, the testimony showed.

David C. Braun, a grocery truck driver, was fined \$5 and costs for excessive speed on the Pacific highway.

'DEHORN' SELLER MUST PAY HEIRS OF VICTIM

PORTLAND, Nov. 25.—(AP)—Lee Boyer, administrator of the estate of Arthur Johnson, won a verdict of \$100 in circuit court against Solomon Miller, former drug store proprietor serving a three-year prison term on manslaughter charges growing out of the deaths of addicts who drank wood alcohol.

Miller was accused of selling synthetic methanol to Johnson as denatured alcohol in 1934.
