

Savich to Unleash Sonnenbergs Against Mean Smolinski Tonight

EX-GRIDIRON STAR TOUTED TO TAME VILLAIN GRAPPLER

Toots Estes Returns for Match With Pete Baltran in Middle Event — Carr and McEwan Open Card

It's cleanie versus meanie in the main event of Promoter Mack Lillard's weekly grappling card at the Medford Armory tonight when Danny Savich, Sonnenberg, savage-hitting ex-military Utah pigskin performer, tangles with the ace villain of the local ring, Joe Smolinski.

Uses Football Tactics

The Savich-Smolinski bout, from pre-match appearances, seems destined to go down in local wrestling history as one of the most sensational ever seen here. There have been few, if any, members of the grunt and groin fraternity who pack the color, dash and fan-appeal as exemplified in the clean wrestling Savich. His thundering Sonnenbergs, his thrilling flying tactics, and his great all-around wrestling ability has placed him at the very top among all local grapplers.

Smolinski, the Polish Palooka, will be no setup. In fact, Smolinski will be about the toughest opponent Savich has ever faced here. The unorthodox and underhanded tactics of the raging Pole are second to none, and since the disappearance of Terrence Ted Christy from the local house of horrid happenings, no grappler has even approached Smolinski in the matter of pure and unsoldiered dirt.

Estes Also Ex-Gridman Another ex-gridiron star will be seen in the middle event when Toots Estes, former Oklahoma A. and M. grid luminary, returns to the Medford ring after two years of absence to meet Pete Baltran in an Australian system match.

Estes, in former appearances, proved that he knew most of the answers, and was one of the most popular men to ever show here. He is a big fellow, and his sparkling and clean methods won him many friends.

Roly-poly Charley Carr, the aggressive fish who has had tough luck in most of his local bouts, will form the one-man welcoming committee for Billy McEwan from San Antonio, Tex. It will be McEwan's first appearance on the Pacific coast, and reports from the land of cowpunchers are that he is on his way to becoming one of the country's top-notchers.

Plans for a five-way track and field meet to be staged on the high school field next Saturday afternoon were announced today by Coach Bill Bowerman of Medford high. Invitations had been extended to Grants Pass, Central Point and Kerby to send teams, the coach stated.

At the same time, plans were being made to stage a Junior meet Friday afternoon between teams from the same school with Jacksonville included. The Junior meet will be for performers 16 years of age and under.

In an attempt to procure a Portland high school team for a dual meet May 1, Bowerman has been contacting Washington high for the past week and, as yet, no definite word has been received from the metropolitan school. Bowerman stated today that if Washington high was unable to appear here on that date, a southern Oregon invitational meet would be held with all schools in the district competing.

Time trials for positions on the Medford high team will probably be held Wednesday afternoon, Bowerman said. The best performers will take part in the meet Saturday.

Twenty-two potential members of Medford's Southern Oregon league baseball entry got the winter kinks out of their arms yesterday morning at the high school field in the first official workout of the year, and after two hours of hitting and fielding practice, including a five-inning practice game, called it a day and went home to nurse aching muscles.

The consensus of opinion of Medford Athletic Association officials following the workout was that the local team would be in the pennant race from beginning to end. Next practice session will be held tomorrow afternoon at the high school field at 5 o'clock. It was announced.

Facing each other in the short practice game yesterday were Ray Erickson, right-handed hurler of last year's club, and Alvin Merritt, also a right-hander and a former Medford American Legion chucker. Both pitchers worked easily, confining their deliveries to fast balls.

Those showing up well at the plate were Dick Lewis, Hoffman, Merritt, Donovan, Dick Sakralda and Virgil Swanson. Lewis hammered out the longest hit of the day, a line drive that traveled fully 300 feet, and Donovan, a third sacker who saw action with the Medford team two years ago, also connected for several lousy drives.

GOVERNMENT WINS MAJOR VICTORY IN LABOR RELATIONS

(Continued from Page One.) by freely selecting those to whom his manufacturing operations are to be entrusted. We think this cannot lawfully be done in circumstances like those here disclosed.

"It seems clear to us that congress has transcended the powers granted."

Although Justice Sutherland read his dissent to the Associated Press decision immediately after it was delivered, Justice McReynolds did not announce the dissent to the other three cases until after all had been decided.

Looking over the audience, he said: "I have written our joint views and I will not stop to read it. I think I can give you some understanding of what these opinions mean."

No Strike Ban He then read provisions of the act and said it did not "prohibit strikes." "This act is leveled at employers," he continued. "The character of employment has nothing to do with it. We are told the act is intended to prevent employers from discharging employees who belong to a labor organization."

"It has been held by this court for 50 years, and especially for the last two, that manufacture is only incidentally related to interstate commerce and congress has no power to regulate it."

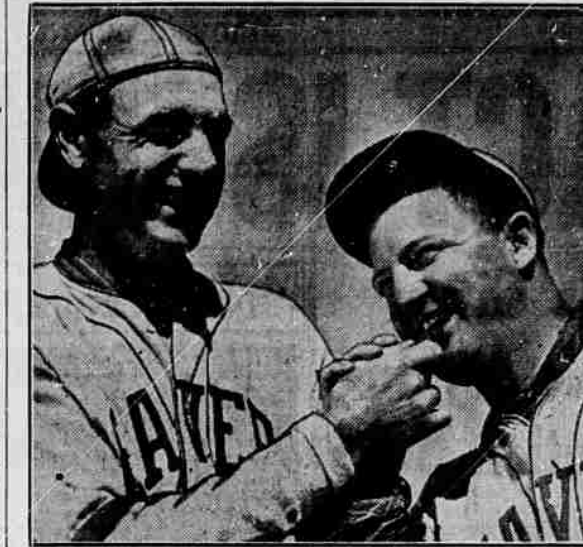
In the steel opinion, reading rapidly and frequently glancing about the packed court room, Hughes asserted that "the steel industry is one of the great basic industries of the United States, with ramifying activities affecting interstate commerce at every point."

"The government," he continued, "aptly refers to the steel strike of 1919-1920 with its far-reaching consequences. The fact that there appears to have been no major disturbance in that industry in the more recent period did not dispose of the possibilities of future and like dangers to interstate commerce which congress was entitled to foresee and to exercise its protective power to forestall."

Relationship Stressed "It is not necessary again to detail the facts as to respondents (Jones and Laughlin) enterprise. Instead of being beyond the pale, we think that it presents in a most striking way the close and intimate relation which a manufacturing industry may have to interstate commerce and we have no doubt that congress had constitutional authority to safeguard the right of respondent's employees to self-organization and freedom in the choice of representatives for collective bargaining."

(The legislation guaranteed collective bargaining to workmen and set up the national labor relations board to aid in settling industrial disputes. It was termed "labor's magna charta by William Green, president of the American Federation of Labor.)

"have correlative right to organize for the purpose of securing the redress of grievances and to promote agreements with employers relating to rates of pay and conditions of work. Restraint for the purpose of preventing an unjust interference with that right cannot be considered arbitrary or capricious."

Bars Intimidation "The act does not interfere with the normal exercise of the right of the employer to select its employees or to discharge them. The employer may not, under cover of that right, intimidate or coerce its employees with respect to their self-organization and representation, and, on the other hand, the board is not entitled to make its authority a pretext for interference with the right of discharge when that right is exercised for other reasons than such intimidation and coercion."

Limits of Law Shown "The chief justice said the Wagner law in its present application 'goes no further than to safeguard the right of employees to self-organization and to select representatives of their own choosing for collective bargaining or other mutual protection without restraint or coercion by their employer. That is a fundamental right.'"
