# DIZZY DEAN UNDER BAN INDEFINITELY

WASHINGTON, June 2.—A wise official high up in the new order picked up his daily paper which told of the German-Communist war in Spain (19 dead that day) and the C. I. O. Steel war in Chicago (4 dead, 30 injured the same day).  
"Behind those two developments," he said, "lies the same trouble, and the whole trouble with the world. No leadership anywhere, where is stressing forebearance, respect for order or law, or respect for the rights of others. This seems to be the day of dog eat dog."  
"The Reds bomb a German battleship and kill twenty-three. The Germans bomb a Red town and kill nineteen. A steel mill disregards the rights of workers to organize. The workers disregard the property rights of the steel mill, trespass and start a fight."  
"Leadership which makes these things is strictly leadership. And incidentally, the two organizers who incited the steel strikers before their march were not listed among the dead or wounded. Hitler and Stalin were far away when the Spanish shooting started."  
"Are leaders going to hurl their forces of hate at each other until they acquire some common sense from sheer exhaustion of war, or are there men big enough in the world to make forebearance and respect fashionable again?"  
This kind of thought has taken hold rapidly in high places here since the first all-down strike.

## CARDS' AGE TALKS OUT OF TURN TOO MUCH, SAYS FRICK

**National Head Orders Suspension for Detrimental Conduct, Good of Baseball**

NEW YORK, June 2.—(AP)—Jerome Herman (Dizzy) Dean was suspended indefinitely today by Ford Frick, president of the National League, for "conduct detrimental to the best interests of baseball."  
Frick said the suspension was meted out not as the result of any specific incident but because of an accumulation of statements and actions by the star right-hander of the St. Louis Cardinals that Frick considered prejudicial to the game as a whole.  
Frick did not see Dean today although the Cardinals were in town for a series with the Brooklyn Dodgers. However, he personally telephoned the pitcher, told him he was under indefinite suspension and instructed him to report to his (Frick's) office at 11 a. m. tomorrow for a conference.  
"Dean has been popping off and talking out of turn too much," Frick said, "so much so that definite and drastic action had to be taken. This applies to his statements and actions, both on and off the playing field."  
"These statements and actions, I consider harmful not only to the National League but to baseball in general. The time has come for a showdown on whether Dean is bigger than the National League. Personally I don't think he is."  
Dean has been the center of a series of disturbances both on and off the field since the spring training season began.

## UPSTATE SWEATS IN SUMMER HEAT

PORTLAND, June 2.—(AP)—June kept up its summery start on the weather front today, although with slightly less enthusiasm, by delivering better-than-80-degree temperatures to most parts of the state.  
The thermometer passed 82 degrees here at noon but was not expected to reach yesterday's seasonal peak of 90.  
The temperatures yesterday generally set hot weather records for the season. Warmest of cities reported was The Dalles with 94 degrees.  
Salem recorded 91 degrees and Grants Pass was a notch under Medford at 89, while Roseburg reported 86.6, and Eugene 87, all seasonal highs. Elsewhere the weather man reported 81 at Baker and 83 at Klamath Falls—each has had a higher reading this year—La Grande 88, Pendleton 90, North Bend 85, Bend 82.

## GAME PROTESTED; SAY 'UMPS' DRUNK

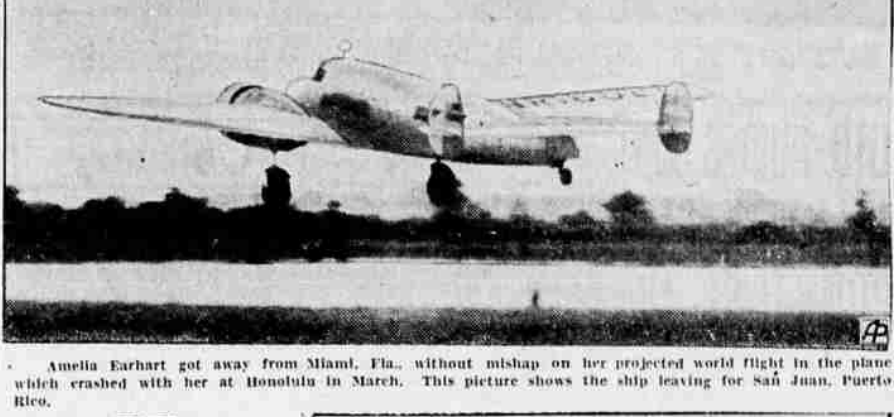

## EX-PUG STEVEDORE HELD FOR DEATH

PORTLAND, June 2.—(AP)—The death of John P. Spalding 46, from a skull fracture led today to the arrest of Thomas McCarthy, 37, former pugilist and a member of the International Longshoremen's association, for investigation by the district attorney.  
Spalding's death occurred after an alleged fight in the I.L.A. hiring hall here. Questioned about it, McCarthy admitted being involved, said Detective John Galt, but asserted he had knocked Spalding to the floor in self-defense after Spalding pounced upon him when McCarthy objected to his remarks about "a friend."

MIAMI, Fla., June 2.—(AP)—Pan American Airways reported that Amelia Earhart landed at Caripito, Venezuela, at 10:18 a. m. (Eastern Standard Time) today after a flight from San Juan, Puerto Rico.  
It was expected that she and her navigator, Capt. Fred J. Noonan, would remain over night in the Standard Oil company's guest house there and take off tomorrow for Paramaribo, Dutch Guiana. From there she probably would proceed to Natal by way of Para, Brazil.  
The aviatix is flying around the world as near the equator as practical, making the 28,000-mile journey for pleasure.

## VAN DEVANTER OF HIGH COURT ENDS 26 YEARS SERVICE

WASHINGTON, June 2.—(AP)—Justice Willis Van Devanter exchanged today his busy 26-year career as a member of the supreme court for that of a gentleman farmer.  
His colleagues in a letter expressed high esteem and warm affection and "a poignant sense of regret" at his voluntary retirement.  
In reply, Van Devanter said he would carry happy memories of the association "together with profound respects and true affection" for each of those remaining.  
The 78-year-old justice attended his final session of the court yesterday, when the tribunal adjourned until next October.  
Van Devanter intends to spend most of his time at his 780-acre Maryland farm.

## ANDERSON GIVEN TRANSFER FOREST SERVICE, CONTROL FOR CALF THEFT U-C LANDS ASKED

WASHINGTON, June 2.—(AP)—The interior department asked congress today to transfer to its jurisdiction the forest service, now an agency of the agriculture department.  
Assistant Solicitor Rufus Poole of the interior department made the proposal in the form of a proposed amendment submitted to the house public lands committee to a bill setting up new administrative machinery for 2,500,000 acres of re-vested western Oregon grant lands.  
L. P. Kneipp of the forest service previously testified the agricultural department could do a much more efficient job of administering the grant lands than the interior department under whose jurisdiction they have been since their return by the Oregon & California railroad and the Coos Bay wagon road companies.  
"For the past 21 years," Poole said, "the jurisdiction of the Oregon & California lands has been in the interior department. The interior department now seeks to improve the management of these lands and the department of agriculture has used the occasion to divert us of our jurisdiction and add to their own."  
He said the interior department, in proposing a new administrative set-up and a revision of the revenue feature of present statutes, affecting the grant lands, speaks with the approval of the administration.  
Poole said the contemplated government reorganization program indicated the interior department would be changed to the department of conservation.  
"To transfer the jurisdiction of the Oregon & California grant lands to the department of agriculture would only add responsibility to that department, which under the recommendation of the president's reorganization plan—it would seem—should be placed in a department of conservation," Poole asserted.  
The departments of agriculture and interior have duplicating functions in many government activities including grazing forestry, mineral development, park and recreational activities and game preservation.

## PINBALL SCANDAL IN SISTER CITY

GRANTS PASS, June 2.—(AP)—City police today conducted a city-wide checkup on pinball machines, investigating possible switching of license numbers if true would divert license money from the city treasury.  
Under the licensing ordinance, permits are granted to individual machines and they may not be placed on other machines or their signatures, descriptions, or other identification altered.  
Auditor C. R. Duser said 34 machines are taxed at \$50 annually.  
Chief of Police Ben F. Graybill, armed with a list of devices and their descriptions, called on business houses checking possible alterations.

## PARSON BRAVES WRATH OF CHURCH TO WED WINDSOR

Volunteers By Telephone to Perform Ceremony—Wallis and Duke Rejoice

MONTS, France, June 2.—(AP)—A fighting north England parson, braving the opposition of the Church of England, will give the Duke of Windsor and Wallis Warfield his religious blessing at his wedding tomorrow.  
The middle-aged, "labor" preacher, the Rev. R. Anderson Jardine, vicar of St. Paul's church, Darlington, Eng., will perform the religious ceremony after the civil service is read in the Chateau de Candé music room by Mayor Charles Mercier of Monts.  
It came about this way:  
Edward was called to the telephone last night, after all hope for the desired religious consecration of his marriage had been given up.  
An unfamiliar voice said firmly: "I am coming down to marry you."  
It was the small town vicar, the Rev. Jardine, known for his work among the laboring class.

The preacher gave his former monarch no opportunity to protest. "I am coming," he insisted.  
"Today he is taxed, to Candé and bowed to the duke."  
"I prefer to die rather than see my king married outside the church," proclaimed the Rev. Jardine.  
Windsor and Mrs. Warfield were said to have been overjoyed. Both were represented as having been extremely disappointed over the impossibility of finding a clergyman to marry them, because the Anglican church frowned upon remarriage by divorced persons and Mrs. Warfield had been twice divorced.

Rogers will give Mrs. Warfield away in the religious ceremony and Maj. Edward Dudley Metcalfe, the duke's equerry, will be best man. Rogers and Major Metcalfe will act as witnesses for the couple at the civil ceremony.

## Spanish-European Crisis in Brief

(By the Associated Press)  
Washington — President Roosevelt invited three of his leading diplomatic advisors to a White House luncheon conference today for a general discussion of the European situation.  
Rome-Italian warships established a virtual blockade of government Spain to halt any soviet supply ships; Premier Mussolini prepared a great naval display for the visiting German war minister—Werner von Blomberg.  
Berlin—British ambassador offered Germany the friendship and support of Great Britain if Europe's peace is maintained. The reich's attitude toward the vatican grew increasingly hostile; rupture of diplomatic relations feared.  
London — Great Britain reported considering joint naval action against Spain to protect neutrality patrol ships and offset Italian blockade. Eden conferred with diplomats seeking to re-form the international non-intervention committee after the Italo-German withdrawal.  
Madrid—Government troops tightened their lines around La Granja, northwest of the capital; reported insurgent garrison running low on ammunition.  
Hendaye — Insurgents reported a Basque attack on besieging insurgents eight miles from Bilbao was repulsed.  
Washington—The Spanish government embassy announced Ambassador Fernando De Los Rios had been recalled to Valencia for consultation regarding the European situation.

## C. I. O. DESCRIBED BY A. F. OF L. CHIEF AS 'ANOTHER FAD'

SEATTLE, June 2.—(AP)—William Hutcherson, president of the United Brotherhood of Carpenters and Joiners, said today that John L. Lewis' committee for industrial organization is another "labor fad which will fade from the picture as soon as the novelty wears off."  
In the Pacific northwest on a tour of inspection, Hutcherson and his associates, R. E. Roberts, Dallas, Tex., and Abe Muir, San Francisco, members of the union's general executive board, conferred with brotherhood leaders from this area.  
"The American Federation of Labor is too big and too well established to be damaged permanently by a movement like this," Hutcherson said.  
"The A. F. of L. has seen the I.W.O. the Knights of Labor and the one big union movement rise and fall, and the A. F. of L. has gone on, outliving them all."  
Hutcherson, a close associate and adviser of William Green, A. F. of L. president, described the C.I.O. as a radical movement.  
"I don't say that all C.I.O. advocates are radicals and communists," he said, "but I do say that all the communists and radicals in the labor movement are C.I.O. advocates."

## SIGN REMOVAL ON HIGHWAYS URGED

SALEM, June 2.—(AP)—Declaring that Oregon highways are the "show windows of the state," the state highway commission sent out letters last night to all service clubs, lodges and churches to assist in eliminating their signs from the highways.  
Highway department officials stated the placing of these signs along the highway was in violation of the state laws. The commission stated it had recently received communications from the state planning board protesting the presence of these signs.

## Rose City Papa Gives 1500 Cigars On Birth of Boy

PORTLAND, June 2.—(AP)—The biggest box of cigars in Portland, containing 1,500 stogies and measuring 12 by 41 by 38 inches, was distributed to his customers today by E. H. Bixby, restaurant owner, honoring the birth of a son.  
On the box, was a sign, "we took one boy, not twins, so take one cigar please. Don't be afraid to smoke it, it will not blow up. We want you to come back able to eat."

## DEATH COMES TO PHONE OPERATOR IN AUTO MISHAP

Miss Sabrina Thatcher, 21, Dies of Anjuries — Was Class Valedictorian.  
Death last night claimed Sabrina Thatcher, 21-year-old telephone operator, who was injured in an automobile accident four miles south of the California inspection station on the Pacific highway early Monday morning.  
She died in Sacred Heart hospital at 8:30 o'clock from extreme shock, the attending physician stated. Miss Thatcher sustained a broken arm, severe cuts and bruises, and a jaw fracture on the left side that extended to the base of the brain, according to the physician.  
It could not be learned definitely today whether an inquest into the accident would be held. According to the coroner's office here, an inquest was in the hands of the Siskiyou county coroner, the accident having happened in California.  
Driver of the car which brought death to the popular Medford girl was Jene Vaughn of Klamath Falls, employe of the southern Pacific railroad bridge and building outfit car, gang 4, according to state police.  
Vaughn, state police said, apparently went to sleep at the wheel of his car, a 1932 Ford coach. In addition to Miss Thatcher and Vaughn, the car contained June Houghton of 716 West Thirteenth street, Medford, and Raymond Fuller, of Klamath Falls.  
The party was returning from a trip into northern California. Following the wreck, the two girls and Fuller were rushed to Community hospital in Ashland, Miss Houghton suffering from minor bruises and Fuller an injured back and a lacerated ear. Miss Houghton and Fuller were released from the hospital Tuesday, and Miss Thatcher was brought to Sacred Heart hospital.

## SENATE ECONOMY BLOC WILL SEEK ONE-THIRD SLASH

WASHINGTON, June 2.—(AP)—The administration's \$1,500,000,000 relief bill, winning midnight house approval after a compromise quashed a persistent revolt, went to the senate today for another major battle.  
Economy advocates in that chamber said they would renew demands to cut the fund by one-third. A house bloc lost a similar attempt before the final 323 to 44 vote by which the bill passed.  
There were prospects, too, some senators would try to renege amendments to earmark one-third of the total for roads, dams and other special projects. These won tentative house approval last week over the objections of administration leaders.  
After week-end conferences, however, the president's lieutenants agreed on modifications, which were accepted last night.  
Majority Leader Rayburn (D, Tex.) had argued tying of the president's hands by the earmarking amendments would force dismissal of more than 630,000 workers from works progress rolls.  
The administration contended the earmarking proposals would take extra money for materials and reduce the amount available for wages.  
House members described the compromise as including:  
1. An administration promise that probably more than the \$45,000,000,000 tentatively earmarked would be spent for flood control.  
2. An agreement to revoke an all-relied-labor order which had held up use of \$131,000,000 now in the public works administration's revolving fund for loans and grants to cities. This would mean completion of a large number of projects for which
