DANCE IN HANGAR TO BE CLIMAX IN AVIATION CARNIVAL

A big public dance in the hangar will top off Medford's aviation carnival at the municipal airport Friday, it was announced today by Max Peirce, president of the local chapter of the National Aeronautic Association, sponsor and head of the Oregon Aviation Development Committee, Inc., in charge of the ten-city air tour.

The 50 or 60 pilots who will participate in the sky show will attend the dance, together with aircraft owners and others who will come to Medford for the carnival, said Chester Hubbard, chairman of the dance committee.

Dancing will begin at 9 o'clock and continue to 2 a. m. Les Price and his eight-piece orchestra will provide the music. Cold drinks will be available at booths and sandwiches may be procured at the airport cafe. During the evening pilots will take passengers up for night flights over the valley, Mr. Hubbard said.

The big hangar floor was being prepared today for the dance. The floor will be scraped, cleaned with gasoline and polished with wax to put it in first-class condition for dancing, Mr. Hubbard said. A small stage will be erected for the orchestra. All planes will be removed and 300 chairs will be placed against the walls, he added.

The public is invited to attend the dance and meet the visiting pilots. Tickets will be on sale at the door.

Prior to the dance the pilots will be entertained at dinner in the Hotel Medford by the Crater Club. Four new members are to be initiated by the club and possibly a few of the pilots will be made honorary members. The dinner will be served at 7 o'clock.

Twenty-five men are needed to sell the tickets at the various entrances to the airport and lodge members who wish to assist were asked to communicate with Mr. Peirce, A. H. Banwell or William Peck. It is expected that the airport will be crowded all day and for convenience it was urged that tickets be procured in advance if possible. The tickets may be obtained from members of the aeronautic association or at the Jackson County Chamber of Commerce.

A great array of planes of all types will be lined up in the morning for public inspection. The sky show, with famed stunt pilots and parachute jumpers participating, will be staged in the afternoon.

The suit was based on an auto accident on the Sams Valley highway, when a car driven by Lindley and the Cota auto were in collision. Mrs. Cota in her complaint alleged she was injured. The accident occurred a year ago.

In a similar action filed by her husband, a circuit court jury returned a verdict in his favor for \$250.

MINE ASSESSMENT WAIVERS PILE UP

Filing of exemptions for assessment work on Jackson county placer and quartz mine claims took a substantial jump at the clerk's office today as the July 1 deadline approached.

The bill waiting for the current fiscal year, the annual \$100 assessment work required on mining claims was signed by President Roosevelt late last week.

For June to the close of business yesterday 130 affidavits showing assessment work completed for the year were filed in the clerk's office. The same period 24 exemptions were filed, most of them within the past few days.

A large stack of affidavits and exemption claims, probably twice as many as for the rest of the month combined, was received this morning, the clerk's office said. They were not immediately sorted and filed but it was indicated that about half of them were exemption claims.
