

DIGNITY OF LORDS RUFFLED BY EARL PUFFING CIGARET

London Press Divides in Treatment of Incident in Parliament—Offender Is Escorted From Room

LONDON, July 9.—(AP)—The London press today partly revived the self-imposed censorship of pre-arranged days in an attempt to uphold the dignity of the house of lords which had been ruffled by the Earl of Moray and his cigarette.

The tall, 46-year-old, war-wounded earl shocked his fellow peers last night by leisurely lighting up and smoking at the steps of the throne used by the king at the opening of parliament. He had just disrupted debate on a bill to broaden grounds for divorce.

The earl was escorted from the chamber. After it was unofficially indicated an ancient statute might be invoked to penalize newspapers publishing an account of the incident, the London press divided in its treatment of the affair.

The Times, Post, Mail and News Chronicle gave a big play to the general debate but passed over mentioning Lord Moray's actions. The Telegraph carried a bare reference to his remarks which it said were "almost inaudible and abruptly concluded."

The Herald put a foot in both camps by printing an account of the disturbance in its second edition and later withdrawing it. The Express and Mirror alone splashed full details under front page headlines.

The upper house was discussing an amendment (later defeated) to strike out insanity as a ground for divorce from the bill under consideration when Lord Moray interrupted Lord Darcy de Knayth and started the chamber with:

Tumult Breaks "This is a serious matter which concerns our lordships' house from an inheritance point of view rather than..."

Tumult broke. There were cries of "Order!"

Lord Darcy resumed but again the earl interrupted:

"This is a serious matter which concerns your lordships' house more than the house of commons, both from an inheritance point of view and from a religious one."

Lord Moray sauntered from the bench where he had spoken, hands in pockets. He paused before the royal throne, leaned against the railing there, fished out a cigarette and matches, and puffed calmly while his fellows gazed in astonishment.

Then Lord Perthung strode forward and escorted the earl from the chamber.

PLAN CLEANUP IN OIL LEASE SALES

PORTLAND, July 9.—(AP)—Oregon will be the next battle ground for the securities and exchange commission, which has cleaned up Idaho in its battle against sale of unregistered oil leases through misrepresentation.

Bruce Aitchison, commission attorney reported the conviction of two defendants in Idaho in a telephone conversation with the Oregonian Wednesday, and said he expected to arrive here in about two weeks.

Federal Judge Charles Cavanaugh imposed a fine of \$500 on the Boise Petroleum corporation and \$300 on C. S. Hessler of Spokane on the commission's complaint that leases totaling about \$100,000 had been sold in Oregon, Washington and Idaho, Aitchison said.

The complaint asserted that the leases were not registered and that the defendants misrepresented in claiming to own a successful gas well, and to have arranged for the city of Portland to buy the output and construct a pipe line from Portland to Beacon Hill, on the Oregon-Idaho boundary.

Ex-Mayor Buried GRANTS PASS, July 9.—(AP)—Funeral services were held today for George J. Fox, 74, former Grants Pass mayor, who died Wednesday following a paralytic stroke suffered Monday.

A resident for 27 years, he served three terms as mayor, from 1927 to 1932.

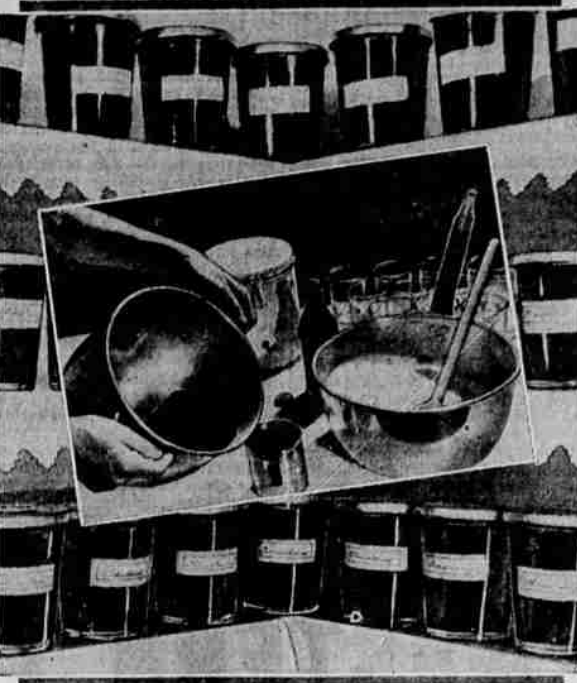

Strawberry Jelly 4 cups (2 lbs.) berry juice 3 tablespoons lemon juice 8 cups (16 lbs.) sugar 1 bottle Certo

To prepare juice, crush thoroughly or grind about 3 quarts fully ripe berries. Place fruit in jelly cloth or bag and squeeze out juice.

Squeeze and strain juice from 1 medium lemon. Measure sugar and fruit juices into large saucepan and mix. Bring to a boil over hottest fire and at once add Certo, stirring constantly. Rhubarb and Strawberry Jam 3 cups (1 1/2 lbs.) prepared fruit 4 1/2 cups (9 lbs.) sugar 1 box powdered fruit pectin

To prepare fruit, trim and slice fine (do not peel) about 1/2 pound small red-stalked rhubarb. Grind about 1 quart fully ripe strawberries, or crush completely one layer at a time so that each berry is reduced to a pulp. Combine fruits.

Measure sugar, into dry dish and set aside until needed. Measure prepared fruit into a 6- to 6-quart kettle, filling up last cup or fraction of cup with water if necessary; place over hottest fire. Add powdered fruit pectin, mix well, and continue stirring until mixture comes to a hard boil. At once pour in sugar, stirring constantly. (To reduce foaming, 1 teaspoon butter may be added.) Continue stirring, bring to a full rolling boil, and boil hard 1 minute. Remove from fire, skim, pour quickly. Paraffin hot jam at once. Makes about 7 glasses (6 fluid ounces each).

64 RUSSIANS EXECUTED FOR RAILROAD WRECKS

INDIAN COMMISSIONER CLAIMS ACCUSATIONS OF CRAWFORD 'FALSE'

WASHINGTON, July 9.—(AP)—Indian Commissioner John Collier branded today as "flatly false" maladministration accusations made against him by Wade Crawford, deposed superintendent of the Klamath, Ore., reservation.

Collier told the senate Indian affairs committee it was inconceivable to him that a former superintendent should be putting into the record alleged evidence which is untrue.

Crawford, dismissed on the grounds of failure to handle personal affairs of Indian health, property and money and of utter neglect and indifference to social and moral progress of the Klamath Indians.

Collier said the bureau's interest always had been with the Indians and the every effort had been made to protect them from discrimination or exploitation by white lumbermen operating on the reservation.

HEADS OF BUREAUS PROMISE ECONOMY

WASHINGTON, July 9.—(AP)—Heads of 28 independent federal agencies promised President Roosevelt at a White House conference today to do all they could to save 10 per cent of their current fiscal year appropriations.

The president had asked all departments and agencies to make the 10 per cent slash effort in the hope that \$400,000,000 could be saved and the budget balanced by the end of the fiscal year, June 30, 1938.

Those attending today's conference represented agencies getting appropriations direct from congress. Representatives of the works progress and public works administrations, which obtain their funds through presidential allotments, sat in as observers, as did Secretary Morgenthau and Daniel W. Bell, acting budget director.
