BLAME SABOTAGE FOR SHIP BLAZE
BALTIMORE, Md., July 31.—(AP)—Capt. Charles O. Brooks, master of the ill-fated City of Baltimore, reiterated to a federal inquiry board today his belief the disastrous fire which destroyed the liner and cost two lives was started deliberately.
Captain Brooks blamed sabotage, he said, because he could not otherwise understand how the fire spread so rapidly.
Prior to the start of the hearing, A. L. Stephens, president of the Chesapeake line, owners of the gutted ship, asserted he was convinced three men perished in the fire which gutted the steamer City of Baltimore in the Chesapeake bay Thursday night.
Stephens said he is convinced Cy Haynie, an oiler listed as missing died in the fire.

LAKE CO. WETHERS BRING 80 POUND
SILVER LAKE, Ore., July 31.—(AP)—Eight cents a pound for wether lambs was paid by Carl Holland, Columbus, Ohio, who contracted Thursday the wether end of several bands, the first of this season's crop sold in this vicinity.
Well out in front in the annual scramble to contract Lake county's lamb crop, of approximately 75,000 head, Holland represents the eastern buying company.
The lambs were contracted for delivery in September, when they will be shipped to Ohio for winter feeders. Local owners are holding the ewe lambs in expectation of a better price.

Hoist Amateur 'Dick' On His Own Petard
PORTLAND, July 31.—(AP)—Police told today of an amateur detective who enabled them to "get their man" but landed behind the bars as the result of his own investigation.
Detectives John Glos and John Abbott said Ole A. Blomlie, 55, read a "wanted" notice in a detective magazine and thought he knew where to locate the fugitive. He wrote eastern authorities claiming the \$100 reward, and they notified Portland police.
The detectives said they investigated the "suspect" and then investigated Blomlie, finding he was wanted in Seattle on a forgery charge.
The man they arrested was not the "suspect."

MILNE LOW BIDDER ON SANTIAM HIGHWAY JOB
PORTLAND, July 31.—(AP)—Nine bidders filed today estimates on construction of 8.4 miles crushed rock surfacing on the North Santiam highway, from Marion creek south, in Linn county, with A. Milne of Portland submitting the lowest at \$63,831.80. W. H. Lynch, district engineer of the federal bureau of public roads announced.
The bids will be sent to the national capital for approval before the contracts will be let.

Old Ashland Depot Site Of Colorful Gatherings
ASHLAND (Sp)—The forthcoming tearing down of the old Southern Pacific station to be replaced by a new modern structure recalls the colorful history of this building and early railroad history in this area.
Saturday, December 17, 1887, saw the golden spike drive which signified the union of the two roads, the one from the north and the one from the south, which had been in building for many years.
The road from the north was completed to Ashland on May 4, 1884, the southern line meeting it in Ashland in 1887, the occasion bringing special trains from both Portland and San Francisco, filled with railroad officials and notables for the ceremonies held on the Saturday and in front of the station in Ashland. It was an elaborate celebration, the citizens of Ashland playing a prominent part.
Could the walls of the Ashland station speak they could tell stories as exciting as any in the realms of fiction.
Great gatherings were entertained, train loads of notables of theatrical and operatic companies, and delegates to great conventions were there on occasion.
Furnishings of the depot were lavish, a replica of those of the Palace hotel in San Francisco. The most comfortable beds between Port-

land and San Francisco, so much silver that some of it was never opened until years after the establishment came into being.
The parlor furniture was of Cuban mahogany. Everything was so substantial that little or no repairs were necessary.
First to operate the hotel was a Mr. Clawson, the second Mr. Parker, the third Mr. Gross. In August, 1901, Mr. and Mrs. H. A. Pracht, became the owners and were in charge until 1905, when they sold to J. P. Wolf.
During their regime the dining room would accommodate 200 at a time, and the delegates to the first C. E. convention held on the coast were taken care of by the Frachts. In June, 1905, they entertained the National Editorial association.
A story in Good Housekeeping tells of the entertainment Ashland afforded the delegates to a great women's convention in Los Angeles, stating that it far exceeded that of the convention city. This was when Mr. Pracht was the operator.
During this time there were no greenhouses, but friends supplied that need on occasion, and roses were brought by the clothes basket full for dining room decoration.
When trains were delayed the company fed them at their own expense, sometimes for days at a time.
