

### ACCUSATIONS IRK WISCONSIN NAZIS; ASK F.R. TO PROBE

#### German-American Hall Picketed During Rally of Volksbund—Swastika and Black Shirts Displayed

KENOSHA, Wis., Aug. 10.—(AP)—Copies of a resolution calling for a sweeping investigation of alleged charges hurled against the German-American Volksbund, an organization of German-Americans, were forwarded to President Roosevelt and Wisconsin legislators today.

George Frobose of Milwaukee, president of the Midwest German-American bund, said the resolution was adopted unanimously at a statewide rally here yesterday. More than 100 persons, many of them carrying signs indicating their anti-Nazi sympathies, picketed the German-American hall where the meeting was held after the city council last week revoked a permit to hold the rally in Washington Park bowl.

To Mail Copies  
Frobose said copies of the resolution, asking an investigation to "set at rest the malicious propaganda against our organization," will also be sent to Governor La Follette, U. S. Senators Robert M. La Follette, Jr., and F. Ryan Duffy, as well as Wisconsin members of the house of representatives.

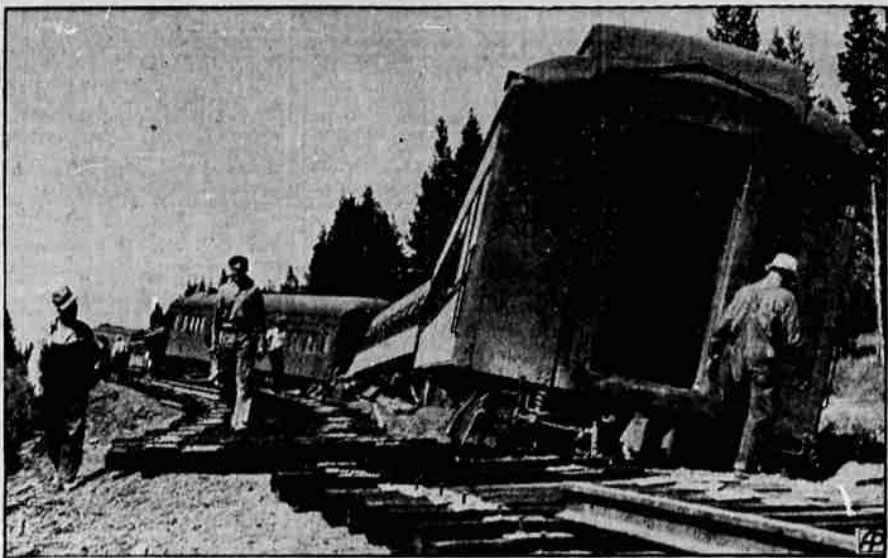
One of the most serious charges hurled against the organization, Frobose said, was that it had been financed by the German government. "If these accusations are examples of American democracy," Frobose declared, "then I don't want to be either a Democrat or an American."

The bund leader said the rally was attended by approximately 750 persons from Wisconsin, Illinois and Indiana.

Many of the members wore brown and black shirts with the Nazi swastika sleeve insignia, black riding breeches and black boots.

They stood talking in groups outside the club house when the pickets, led by Delton C. Johnson, head of the communist party branch in Kenosha, arrived. Then Frobose an-

noticed as the crowd moved inside:

"We anticipate no violence as long as you communists stay on the sidewalk. But if you attempt to come up to the door, it will be just too bad."

The pickets' signs bore such inscriptions as:

"Which—allegiance to Hitler or democracy?"

"Hit gory agents of Hitler shall not pass."

"Nazi murderers, sadists and arsonists forfeit the rights of free speech."

"The oath of allegiance to Hitler is an act of treachery to the American people."

Frobose, in addressing the rally, said:

"Our work will continue. Nobody is going to stop us. If they will stop the boycott against German goods, and stop the anti-German propaganda we'll talk peace terms. If not, we'll fight them to the last ounce of blood in our veins."

### WHEAT CROP SEEN NORMAL IN COUNTY

The wheat yield in Jackson county will be normal, running on an average of 23 bushels to the acre, with a yield of 80 bushels to the acre reported on the Walter Brant farm in Sams valley. Following an unusually severe winter and wet spring, it was feared the grain crop would be lessened, according to County Agent Robert G. Fowler.

The oat crop will run 50 to 80 bushels to the acre and the barley crop 30 to 35 bushels to the acre, it is estimated.

Threshing of all grain crops is now under way in all sections of Rogue River valley. The acreage is about the same as last year.

The corn crop, according to the county agent, is now in 100 percent condition with an above normal crop, and the largest corn acreage in years. The corn is now in the "tassel," and some prodigious growths have been reported.

### NEHEMIAH'S EFFORT CITED BY PASTOR IN NAZARENE DISCOURSE

Speaking Sunday morning at the Church of the Nazarene, Fred M. Weatherford, pastor-evangelist, drew his sermon from the second chapter of Nehemiah. He took as his topic "Hands that were strengthened in a good work." He emphasized the 18th verse of the chapter cited—"And they said, let us rise up and build. So they strengthened their hands for this good work."

The pastor said: "Nehemiah was one of the captives born in Babylon. He rose to hold the responsible position of trust as cup-bearer to the king. Before the king one day he bore a sad countenance, occasioned by the great burden he bore for his people and the rebuilding of the wall at Jerusalem. He said 'My city, the city of my Father, lieth waste and we are a reproach, and this is the sorrow that breaks my heart.'"

"Two things Nehemiah had prayed for—first, 'If it please the king . . . send me . . . that I may build.' His second prayer was that he might have access to the supplies with which to rebuild the wall.

"Nehemiah succeeded under great difficulty through opposition, in the rebuilding of the wall, because they strengthened their hands and had faith for the accomplishment of this work.

"What Jerusalem was to Nehemiah, the House of God is to us. Infidels may scoff at the church and enemies rise up to dismantle the Word of God, but you stand ready today to make your sacrifices for the church than for any other institution, and at the same time give your all in defense of the Holy Bible."
