His action followed a decision by Circuit Judge L. G. Jewelling disallowing a temporary injunction restraining the district attorney from prosecuting the operators.

The judge denied a petition brought by Hugh Hammerly, Albany pinball owner, for a change in judges. Judge Jewelling said the case could not be transferred after it had started.

Judge Jewelling, however, disqualified himself from further participation by asking the supreme court to name a judge to hear a petition for a permanent injunction if machine owners resist the closing.

G. Pass Poacher Convicts Himself. GRANTS PASS, Aug. 11.—(AP)—When Paul Erwin Bruner of New Hope shot a deer in the Marvin Webster corn patch near Murphy Sunday night, he left his calling card. State police testified in justice court today.

Bruner admitted a receipt for gas and oil found near the entrance of a deer was his, pleaded guilty to game law violation, paid \$25 fine, and was released under suspended sentence of 30 days in county jail.

IDAHO ROAD SCANDAL SLATED FOR AIRINGS BEFORE GRAND JURY. BOISE, Idaho, Aug. 11.—(AP)—Idaho Attorney-General J. W. Taylor announced today he would ask a grand jury—perhaps several—to consider transactions and conditions in the state highway bureau.

"The audit, for which the last legislature provided \$25,000, has brought to light so many matters in addition to those already known by this office that the interests in the state demand such an inquiry," Taylor explained.

Under Idaho law, the attorney-general must make his recommendations to one of the two district judges for Ada county, Charles F. Koelsch or C. E. Winstead. They may grant or deny the request. Taylor said he would make his recommendations "shortly."

"Of one thing I am certain," said Taylor: "The state of Idaho has paid out enormous sums of money for services and material that have not been delivered, and the taxpayers are entitled to know whether this was accomplished through criminal dishonesty or militant stupidity."
