# MEDFORD WOMAN KILLED IN SMASHUP

## FLORENCE MORGAN DIES INSTANTLY AS AUTO OVERTURNS

Mrs. Pearl Johnson Seriously Injured in Accident 25 Miles North of City—In Grants Pass Hospital

Mrs. Florence Morgan, 25, of 1211 West Tenth street, was instantly killed yesterday afternoon when the car in which she was a passenger upset and rolled over two and a half times on the Pacific highway about 25 miles north of Medford.

Seriously injured in the Josephine General hospital at Grants Pass and not expected to live are Mrs. Pearl Harriet Johnson, 24, of 1208 West Tenth street and Jack Thomas Woolfolk, 26, of 721 Alder street.

Mrs. Morgan met death when the 1931 Ford phaeton sedan, driven by Woolfolk, left the pavement and traveled for more than 300 feet on the road shoulder, then swerved back on the highway, over turned and rolled 37 feet. The car, demolished, came to a rest upside down. According to state police who talked with eye witnesses, Mrs. Morgan was thrown clear of the catapulting auto, then picked up in some manner. When the car halted, she was lying on the exhaust pipe. The accident occurred about 4 p. m. on only a slight curve in the road.

County Coroner Frank Perl, who removed her body to the Perl funeral home, stated the actual cause of death was a severe skull fracture.

Mrs. Pearl Johnson, wife of Earl Johnson who drives a fruit produce truck between Medford and Sacramento, lies near death with a fractured skull, lacerations of the left arm and a crushed right shoulder. She was unconscious in the car following the wreck.

## Press Photographers Risk Lives In China

 SHANGHAI, Aug. 25.—(AP)—A steel-helmeted Associated Press "foreign legion" is fighting the Shanghai war with speed cameras and flash bulbs instead of guns and grenades. Day and night a corps of Associated Press photographers of a half dozen nationalities is under fire in Chinese and Japanese lines and in flame and shell-scarred Shanghai. The "foreign legion" includes American, British, Russian, Chinese, Japanese and Turkish camera men.

On two occasions they were bullet-proof vests and crawled into skirmish zones.

The field staff sends hundreds of plates daily to the Shanghai bureau office. The developing and printing staff works under high tension to speed pictures to America by every possible means.

Japanese troops virtually banned foreign photographers from the front line positions, but a Japanese expedition who came with me from Tokyo works alongside those from Tokyo newspapers. Behind Chinese

## CHANGE IN COURT REMAINS AS GOAL SAYS ROOSEVELT

Statement Comes With Announcement of Signing of Measure Providing for Changes in Lower Court

WASHINGTON, Aug. 25.—(AP)—President Roosevelt served notice today that some reorganization of the supreme court remains an objective of his administration.

He made his first public statement on the court situation since Congress shelved his demand to enlarge the high tribunal by one member for each present justice over 70 who did not retire.

The statement came with a White House announcement that Mr. Roosevelt had signed a measure providing for changes in judicial procedure in the lower courts. Out of the long and bitter fight over the court bill these proposals alone were retained and enacted.

Further Action Needed

The president said that the lower court bill "registers a moderate and limited advance into a field which calls for further and more complete exploration."

He listed as being "on the side of omission" the fact that the bill "leaves entirely untouched any method of relieving the burden now imposed on the supreme court."

This he then included as one of the objectives which he said "are of a necessity a part of any complete and rounded plan for the reform of judicial processes."

## TEAMSTERS UNION SUED BY BREWERS ON BOYCOTT CLAIM

Suit for \$165,000 alleged damages against the International Brotherhood of Teamsters Union, Medford Local No. 57 of the teamsters and 15 "Dons," designated in the complaint as "First Doo," and so on up to 15, was filed today by eleven California and Mid-West breweries in circuit court here.

A preliminary restraining order and a permanent injunction is also sought by the plaintiff brewers to prohibit the teamsters union from engaging in an asserted "primary or secondary boycotting" of the plaintiffs' products in Jackson and Josephine counties, the territory embraced by the Medford local No. 57 of the teamsters' union.

The complaint also seeks prohibition of picketing, acts of violence, or boycotting of plaintiff breweries' beer, or distributors thereof.

The complaint points out the breweries have no quarrel with union labor but legal action is due to a jurisdictional dispute between the brewers unions and the teamsters union.

Breweries listed as plaintiffs are the Acme, Rainier, Golden West, and General Breweries, California corporations, and Schlitz, West Hamm Brewery, Miller Brewing com-

## HIDDEN MINES AND MACHINE GUN FIRE RIDDLE JAPANESE

Foreign Residents in Heart of Shanghai Surrounded by Devastation—Two Jap Warships Sunk, Is Claim

 SHANGHAI, Aug. 25.—(AP)—The lives of hundreds of Japanese soldiers were sacrificed today in a mass effort to land desperately needed reinforcements and wipe out the Chinese armies of Shanghai.

The city's wily defenders took heavy toll of Japanese landing parties thwarting a Japanese plan to land 55,000 troops near Woosung and storm Shanghai's defenses from the rear.

Woosung is at the confluence of the Whangpoo and Yangtze, down river 12 miles from the heart of Shanghai.

Hanks Riddled

An estimated 42,000 Japanese still were on their ships and the ranks of some that reached shore were riddled.

The Chinese allowed the new Japanese troops to rush what seemed to be second defense lines, then exploded hidden mines and virtually wiped out the invaders with sheets of fire from secret machine-gun nests.

Both sides admitted that casualties in the Woosung sector, where the battlefront abruptly shifted, were extremely heavy.

## PINBALL ARREST INVITED TO TEST LEGALITY OF BAN

The district attorney and sheriff of Jackson county, in a letter today from legal representatives of pinball machine interests, were invited to make an arrest tomorrow to test the legality of the Oregon anti-lottery law.

The letter served notice that Murray Bell would have a pinball machine for play in his place of business in this city tomorrow, irrespective of the deadline set by you.

Pinball machines, under an order issued by the sheriff, must be removed after midnight tonight, and players, proprietors and distributors are subject to arrest tomorrow. The ban also applies to punchboards in Jackson county.

Sheriff Syd I. Brown said: "There is no need of writing a letter about it. If anybody is caught violating that law they will be arrested, with or without an invitation."

The letter, signed by Attorneys George A. Roberts and William L. McAllister stressed "This letter is not written in any spirit of defiance or disrespect of your authority, but merely for the purpose of obtaining an early determination as to whether or not this game which has been sanctioned by the legislature, and licensed by the city of Medford is unlawful..."

## TWO ARE FINED ON FIRE CHARGE

J. E. Roberts and Clifford Crump were each fined \$20 and \$4.50 costs by Judge L. A. Roberts in Ashland justice of the peace court yesterday afternoon.

They pleaded guilty to permitting a fire to spread in forest land. Complainant was Clarence Williams, a state fire warden of the Klamath Falls district.

Employed by the M. L. Fox Logging company at Pinehurst, Roberts and Crump set a fire Monday to burn out a nest of yellow jackets which had bothered them in their logging work, Rogue River national forest headquarters here said. The men thought the fire was out but as an extra precaution covered it with dirt before quitting work, headquarters explained.

The fire flared up, however, and spread over half an acre of timber land, requiring an all-night fight by loggers and personnel and equipment of the Rogue River national forest.

HOLBROOK, Ariz., Aug. 25.—(AP)—Thirteen-year old Wayne McClure, of Grants Pass, Ore., who consulted a ouija board to determine his destination, was located today by Sheriff Lefe S. Hatch at Painted Desert lion farm, 25 miles from here.

The youth's parents, Mr. and Mrs. L. E. McClure, with Sheriff Hatch, had been directing a frantic search by 30 men since Monday.

Hatch quoted the youth as saying he "wandered away from his parents' small car purposely so that he might return to the lion farm which he had visited previously, and secure a job feeding the animals."

"He told me," the sheriff said, "he had consulted a ouija board twice while visiting his grandmother in Santa Fe, N. M., recently and it told him both times he should go to the Painted Desert lion farm and settle down."
