PORTLAND, Ore., Sept. 3.—(AP)—The AFL-CIO blockade in the major sawmills here forced a partial shutdown of two plants today. Confronted by sawdust and block wood accumulated from sawing operations, the Jones Lumber company and the Clark & Wilson mills stopped cutting logs, although other departments, including planing machines, continued to operate. Workmen began stoking burners to capacity in hope of clearing enough sawdust and block wood by Tuesday to permit resumption of sawing. The day dawned with AFL pickets before the big mills, where CIO workers have been producing lumber in defiance of the AFL, which seeks full control of the lumber employes.
