APPLE HARVEST GETS UNDER WAY

PORTLAND, Sept. 15.—(AP)—The Jonathan apple harvest is underway in many producing districts this week with growers receiving offers of about \$1.25 or better for fancy grades, a market survey showed today.

Sizes are running small and producers have encountered difficulty in obtaining grades for eastern shipment.

The September report estimated the Oregon crop at 3,740,000 boxes, 510,000 boxes less than a year ago.

Pear movements passed the peak and probably will show a decline each week. Oregon and Washington forwarded 862 cars last week compared with 684 the previous week.

CCC BOY DIES AFTER APPENDIX RUPTURES

Willie C. Moore, 17, son of Hiram Moore of Lily, Kentucky, died this morning at a local hospital following an operation last week.

Moore was a CCC member from Camp Klamath and had suffered a ruptured appendix following a sudden attack of appendicitis at his camp. He was brought to Medford where an emergency operation was performed, but peritonitis followed.

His body was taken to the Conger mortuary and will be shipped to his home in Kentucky for interment.

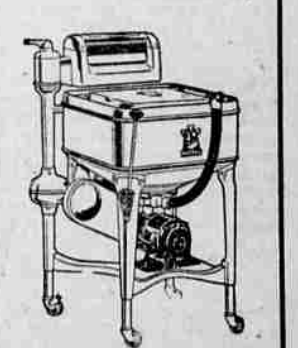
