**REICH TAKES OVER OLD HAMBURG BANKING HOUSE**  
**JEWISH FINANCIER OUSTED BY NAZIS**  
**WAS HERO OF 1919 PEACE NEGOTIATION**  
**DEMAND VAST RANSOM FOR ROTHSCHILD**

WASHINGTON, June 9.—(AP)—The partners of M. M. Warburg & Company, of Hamburg, have resigned. The 150-year-old banking house has been taken over by the German state.

The news sounds much like other news from the reich, in those last years. To be sure, Max Warburg and his brother, Fritz, are old men 72 and close on 70. To be sure, their firm has always played a large and notable part in the commercial life of Germany. To be sure, the Nazi leaders have not been ashamed to use Max Warburg's wisdom, to guide them through the monetary mazes of sick European finance.

But they are Jews, Max and his brother, Fritz. It had been coming for a long time. Once before, a year or so ago, their resignation had been tentatively demanded. Always there were inquisitions, espionage. Frau Warburg was brought close to the cracking point by the terror of the days and nights. And Max stayed, against the urgings of his friends, only because, he said: "If I go, what will my people think who are poor and must remain? And what will I do, a German, out of Germany?"

Yet when the storm-troopers came, or the telephone from Berlin brought the resignation order, Max Warburg's mind must have flown sadly back over the years, to the spring of 1919. At Versailles, that spring of 1919, the crowd pressed hungrily around the Hotel Des Reservoirs. Guards marched to and fro along a makeshift iron fence, across the pavement, sun-flecked through the trees. The crowd murmured, as children will at 80s, when a strange new animal elings to the darkness at its cage's rear.

Within the hotel, among the rad-died grandeur of the tall rooms, the German delegates to the Versailles peace conference argued interminably. They might have been expected to disagree. Count Von Brockdorf-Rantzau, the foreign minister, a man of the old regime; Edward David, the socialist leader; the professional diplomat, Dr. Adolf Mueller; Herr Geis-

## MAN IN CUSTODY LEADS OFFICERS TO HIDING PLACE

Ransom Money Also Located—Former Tenant of Cash Apartment Admits Writing of Ransom Notes

WASHINGTON, June 9.—(AP)—Attorney General Cummings said today that Director J. Edgar Hoover and his associates in the federal bureau of investigation performed "a brilliant piece of work" in the Cash kidnaping case. He wired congratulations to Hoover at Miami, Fla.

MIAMI, Fla., June 9.—(AP)—The body of kidnaped James Bailey Cash, Jr., was found today and G-Men announced the recovery of the \$10,000 ransom and the arrest of a suspect, but indicated the case still was not completely solved.

"We have the kidnaper or one of the kidnappers," said J. Edgar Hoover, director of the federal bureau of investigation, in discussing the arrest of Franklin Pierce McCall, husky 21-year-old truck driver who he said admitted writing the three ransom notes and collecting the money.

Hoover declined to say whether authorities were seeking possible confederates. He also turned aside questions as to whether any others were in custody.

To Continue Chase  
"The investigation will actively continue," Hoover announced, adding that the FBI field office in Princeton, however, would be closed.

Hoover said Dr. Thomas Otto, who accompanied federal agents when they located the five-year-old victim's body three minutes after midnight this morning less than a mile from his home, believed he had been dead when left there.

It was understood that while most of the ransom money was recovered, a few of the 1500 bills of small denomination were missing.

### SOUTHERN SOLONS FORCE REOPENING OF WAGE DEBATE

WASHINGTON, June 9.—(AP)—A threat of southerners to fight a previously approved compromise forced a joint congressional committee to reopen today discussion of the pay provisions of the wage-hour bill.

Armed with an ultimatum supported by 18 southern senators in a caucus this morning, Senators Ellender (D-La.) and Pepper (D-Fla.), southerners on the conference committee, told the conferees they must have wage differentials or they would make an active floor fight on the legislation.

The southerners proposed a new compromise, by which a minimum wage of 40 cents an hour would become effective for all interstate industry at the end of seven years, but with exceptions which would permit differentials on a sectional basis.

The conference committee previously had agreed, with 12 of the 14 conferees concurring, to a compromise which would excuse only those industries which could prove at the end of the seven-year period that a 40-cent minimum would cause unemployment.

The southerners insisted, however, that such factors as lower living costs and freight rates, which they said were discriminatory against the south, should be considered in granting exemptions.

### Congressmen Tie In Small Return At Milking Test

WASHINGTON, June 9.—(AP)—The first congressional cow-milking contest between representatives from the middle west and the far west ended in a draw today.

Staged on the Mall between the capitol and the Washington monument, Representatives Knutson (R-Minn.) and Bollesau (Prog.-Wis.) crossed grips with Representatives Sheppard (D-Cal.) and Price (D-Ore.).

After the congressmen had struggled for 15 minutes with very little to show for their efforts, Representative Marvin Jones, chairman of the house agriculture committee and referee of the contest, declared the event a draw.

WASHINGTON, June 9.—(AP)—Administration efforts to rid congress of unfriendly Democrats—no matter what the outcome at the polls—may unite the anti-Roosevelt forces in the 1939 session even more closely.

Many of the senate foes of the court bill and other presidential measures do not come up for reelection this year. They will serve as the nucleus of the anti-administration group in the new congress.

These men already have demonstrated on two occasions that they would aid Democratic colleagues who face administration opposition in their re-nomination campaigns.

Leaders of the group, such as Senators Wheeler (D-Mont) and Burke (D-Neb.), rallied quickly to the aid of Senator Gillette (D-Iowa) when WPA Administrator Hopkins endorsed his principal opponent.

A few weeks earlier they had pledged campaign assistance to Senator Van Nuys (D-Tex.), another court bill foe, who will run as an independent because Indiana Democratic chieftains decided to deny him a place on their ticket.

### BALTIMORE SELECTED FOR NEXT CONVENTION SHRINE ORGANIZATION

LOS ANGELES, June 9.—(AP)—With Galloway Calhoun of Karem temple, Waco, Texas, named as imperial outer guard and Baltimore selected as next year's convention city, the imperial council of the ancient Arabic order, Nobles of the Mystic Shrine, went into the final sessions of its 84th annual meeting here today.

Installation of the newly elected imperial grand, with Andrew A. D. Rahn of Zuhrah temple, Minneapolis, as imperial potentate, featured today's ceremonies of the imperial council.

Calhoun was named to the post which in 11 years will lead to imperial potentate when he received 385 of the 600 votes cast. John H. Zink of Boumit temple, Baltimore, received 111 votes and Stephen S. Jones of Korzar temple, Louisville, Ky., 103.

Baltimore's selection as next year's convention city became assured when Atlantic City and San Francisco dropped from the contest.

Three days of pageantry and fun which attended the more serious business meetings of the imperial council will reach their climax tonight in the motion picture electrical pageant in the Coliseum.

### SEATTLE BAKERS STAGE WALKOUT

SEATTLE, June 9.—(AP)—Husbands began to suggest to wives: "I don't see why you can't bake bread, mother did" today after all major bakeries were closed at midnight last night by a bakers' union strike.

Final deliveries of bread and the extra supplies baked yesterday were being made but by tomorrow or Saturday all will be used up, bakers said.

Ed Hagen, secretary of Bakers' Union local 9, said 45 bakeries which make 95 per cent of the city's bread supplies were shut down. Many one-man shops will continue to operate but they will be unable to meet the city's demand of about 200,000 loaves a day.

Most bakers at nearby Everett and Bremerton also walked out.

### WALKOUT STAGED AS CITY JAMMED FOR ROSE FIESTA

PORTLAND, June 9.—(AP)—Marching pickets and bewildered, stair-climbing guests today marked a strike which drew 1250 to 2000 hotel employees from their work in eight of the city's largest hotels yesterday.

Elevator operators, bellhops, switchboard girls, dining room and kitchen employees, clerks, chambermaids and porters—all joined the exodus ordered by the unions involved to force recognition from employers.

However, certain groups in at least several hotels refused to accept the unions' edict, and the Multnomah, one of the largest, claimed 75 employees stayed on the job.

All Hotels Open  
No hotels were closed and all attempted to keep up a semblance of service, with managers handling registration desks, carrying baggage and preparing rooms.

A union statement declared a strike deadline had been ignored by operators who, the unions said, had been "unfair" in refusing to live up to their agreement to arbitrate and in asking the unions to hold an election to prove their right to exist as functioning organizations for collective bargaining.

### U. S. ENVOY ASKS JAPS TO CEASE BOMBING OF AMERICANS' PROPERTY

WASHINGTON, June 9.—(AP)—Ambassador Joseph Grew at Tokyo asked the Japanese government today to take urgent measures to stop bombing of non-combatant property in China.

The state department said Grew was instructed to apprise the Japanese foreign office of an attack of Japanese planes upon the Linpan university campus yesterday.

Grew, the announcement said, told the Japanese that three bombs were dropped on the edge of the school's athletic field 200 yards from the residences of Americans at the university.

There were 37 Americans at the university at the time.

PORTLAND, Ore., June 9.—(AP)—Veterans and youthful stars were about evenly divided today in the championship flights of the Oregon state amateur golf tournament.

Moe beat Andy Vetch, 5 and 4, and James Bushong, La Grande, 3 and 1, yesterday, while Dr. Willing disposed of Ray Isaacs, 3 and 2, and Bob Jensen, 2 up.

### Recent Hot Days Brake On Blight

Recent warm weather has held back orchard blight and there is considerable less of the tree disease than last year, according to Fletcher Fish, federal fruit inspector. Fish estimates the crop as slightly larger than last year, when the total was 2,250 cars.

Grain crops in the valley need rain, according to County Agent Robert G. Fowler. There is plenty of water underground, due to the rain excess of last winter, but the surface is dry. Spring grain was sown late, due to a late season and would benefit, along with fall grain and gardens, from a shower.

### NILE DAUGHTERS AIDES APPOINTED

TACOMA, Wash., June 9.—(AP)—Mrs. Harry Micklethwait of Tacoma, supreme queen-elect of the Daughters of the Nile today named national appointive officers to serve with her for the next 12 months.

Emma Love, Tacoma, was appointed princess marshal.

### STATE TO RECEIVE FEDERAL ROAD AID

SALEM, June 9.—(AP)—The federal government will spend about \$3,350,000 on Oregon roads in fiscal year 1940 and \$4,145,000 in 1941, the state highway department said today.

The state highway department will spend \$2,169,000 in federal money in 1940, compared with \$3,191,336 each in 1938 and 1939.

The government has spent \$44,000,000 on Oregon roads in the past 21 years.

The 1940 federal road bill provides expenditure of \$168,500,000, while \$191,000,000 will be spent in 1941. The 1938 and 1939 bills appropriated about \$238,000,000.

Fiscal year 1940 begins July 1, 1939.
