

F. D. R. TO CARRY POLITICAL TORCH ON COAST JAUNT

Remarks Indicate President On Verge Striking Bold New Course—May Make Direct Aid to Backers

WASHINGTON, July 5. — (AP)— President Roosevelt starts out Thursday on a journey to San Francisco which may become the most spectacular bit of political torch-bearing he ever has done.

Such evidence of his intentions as can be gleaned from his own remarks indicates he is on the verge of striking a bold new course in politics—of venturing personally into realms which he previously left to his lieutenants.

The new course was outlined in his recent radio speech to the nation. Its purpose will be to keep in congress those the president conceives to be "liberals" and to replace with new men so far as possible those he conceives to be "conservative."

Not From President Administration help for the "liberals" and opposition to the "conservatives" is not new. In the Florida Democratic primary this spring, Senator Pepper had frank administration support. But it came from James Roosevelt, the president's son and secretary, not openly from the president himself.

Other candidates have had the aid of such White House lieutenants as Secretary Ickes and WPA administrator Hopkins.

The president has put in good words personally only for senate leader Barkley of Kentucky and of Senators Duffy of Wisconsin, and McAdoo of California. Now it appears he may give up indirectness in many cases.

In his "fireside speech" he said he felt he had "every right to speak in those few instances where there may be a clear line between candidates for a Democratic nomination involving" platform principles of "involving a clear misuse of my name."

To Decide Friends Which Democratic primaries constitute such instances will be a matter for the president and his advisers to decide. Among the latter there is at present little evidence of agreement.

Reports are that the group of which Thomas G. Corcoran is the sparkplug wants to force out of their seats—or at least attempt it—all those senators and representatives who opposed the administration in any material way.

The practical politicians, such as Postmaster General Paey, and a few naturally cautious people, on the other hand, are advising the president to lay-off all except such outstanding administration critics as Senators Smith of South Carolina, George of Georgia and Tydings of Maryland.

The forthcoming trip to the west coast will indicate how far Mr. Roosevelt intends to go in his personal intervention in the primaries.

To Aid Barkley He will make three speeches in Kentucky, in all of which he is expected to voice clearly his support of Senator Barkley, who is opposed by Gov. A. B. Chandler.

The president will give a pat on the back to Senator Elmer Thomas (D., Okla.), seeking renomination against Gov. E. W. Marland and Representative Gomer Smith. He probably will express support also of Senator William G. McAdoo (D., Calif.).

Whether he will have anything to say for or against Senator Alva Adams (D., Colo.) during a stop at Pueblo July 13 has not been disclosed. Adams, opposed by Judge Benjamin Hilliard, has supported some administration measures and criticized others.

SAWMILL CLOSED FOR UNION NEGOTIATION

TOLEDO, July 5.—(AP)—The big C. D. Johnson Lumber company remained closed today while it negotiated a wage cut proposal with the Industrial Employees union.

The Siletz river camp and a number of small "typo" outfits in the Siletz forest will be closed.

The company recently offered a 15 percent cut as the alternative to partial employment. Spokesmen for nearly 500 workers first declined the reduction and then agreed to negotiate.

CLIMBER IS RESCUED FROM HOOD CREVASSE

PORTLAND, July 5.—(AP)—William Campbell, 20-year old Seattle mountain climber, was rescued from a 20-foot crevasse about 2000 feet from the summit of Mount Hood Sunday morning after he had laid in the frigid trap some 20 hours.

Campbell attempted to climb the mountain alone on skis. He was sighted near the summit by a party of forest service men who directed searchers to the vicinity when it became known the man was lost.

DYNAMITE FIRECRACKER PUTS MAN IN HOSPITAL

HEIRESS RELATES DEATH THREATS IN DIVORCE HEARING

There also was mention of a letter belonging to the countess which the count had taken and which "grieved him very much." Mitchell added that the count had studied grounds for divorce in Danish law.

At another point Mitchell accused the count of "blackmail talk" and said the count had told him he made a mistake in signing a "New York deed," by which he renounced a husband's rights to certain of his wife's property.

One Look At Wife Wearing a blue serge suit and blue skirt and holding a brief case, the count, in the raised dock, constantly wrote notes and passed them to his attorney, Norman Birkett.

He looked at the countess just once. She glanced quickly at the floor as he turned his head and he quickly faced forward again.

The countess wore a large black hat and a long fragile veil covered her face. She came into court wearing a huge silver fox piece but discarded it in the stuffy room.

Thunderclaps shook the packed courtroom and rain drummed on the skylight as Sir Patrick described the count as a man of "violent and un-governable temper."

The count snorted and Barbara Hutton smiled when Mitchell told how he burst into tears when he read a letter from her.

Mitchell read a letter from the countess which he had given the count. In it she said she could not live with him any longer and asked him not to try to see her.

Chauffeur Told Mitchell said he had been authorized by the Woolworth heiress to increase the proffered "gift" from \$250,000 to a limit of \$500,000.

Questioned by Birkett he said the count told him he had a letter from a former chauffeur telling him of "tappings" at the countess' Regent's Park mansion since he left London.

The count, who became the former Barbara Hutton's second husband, a day after she divorced the late Prince Alexis M'Divani at Reno, May 13, 1935, left their London home early in June for Paris.

Soon thereafter she placed a guard around the mansion and went to court to obtain the summons on which today's hearing was based.

Mitchell testified that "the only ground on which the countess wanted a divorce was incompatibility. There was no one else concerned at all," he added.

- Cook the sugar, flour, salt, yolks and milk together in a double boiler, stirring frequently. When the mixture thickens, beat and cool. Fold in the rest of the ingredients and pour over the crumbs. Bake for 35 minutes in a moderately slow oven. Serve warm or cool.
