**SPECIALIZING LAWYERS PREDOMINANT IN GROUP**  
**BIG INDUSTRY "CAZARS" PICKED FOR INFLUENCE**

WASHINGTON, Aug. 19.—The "go-between," who make a profession of bridging the gap between business and government, are different from the fixers and chiselers. It would be unjust to deny that remarkably talented fixers and chiselers may be found in their ranks. But so may honest men. In any case, they operate somewhat more publicly, and on a different plane from the ordinary lobbyists.

The great era of the go-betweens was in the dawn of the new deal, when an impression got round that the United States government was owned by three Democratic national committeemen—Arthur Mullen of Nebraska, Robert Jackson of New Hampshire, and Bruce Kremer of Montana. That era ended when the president commanded them to stop being national committeemen, or stop representing business men before the government. By now, it is all but forgotten. Arthur Mullen is dead, Jackson (not to be confused with Solicitor General Bob Jackson) is in a small way of business. Only Kremer still flourishes.

Kremer is a first-class example of the go-between. Besides being a former national committeeman, he is a "man who knows somebody." An intimate friend of Homer S. Cummings, he actually housed the attorney general when the latter first came to Washington. Kremer does much business with the justice department. O. Max Gardner, former governor of North Carolina, is also conspicuous now in the same way Mullen used to be.

The "cazars" and their first cousins, the political executives of large business, are an important class of go-betweens. The classic example, of course, was the late W. Forbue Morgan. He was treasurer of the Demo-

## AUGUST 31 NAMED FOR CITY BALLOT ON \$73,500 ISSUE

Proposed Issue Coupled With PWA Grant of \$58,500; Mayor Outlines Plan at Special Council Meet

The city council at an adjourned meeting late yesterday adopted an ordinance calling a special election Wednesday, August 31, to vote upon a bond issue not to exceed \$73,500 to provide funds for the reconstruction of paved streets.

The polls will be open from 1 p. m. to 8 p. m. There will be one election precinct in each of the city's four wards.

The proposed bond issue is coupled with a contemplated PWA grant of approximately \$58,500, the combined sum, or about \$132,000, to be used in the complete reconstruction of all paved city streets in need of reconstruction. By completing the reconstruction at once, the council foresees substantial savings to the city, including the expected PWA outright grant of approximately \$58,000.

Started Last Year  
 With many of the city streets badly in need of immediate reconstruction if they were to be saved at all, the council last year took steps to begin the paving project. At a special election in July the voters approved a bond issue of \$50,000 in addition to a special tax levy of two mills a year for five years. It was calculated the two-mill levy would provide about \$16,000 a year to carry on the reconstruction program over the five-year period. Proceeds of the bond issue and part of the returns from the special tax levy have been used in reconstructing some of the most seriously deteriorated streets. This special tax

## FIRST MAN'S CLUB TERMED LOTTERY

SAN FRANCISCO, Aug. 19.—(AP)—Atty.-Gen. U. S. Webb held in an opinion today operations of the First Man's club of California constituted a lottery.

The club, which has headquarters in Long Beach, has extended the chain letter idea to a streamlined basis.

The club sells memberships. Each applicant is required to sell two more memberships at a cost of \$1 each. The application blank contains space for 10 names. As the applicant's name moves up the list he ultimately is entitled to receive \$512 when his name is at the top, and if the chain has not been broken.

The attorney-general's office said under the system the payoff on each name would be \$1,024 if the chain is successful.

An opinion on the legality of the club was asked by Dist. Atty. Buron Pitts of Los Angeles.

Information received by Webb indicated 10,000 persons had joined the club.

## F. R. Denies Monroe Doctrine Involved in Ontario Speech

HYDE PARK, N. Y., Aug. 19.—(AP)—President Roosevelt indicated today no extension of the Monroe Doctrine was involved in his address at Kingston, Ontario, yesterday.

The president arrived here this morning for an indefinite stay.

Talking with reporters from his open car at the Hyde Park station, the chief executive appeared rested and happy after his strenuous trip through Ontario yesterday.

In his Kingston speech, the president asserted Americans would not stand "idly by" if domination of Canadian soil were threatened by a foreign aggressor.

Newsmen at his informal press conference informed Mr. Roosevelt of reports the state department in Washington interpreted his speech as an extension of the Monroe Doctrine.

The chief executive suggested his questioners read the original language of the Monroe Doctrine. He called attention to the fact he had not said anything about Latin America in his Kingston talk.

Questioned regarding an address by Rev. John J. O'Connor last night, Mr. Roosevelt said he merely had seen the headlines on it. O'Connor, whom the president criticized sharply in a statement this week, asserted Mr. Roosevelt's intervention in party primaries "is an escalator to a dictatorship."

## SPANISH REBELS OPEN OFFENSIVE TO WIND UP WAR

Franco's Air Raiders Bomb Barcelona Three Times—French Frontier Closed As Preliminary to Drive

(By the Associated Press.)  
 Spanish insurgents took preliminary action today for what was expected to be a general offensive to end the civil war, while Japan, at war with China and facing a hostile Soviet Russia, prepared to add 1,000,000 men to her armed forces.

General Franco's air raiders bombed Barcelona three times. His aides closed the French frontier—the customary omen of an insurgent offensive—and disclosed Franco personally would direct the campaign.

It was expected to be directed against vital Catalonia, possibly coupled with a drive on Madrid.

British Waris Germany.  
 The British government informed Germany it took "a serious view" of the unexplained arrest of Capt. Thomas Kendrick, British passport officer in Vienna.

Captain Kendrick was arrested by German secret police at the German-Swiss border yesterday as he and his wife were about to leave Germany on a vacation.

These developments overshadowed dim promises of appeasement both in Spain and Czechoslovakia.

Premier Juan Negrin of the Spanish government was in Zurich, Switzerland, ostensibly as a delegate to the international congress of psychologists.

But the reported presence there at the same time of the Duke of Alba, Spanish insurgent representative in London, caused speculation whether they might confer.

A softening of the demands of Czechoslovakia's Sudeten German minority was believed possible as a result of a conference yesterday between Viscount Runciman, unofficial British mediator, and Konrad Henlein, leader of the Nazi-supported Sudeten German party.

Japs Call Men.  
 A new order by the Japanese war office instructed all males in the recruit division—men between the ages of 20 and 34 who have had no active training—to "stand by."

It was believed this indicated Japan intended to throw vast reinforcements into a drive aimed at crushing China's resistance.

But at the same time it was disclosed Russian and Japanese conferees had failed to agree on selection of a joint commission to fix the Siberian-Manchoukuo-Korean border at disputed Changkufeng hill. The foreign office spokesman also accused Russia of violating the August 11 truce that ended a month of tension and fighting on the hill.

## YANKEE SOLONS GAVE COMMUNISTIC SALUTE IN SPAIN, IS AVOWAL

WASHINGTON, Aug. 19.—(AP)—A witness told a house committee today Representative O'Connell (D-Mont.) and Bernard (PL-Minn.) gave the "regular communistic salute" after addressing several hundred American youths fighting in Spain.

Alvin I. Halpern, who told the committee investigating un-American activities yesterday about his experience in the Spanish loyalist army, said the house members spoke at a dedication of pillars at a hospital at Benicassim, Spain.

"They told us we were fighting for a great cause—democracy—to wipe out fascism," Halpern said. "They gave the regular Soviet salute—a clenched fist in an upright position."

"They told us if we wanted anything after we returned to this country to let them know."

Abraham Sobel, another youth who related his experience in Spain yesterday, told the committee under questioning by Representative Starnes (D-Ala.) speakers for the Forbush Workers' club and the American League Against War and Fascism, of which he was a member, solicited his enlistment in the Spanish fighting forces.

The committee later unanimously ordered transmission to the justice department of the testimony of the two young American deserters from the Spanish government army for determination of whether federal law was being violated by communist agents recruiting volunteers here for the Spanish conflict. Representative Mosier (D-Ohio), a committee member, told newsmen he believed the two youths' testimony was the best "antidote" against communist activities the committee had heard.

## SALEM, Aug. 19.—(AP)—The unemployment compensation commission will give information about persons receiving compensation only to those who have written authority from those receiving the assistance, the commission said today.

## MOUNTAIN VIEW, Cal., Aug. 19.—(AP)—A mysterious powder blast heard nine miles away early today wrecked the two-story Bank of America building and damaged other structures for four blocks in the heart of Mountain View.

Chief of police Louis L. Gray said the blast was the work of vandals rather than a robbery attempt. He said there were powder marks on the casing of the front door.

The blast blew in and up, demolishing the inside of the building. Damage to the structure was estimated at between \$20,000 and \$30,000, and to other buildings at between \$10,000 and \$15,000.

Residents of Santa Clara, nine miles south of Mountain View, were awakened by the blast at 2:55 a. m.

Chief Gray said there had been no attempt to blow up the vault of the bank as it was unharmed by the explosion.

## AUSTRALIA WINS RIGHT TO PLAY U. S. NET TEAM

## ASHLAND CYCLIST KILLED BY BLOW FROM AUTOMOBILE

Edward B. Wagner, 36, of route 1, box 313, Medford, died in Ashland Community hospital at 10:30 last night from injuries he received when the bicycle he was riding was struck by an automobile at the intersection of East Main street and Mountain avenue in Ashland about two and a half hours earlier.

The machine, according to Ashland city police, was operated by George Dale Jorgenson, 17, son of Mr. and Mrs. J. T. Jorgenson of 891 East Main street, Ashland. Also in the car was Robert Adams, 16, son of Mr. and Mrs. Dick Adams of 128 Laurel street, Ashland.

An inquest into the fatal accident was to be held at 4 o'clock this afternoon in the J. P. Dodge and Sons funeral chapel in Ashland. It will be conducted by Deputy Coroner Will Dodge and District Attorney Frank J. Newman.

Wagner, married and the father of three small children, died from a fractured skull, a crushed chest and punctures of both lungs. He also sustained a compound leg fracture and numerous minor bruises and abrasions.

"I was traveling faster than I should have been," Ashland city police quoted young Jorgenson as saying after the accident. The youth was not held, but will appear at inquest this afternoon, as will several witnesses to the fatal mishap.

According to Ashland police, the accident occurred as Wagner, riding a bicycle north on Mountain avenue, entered East Main street and proceeded across the intersection. The 1937 Ford coach driven by Jorgenson and registered to his mother, was moving east on East Main street at an apparently high rate of speed. Ashland police explained, and crashed head-on into the bicycle as the latter traveled across the center of the intersection.

## JACKSONVILLE CEREMONIES WILL DEDICATE MARKER ON PIONEER CHURCH GROUNDS

To the memory of the Rev. Joseph S. Smith and the noble pioneers who organized and built in 1854 the Methodist church in Jacksonville, a granite boulder bearing a bronze plaque will be dedicated with impressive ceremonies Sunday afternoon at 3 o'clock.

Services will be held in the churchyard, where the monument will be unveiled and dedicated by the Rev. Sherman L. Divine, pastor of the First Presbyterian church of Medford, and some of the leading clergymen of the county, including the Rev. E. N. Mallory of Jacksonville. The Rev. Dr. Divine will preach the dedicatory sermon and a large chorus will lead the singing. Boy Scout Group 25 will assist in the ceremonies by giving their beautiful flag service.

The public is cordially invited to attend the dedication service. There will be a public address system in operation to enable visitors to clearly hear the sermon and other features of the program.

In cooperation with the Business Men's association of the city, the people of Jacksonville recently purchased the church and grounds and are engaged in preserving the old church as a Christian shrine, not only for the people of today, but for succeeding generations to come. During the past year a new roof has been put on the building, a new porch and new steps have replaced the old ones, and many other improvements are planned for the near future.

Constructed with public funds subscribed by the Christian people of those early days, said by gamblers and saloon-keepers, the old church still stands a mute but eloquent monument to the faith, zeal and generosity of the pioneer spirit that prevailed at that time. It has the distinction of being the first Protestant church building erected west of the Rocky mountains. It is for that reason that citizens of Jacksonville and of the entire county are combining their efforts to beautify the grounds and repair the building so that they will always remain a monument to the early days.

Especially active in the program to preserve the old church has been the Rev. Mr. Mallory and the Jacksonville Business Men's association. They have worked untiringly in their efforts to establish the church as the fine monument it now is and will continue to be.

The large granite boulder was several weeks ago brought from the Bill Bybee ranch and placed in the churchyard. Dr. R. P. Mortensen, president of the Stakjov Memorial park in Medford, graciously made a gift of the bronze plaque which will be set in the granite boulder.

## FIND LITTLE GIRL LOST ALL NIGHT IN WAGNER AREA

Patricia Jonas, 3, Wanders Away From Home Near Ashland Mine—Faithful Dog Stands Night Guard

Patricia Jonas, three year old girl, lost all Thursday night in the rough and rugged country near Ashland mine in the Mt. Wagner district, was found about eleven o'clock this morning, none the worse for her experience, except being hungry and footsore. The little miss was located by Harry Wickman, foreman of the Ashland mine, where her father, Paul Jonas, is employed.

The child, who disappeared about six o'clock Thursday evening, was accompanied by her dog "Jazzy" who stood guard, during the chilly night, and, when the child was found, as first refused to let any one approach her, according to Sheriff Syd. T. Brown. The dog was finally calmed. Clues were found that the girl and her dog companion had spent a portion of the night in a miner's unoccupied cabin, where the girl had taken off her shoes. She was found about two miles from her home.

Due to her age, Patzy is unable to give any details of her wanderings. It appeared from the condition of her shoes, and clothing, she had travelled a considerable distance. She appeared unconcerned, but was glad to get home.

Patzy was first missed by her father about six o'clock, who a short time later, notified the sheriff's office, and Ashland city police. Sheriff Brown organized a volunteer posse and an all-night search was conducted without finding any trace. At dawn the search was renewed with new vigor. The volunteer posse was augmented Friday morning by CCC enrollees and forest rangers, and a systematic check of the area started.

There are a number of abandoned mine shafts in the section, and fears were felt the girl might have fallen into one of them.

## PORTLAND GROUP EYES MEDFORD AS CENTER FOR TRIPLE INDUSTRY

Feasibility of establishing a new triple industry here is being considered by a group of Portland men, it was learned today.

Looking over the field here as a member of the group is Ralph Hahn, former state canner for Washington and retired wholesale grocer. Mr. Hahn said he was now looking over possible sites for the proposed industry. He stated he would return in a few days to Portland to report to his associates for a final decision on the proposition. He did not name his associates.

The proposed industrial enterprise is a brewery, a cannery and an industrial alcohol plant which would utilize culm pears. Mr. Hahn related there would be three separate plants on one site and three separate corporations, all owned and managed by the same group, he said.

All necessary capital is in hand and if it is decided to proceed with the plan actual building of plants would begin in 30 to 60 days, Mr. Hahn asserted.

Initial output of the cannery would be 100,000 cases of pears a year, of the brewery 20,000 barrels of beer a year, Hahn said. Initial production of industrial alcohol has not been determined, he added.

Mr. Hahn stated that he has studied the proposition here numerous times and that he feels confident the proposed business could be made a success.

## DEATH TAKES LAST OF FAMED COMEDY TEAM

ETAUKET, N. Y., Aug. 19.—(AP)—The famous old comedy team of McIntyre and Heath, which was crisscrossing vaudeville audiences with the broad humor of its "Ham Tree" sat a half century ago, lives only in memory today.

Thomas K. Heath, 85-year-old survivor of the team, died of a heart attack at his Long Island home last night, just a year after the passing of his partner, Jim McIntyre.

Heath never knew that his roommate in 60 years of trouping had died before him. Heath was stricken with paralysis when McIntyre died in Connecticut and, through his last year of invalidism, the news was kept from him.

## MONTANA HORSES HIT BY SLEEPING DISEASE

HELENA, Mont., Aug. 19.—(UP)—Sleeping sickness strengthened its attack on horses and mules in western Montana today, bringing the estimate of the total number affected to 7,500, Dr. H. F. Wilkins, state veterinarian, reported.

The latest cases reported were from Corvallis in Vavalli county where the disease struck for the first time this year. It was exceedingly virulent there last year.

The veterinarian estimated that 300 new cases were reported during the last 10 days.
