BREATHING SPELL GIVEN EUROPE AS WAR MOVES GROW

Hitler More Conciliatory as Powers Show Firmness—October 1 Fateful Day—All Nations Mass Arms.

Europe settled down to an uneasy breathing space today after a week of hectic diplomatic maneuvering and waited—in a state of ever-increasing mobilization—for what apparently was to be a fateful day.

Yesterday (Saturday) the government of Czechoslovakia was informed of Reichsfuehrer Adolf Hitler's "final" word on the Sudeten German solution.

Der Fuehrer softened Confronted with distinct indications that Britain, France and Russia might yet rally to the defense of Czechoslovakia it pressed too far. It demanded peace to war.

He still insisted upon surrender of the Sudetenland to Germany—a Czechoslovakia has agreed to do by negotiations—but he gave her until October 1 to do it.

Previously the Fuehrer had been represented as insisting upon immediate evacuation by the Czechoslovaks and occupation by German or Sudeten German forces pending formal demarcation of the new frontier.

But a Berlin informant who saw Hitler's memorandum said he declined to become a guarantor of the new Czechoslovak frontier unless other minorities—Polish and Hungarian—also attained their desires of reunion with their homelands.

Official Czechoslovak quarters in London viewed this refusal as an extension, in effect, of Hitler's demands for "self determination" to include Poles and Hungarians.

The Czechoslovaks therefore regarded the "final" memorandum as going beyond their agreement of last Wednesday with the French and British to concede the Sudetenland as the price of peace.

The memorandum was said by the Czechoslovaks to demand evacuation of the areas where 75 percent or more of the population is German, and a plebiscite in remaining Sudeten districts.

Prime Minister Chamberlain, after returning from his Godesberg conference with Hitler, yesterday conferred with his cabinet and arranged a conference with the French premier, Edouard Daladier, today in London.

Czechoslovakia was turning herself into an armed camp behind a wall of steel and cement. 1,500,000 soldiers were mobilized under the leadership of a government headed by a one-eyed military hero, and her isolation was virtually complete.

OFFICIAL BERLIN THINKS GENERAL COMBAT AVERTED

Hitler's Memorandum Held Way to Peace—Six Points in Plan Outlined.

BERLIN, Sept. 24.—By October 1 at the latest the world will know whether Czechoslovakia will yield to Reichsfuehrer Adolf Hitler's final demands to cede peacefully to Germany those sections of her Sudeten region which are overwhelmingly German.

Complete dismemberment of the Czechoslovak state no longer was insisted upon except by the implication in Hitler's refusal to become a co-guarantor of the whitened-red state's boundaries unless other minorities attained their wishes.

Official Germany seemed confident tonight that a general European war or even a localized German-Czechoslovak conflict had been averted by the Hitler-Chamberlain negotiations at Godesberg.

But the German army and air force remained close enough to the Czechoslovak border to be prepared for all emergencies.

The points in Hitler's stand, as outlined here by an informant, who saw the Fuehrer's memorandum to Chamberlain and by other sources, included:

1. Eight days, counting yesterday, are envisaged for peaceful handing over of the Sudeten German territory to Germany.

2. If Czechoslovakia refuses, she would carry the responsibility for all that might follow. If she agrees, peace will be preserved.

3. Germany declines to become a co-guarantor of the new Czechoslovak boundaries unless other minorities in the republic also attain their wishes.

4. Chamberlain was assured Germany had no intention of annexing territory overwhelmingly inhabited by Czechs.

5. The memorandum contained positive suggestions for effecting the transfer of such parts of the Sudeten region as were conceded to Germany by Britain and France in the plan accepted by the Prague government.

6. The memorandum positively is Germany's last offer to Czechoslovakia.

Flood, Fire, Gale Do \$4,000,000 Damage

MICHELSON PUTS ROOSEVELT FOES IN "PEJO PARTY"

Smear Chief of Democrats Thinks Up New Name for Anti-New Dealers.

WASHINGTON, Sept. 24.—(UP)—Charles Michelson, publicity director of the Democratic national committee, tonight coined a new name for the minority party, composed of old-line Republicans, middle-of-the-roads, those who think the new deal does not go far enough, and a few disgruntled ex-democrats.

The name is the "Pejo party." Michelson said a "Pejorative" is defined by the dictionary as one who believes everything in nature is growing worse.

"Pejorative party," said Michelson in his weekly release, "Dispelling the Fog" sounds a little too long, so may I suggest that we curtail it a little and that henceforth we can speak of the Pejo party.

"This will save a lot of words to describe an aggregation that has no definite policy but is united in the creed that whatever Franklin D. Roosevelt does, or whatever the new deal offers, must be wrong."

AVIATOR'S WIDOW GETS SUIT RIGHT

The company had sought to join her from suing in more than one capacity. Mensing, district superintendent, and Snee, dispatcher, had sought to have the case dismissed as applied to them.

HUNT EXCITEMENT KILLS SALEM MAN

ROSEBURG, Sept. 24.—(P)—Victim of paralysis induced by excitement after he killed a deer, Mark D. Ellis, Salem, became the state's seventh fatality today in the deer-hunting season which started last Tuesday.

Meager reports reaching here from the north Umpqua region 60 miles to the east told how the stricken hunter summoned three companions to his side by firing rifle shots after the party had become separated.

The companions found him in a critical condition and started carrying him to Roseburg but he died at the Steamboat CCC camp, about 40 miles from here as a physician attempted to save his life. The body was brought here today and will be sent to Salem.

INSANITY CLAIM FILED BY NELSON IN MURDER TRIAL

Sea Trip in Fog Held 'Crazy Idea'—Friends Testify to Conduct.

TOLEDO, Sept. 24.—(AP)—Counsel for Henry Nelson, Portland salesman, strove today to prove that he was the victim of an unbalanced mind last July 18 when he was accused of slaying Richard Earle, Depoe Bay boat operator.

Through a doctor, old friends and a coast guardman, George Mowrey, attorney for Nelson, sought to establish grounds for Nelson's plea of insanity by reason of insanity.

After questioning a boatman's mate of the coast guard about the weather that prevailed the day of the slaying, Mowrey was asked by the court to explain the objective.

The lawyer replied that he wanted to show that such a heavy fog lay over the sea that the trip Nelson made that day with Earle was a "crazy idea."

Nelson has alleged that he asked Earle to take him to sea and marry him and Lucille Compenberg but that the boat operator molested the woman. Later, aboard, Nelson claimed that he abducted Earle for his alleged conduct and shot him only after the sailor attacked him.

Dr. C. A. Downs, Salem, one of a parade of nine defense witnesses questioned Saturday as the court remained open to expedite the trial, told of treating Nelson in 1932 for a broken arm and fractured cheek bone suffered in an automobile accident. Mowrey tried to bring out the possibility that shock from the accident might have injured Nelson's mentality, on cross-examination by the state, the doctor said he had never known of a case of insanity to result from such injuries.

EUROPE TURMOIL SHOWS NEED HUGE AMERICAN FLEET

Sen. Glass Seeks Cut in Spending Save for Navy—Not Encouraged.

WASHINGTON, Sept. 24.—(AP)—Chairman Glass (D., Va.) of the senate appropriations committee, said today that developments in Europe had convinced him this country should increase its naval expenditures.

"I have been opposed to those enormous appropriations for war purposes," the 80-year old Virginia senator said in an interview, "but it begins to look as if it is inevitable and desirable to have larger naval appropriations."

Funds made available for the navy reached a new high point for 18 years in this fiscal year, totaling approximately \$618,000,000.

Glass said he saw no reason why the United States should be involved, in the event of a European war, "unless some country does what Germany did before—links our ships and murders our nationals."

The Virginian said he would seek a reduction in virtually all expenditures, aside from those for the navy, in the next congress. He has been a long time advocate of lower government costs.

"There is a tremendous opportunity for a reduction in regular government expenditures, principally through the elimination of useless government agencies," he said. "But I don't know that there will be any support for cuts. There hasn't been any such support in the last three congresses."

"Everything depends on whether a sufficient number of the members of congress have become ashamed of being rubber stamps. I don't feel encouraged to believe that."

Observing that some senators he called presidential "coat-tail hangers" had been defeated in the primaries, Glass said he found it "a very gratifying thing."

DEATH PLUNGE OF EX-U AIDE, VEXES

NEW YORK, Sept. 24.—(P)—Police puzzled today over the motive for a death plunge shortly before midnight in which Dr. Raemer Rex Ranshaw, 58, New York university chemistry professor and former member of the staff of the University of Oregon, and his wife, 60, died.

Authorities were told that Dr. Ranshaw was heard to yell before the fall. Detectives were inclined to the belief that it was a double suicide. The doctor, who was noted for chemical research and was the author of 35 scientific papers, was fully dressed but his wife was nude. No notes were found.

Before coming here in 1920, Dr. Ranshaw had served at Oregon, Wesleyan university, Iowa State college and the Harvard medical school. He and Mrs. Ranshaw were married in 1931, each having been married before.

NATIONAL GUARD ORDERED TO KILL STORM PROWLERS

Homes of Cape Cod Rich Looted by Roving Bands—Reconstruction in New England Starts.

(By the Associated Press) An army of 100,000 WPA workers, reinforced by thousands of volunteers, regular army soldiers and national guardmen, sailed far into last (Saturday) night on the gigantic task of cleaning up the seven-state hurricane front where nearly 500 known victims lay dead and scores of others were missing amid \$500,000,000 property damage.

Jacksals of the storm—roving bands of looters—led Adm. Gen. Charles H. Cole of Massachusetts to issue "shoot to kill" orders to national guardmen.

As the reconstruction work went forward, General Cole rushed 250 guardsmen to Cape Cod to stamp out reported looting of rich estates at Falmouth, Gray Gardens, Bourne, Buzzards Bay and Mashpee.

"It is open and bold-faced," Cole said. "At such a time as this, nothing is more despicable. I have issued orders to shoot to kill."

Officials estimated the damage in Rhode Island, New Hampshire and Massachusetts at more than \$130,000,000.

State and federal authorities rushed tons of food, blankets and medical supplies to the wide-spread stricken areas, where 12,000 families were homeless.

Crowning the three-day ordeal of stunned tragedy and desolation, fears of a possible disease epidemic led to emergency measures in many communities.

Relief workers inoculated 700 persons against typhoid fever at Adams, Mass., and town officials at Ware, Mass., where drinking water reservoirs gave away, asked for 300 vials of anti-tetanus vaccine.

Slowly ebbing flood waters gave the "mop up" legions a chance to bury the dead and sift through mountains of debris for the bodies of scores still missing.

Tree-clogged highways and wrecked lines of communication prevented a final accurate assessment of the life and property loss, but many officials agreed it was the area's worst storm disaster—striking with appalling suddenness Wednesday as it howled out of the tropics and raged along the Atlantic seaboard—in more than a century.

In New England alone, telephone company officials said 250,000 miles of wire would have to be replaced. Airplane observers reported New Hampshire's tall pines and birch trees leveled by the hundreds.

The little community of Petersboro, N. H., still isolated, reported by radio that its losses by fire, flood and hurricane totaled more than \$1,000,000.

Yankee Ship Menaced BARCELONA, Sept. 24.—(P)—The American freighter Wincomat, out of Portland, Ore., barely escaped serious damage in heavy daylight bombing of lower Barcelona today.
