

MARTIN ASSAILS DICTATOR TREND OF SMALL GROUP

SALEM, Oct. 4.—(AP)—A warning to citizens to guard against being misled by the belief that a large and single party alone can accomplish the ends of good government was delivered Saturday by Gov. Charles E. Martin, speaking at the dedication of Oregon's new capitol.

The governor, who celebrated his 78th birthday Saturday, took occasion near the end of his address to remark against "small cliques and groups organized here to accomplish their own selfish ends."

"Establishment of uncontrolled bureaucracy and centralization of power into the hands of one group without continuing the checks and balances laid down by the founding fathers for the protection of democracy is as dangerous as is the extreme example of mental laziness," said the governor.

He recalled how "here in Oregon we recently saw an attempt at labor dictatorship in the recent reign of terrorism, which was broken only when the racketeers and vandals were brought to justice."

In centralization is bred, he said, the seeds of dictatorship, "especially when the majority party is itself merely a coalition of minorities, each with a Trojan horse to stable in the party organization."

"Here in Oregon we have the opportunity right at hand to strike a valiant blow for the defense of democracy and against the forces of disension and disruption that now seek to smash themselves on to the body politic and gorge themselves on the tax dollars meant for the benefit of all of us," he declared.

"We can rout the enemy from our midst by our vigorous and wholehearted participation in the affairs of state, beginning with the November election."

JERUSALEM RIOT NETS 106 DEATHS

JERUSALEM, Oct. 4.—(AP)—At least 98 persons were killed today in new outbreaks of violence in the Holy Land, bringing to 106 the number of deaths since Saturday.

Six persons were killed when a house in Jaffa was blown up by a bomb early this morning.

Twenty Jews, including 11 children and three women, were slain and three were wounded when an armed band, described by officials as Arab rebels, raided a suburb of Tiberias on the Sea of Galilee.

The band entered numerous houses, firing indiscriminately at the sleeping occupants.

Other bands raided Tiberias itself, burning a Jewish synagogue, government offices, law courts and numerous other buildings before they were driven out by police and troops. Six of the raiders were killed.

FUND ASKED FOR '39 FAIR EXHIBIT

SALEM, Oct. 4.—(AP)—The board of control, granting a request of the greater Willamette Valley association, voted today to ask the state emergency board to appropriate \$25,000 to finance an Oregon agricultural exhibit at the 1939 San Francisco world fair.

If the appropriation is made, the board will ask the legislature to provide the money by turning the unexpended appropriation for the New York fair over to the emergency board.

The New York fair appropriation was not used because Oregon withdrew its exhibit. The attorney general ruled that this money would have to revert to the general fund and could not be transferred to the San Francisco exposition.

Evangelist Series Are Continuing At Nazarene Church

Evangelistic services will continue every night this week at the Church of the Nazarene, with the Long quartet contributing special musical numbers each evening. An entire evening of music will be given by the quartet Thursday.



Large congregations attended the three major services at the church Sunday, there being about 20 professions of faith. At the evening service the Rev. Fred M. Weatherford, pastor-evangelist, gave a sermon on "The Opales of Life."

Millard's Brother, Delaware Pastor, Wins Recognition

The Rev. Dr. Paul A. Millard is included in the 50th anniversary edition of Who's Who in America. It was announced in a recent issue of the Daily Times of Worthington, Minn., where he is pastor of the Church of Christ. Dr. Millard is a brother of the Rev. D. E. Millard of Trail, former pastor of the First Christian church here.

Dr. Millard was among 39 in Minnesota and 2,545 in the United States representing newcomers among the 31,545 outstanding contemporary men and women listed in Who's Who, the Times said.

Dr. Millard was included in the book's listings because of his work in religion and religious education, the Times stated. He is president of the Minnesota Bible university and will begin his 32nd year in the ministry January 1. He has had the longest continuous pastorate among Churches of Christ in the northwest.

PURGE WIN COST TYDINGS \$88,814

BALTIMORE, Oct. 4.—(AP)—The cost of Sen. Millard E. Tydings' Democratic primary victory over administration-sponsored Rep. David J. Lewis was spread on circuit court records today—\$88,814, with \$11,931 of it a deficit.

The report, filed as required by Maryland election law, listed Tydings' law partners, Allan Sauerwein and Robert H. Archer, as the largest single contributors with \$2,000 each. Another partner, Herbert Levy, gave \$1,750.

Tydings himself put in \$1,500; his wife and John J. Raskob gave \$1,000 each. Sen. George L. Radcliffe, a personal friend of President Roosevelt, but Tydings' campaign manager, gave \$100 and former Sen. James A. Reed of Missouri contributed \$50.

No Hunting License: Fined Bert Rippey, 50, of Jacksonville, a cook at Applegate CCC camp, was fined \$25 and \$40 costs and sentenced to 30 days in jail by Judge William R. Coleman in justice of the peace court this afternoon for hunting without a license.

Rippey pleaded guilty. He was arrested by state police yesterday morning near the Buzzard mine. He was committed to jail after passing of sentence.

Strengthen Ft. Worden PORT TOWNSEND, Oct. 3.—(AP)—A battery of four new type mobile antiaircraft guns, effective against airplanes at up to 25,000 feet, and drawn by army trucks, will be stationed at Fort Worden soon.

WASHINGTON, Oct. 4.—(AP)—Counsel for railroad brotherhoods contended today increasing business indicates there is no need for the 15 per cent pay cut the carriers have proposed.

Cross-examining a witness for the joint carriers' conference committee, Charles M. Hay of the brotherhoods' legal staff brought out before the president's railroad fact-finding board carloadings for four weeks in September exceeded those for any other period this year.

The witness, Dr. Julius H. Parmelee, countered with the assertion while this was true, carloadings still were 20 per cent below the similar period in 1937. Parmelee is director of the bureau of railway economics of the Association of American railroads.

Mary's Hubby Hurt COLUMBUS, O., Oct. 4.—(AP)—Buddy Rogers, orchestra leader husband of Mary Pickford, suffered a sprained shoulder in an automobile accident near here today and two companions also were slightly injured.

MANY IMPORTANT NEW DEAL CASES WAIT HIGH COURT

WASHINGTON, Oct. 4.—(AP)—The supreme court opened its new 1938 term Monday by paying tribute to Associate Justice Benjamin N. Cardozo, who died last July.

As soon as the black-robed justices filed into the marble-columned chamber, Chief Justice Charles E. Hughes delivered a brief eulogy of the late jurist.

A vacant chair served as a reminder a successor to Justice Cardozo has not yet been appointed by President Roosevelt.

Hughes said the court had suffered an "irreparable loss" in Justice Cardozo's death.

The chief justice, who spoke without referring to manuscript, referred to Cardozo's career as "one of the most illustrious in judicial annals."

The court, reassembling for an eight-month term, found a bumper crop of litigation—including fresh attacks on major administration laws—awaiting its attention.

The first session after a summer recess is limited to admitting attorneys to practice and hearing motions. For the next week, however, the eight justices will be busy passing on approximately 350 petitions for review of lower court decisions which have accumulated during the four-month adjournment.

Announcement of the action decided upon will be made next Monday.

At that time arguments also will begin on cases the court agreed last spring to review. These include an attack by 18 private power companies on the constitutionality of the Tennessee valley authority act.

Among the petitions awaiting action is an appeal by Thomas J. Mooney, serving a life sentence in San Quentin penitentiary for complicity in the 1916 preparedness day parade bombing in San Francisco. He lost his right for freedom before the California supreme court.

There also are several controversies growing out of interpretations of the national labor relations act, including the Ford Motor Co. case.

WATER FACILITY AREAS PROPOSED

WASHINGTON, Oct. 4.—(AP)—The soil conservation service said today the department of agriculture was setting up water facility regions in each of 17 western states in cooperation with state officials.

Congress provided \$50,000 for use in the states as loans in building small dams, water pumping projects and other domestic and livestock water facilities during this fiscal year.

The farm security administration decided recently to spend \$5,000,000 for a similar purpose but only on farms where rehabilitation work was necessary.

Areas in which projects may be carried on are being established in North Dakota, South Dakota, Nebraska, Kansas, Oklahoma, Texas, Arizona, New Mexico, Utah, Colorado, Montana, Wyoming, Idaho, Nevada, California, Oregon and Washington.

SCRIBES STRIKE, MINERS GIVE AID

WILKES-BARRE, Pa., Oct. 4.—(AP)—Residents of this anthracite city of 86,000 read their news in out-of-town papers today, or did without, as a strike of editorial employees on Wilkes-Barre's four newspapers—three dailies and one Sunday—entered its fourth day.

Publishers of the Evening News and Times-Leader, afternoon papers, the Morning Record and the Sunday Independent announced late yesterday they were suspending operations in all departments, after printing since Saturday with skeleton editorial forces.

Stanley Kupatas, president of the A. N. G. local, said members of the United Mine Workers of America joined newsmen on picket lines at the four newspaper plants yesterday.

Hunter Wounded DALLAS, Oct. 4.—(AP)—When Lloyd Shank, 22, deer hunter, stumbled and fell down an embankment near here Saturday he accidentally discharged his gun. The bullet struck his leg.

LABOR PEACE PUT UP TO COMMITTEE

SAN FRANCISCO, Oct. 4.—(AP)—Mayor Angelo Rossi charged 10 representatives of labor and industry today with the task of taking pickets off the patrol they started September 7 before 35 of the city's major stores and with returning the 3,000 striking A.P.L. clerks to work.

Calling his newly appointed conciliation committee into his office, the mayor was scheduled to present a brief history of the strike to the committee late today (4:30 p. m.) and then withdraw until it has presented a solution to the industry.

The committee, split equally between leaders of men who work and those who hire work done, was to determine the methods it will pursue in arriving at findings which the A.P.L. clerks' union and retailers' council, representing the stores, will be asked to accept. Principal issue is a seniority demand by the union.

UNIVERSITY PLAYER'S CAR KILLS WOMAN

EUGENE, Ore., Oct. 4.—(AP)—Mrs. W. R. Hall, elderly Eugene woman, was fatally injured Saturday night when she was struck on a downtown street intersection by a car driven by Victor Reginato, varsity end of the University of Oregon football team.

Her husband was also injured. Reginato, registered from Klamath Falls, was not held. District Attorney L. L. Ray said state police would investigate the accident.

PLANT SHUTDOWN, DENY ANY STRIKE

PORTLAND, Oct. 4.—(AP)—Pickets parading before the huge Doernbecher furniture plant halted operations for the second day although union officials denied there was a strike.

The 1,092 workers rejected a 10-cent per hour pay cut, but termed the shutdown a lockout.

Howard Chastain, vice-president, said his firm was "open for business" and the management was "open for negotiations" but that no meeting had been scheduled.

Working contracts covering 1,000 workers in nine plants and three unions—furniture and upholsterers' locals—expired Saturday. The company announced a lower wage scale and the workers' action followed.

The company's sawmill at Coalinga, near Oregon City, was closed.

JOIN SPRINGFIELD TO EUGENE TALKED

EUGENE, Oct. 4.—(AP)—An investigating committee listed benefits of the proposed merging of the cities of Eugene and Springfield, a merger which would form the state's second largest city.

The committee said the combined city would stand to get more efficient school, police and fire service, might get lower water and electricity rates.

Peace Bonus WILMINGTON, Del., Oct. 3.—(AP)—A "peace bonus" of \$5 each, tested in the pockets of a billboard company's employees today.

PLAN CEREMONIES FOR HOMECOMING, NORMAL OCT. 28-29

SOUTHERN OREGON STATE NORMAL SCHOOL, Ashland, Oct. 4.—(Sp.)—Homecoming at the Southern Oregon State Normal School, set for October 28 and 29 will feature ceremonies designed to appeal particularly to the graduates of the former normal school in Ashland, including a reunion of the class of 1896 with removal of the class stone from the old site to the present campus and a re-dedication of the marker in its new location.

Planning the 1896 class reunion with the accompanying ceremonies for the alumni of the former normal school and acting as invitations and publicity committee are Mrs. Rosa Dodge Galey and Mrs. Susanne Homes Carter of Ashland.

AERIAL SHOTS HIT BRITISH VESSELS

MADRID, Oct. 4.—(AP)—Three British ships were struck by bombs today and two of them set afire in a renewal of Spanish insurgent air raids along the Mediterranean coast of government Spain.

Fourteen Savoia (Italian) type planes in a raid on the Barcelona waterfront bombed and set fire to the Theophrastus, 2,182 tons, and the Gothic, 2,146 tons. No casualties were reported.

In Valencia harbor a lone seaplane dropped 12 bombs one of which struck the 1,074-ton British vessel Lulimneeh. The ship's cook said to be British was injured.

In another seaplane raid several buildings were destroyed at the port of Denia.
