The Shasta fir grows only in high altitudes, has no commercial value, but is ideal for Yule decorations, and much in demand in California and the east. It is undersized to two different California dealers have offered to buy the trees.

The commissioner journeyed to Beaver creek today to count the trees. The purchasers desire to remove the trees before snow comes in the high hills.

NEW LAND TESTED FOR GOLD MINING

Testing for gold was underway today on the Ray Offenbacher property on the Big Applegate river. The enterprise was initiated by Bert C. Roedel, Medford real estate agent, as broker. Mr. Roedel is associated with Joseph Penso of Sacramento, Cal., as field man.

About 500 acres of land owned by the Offenbacher and William and Ralph Smith families are held under option, Mr. Penso said. If the tests show that mining can be carried out on a profitable scale, two dredges will be installed by the Lord & Bishop engineering firm of San Francisco. Mr. Penso related.

The exploration will take about five months, Mr. Penso said, adding that four men are doing the testing with a Keystone drill. An effort is being made to procure additional land, he stated.

Menus of the Day

(By Mrs. Alexander George)

Meatless Baked Dinner (Serving three or four)
Spanish Rice Mold
Baked Squash
Orange Muffins
Fruit Salad
Raisin Pie

Spanish Rice
2 cups boiled rice
1/4 teaspoon salt
1/4 teaspoon paprika
1/4 teaspoon celery salt
2 tablespoons butter, melted
1 teaspoon chopped parsley
2 egg yolks
1/4 cup milk

Mix ingredients and fill buttered ring mold. Bake for 15 minutes in a pan of hot water in a moderate oven. Remove from oven and let rice mold stand in hot water five minutes. Carefully unmold and fill and surround with sauce.

Sauce
4 tablespoons butter
3 tablespoons minced onions
2 tablespoons minced green peppers
1/4 cup diced celery
1 cup tomatoes
2-3 cup water
1-3 teaspoon salt
1/4 teaspoon white pepper
1/4 cup chopped ripe olives

Brown onions, peppers and celery in butter heated in a frying pan. Add flour and cook until it has browned. Add rest of ingredients. Let simmer for five minutes or until thick and creamy. Serve very hot.

Orange Muffins
1 1/2 cups pastry flour
3 teaspoons baking powder
1/4 teaspoon salt
3 tablespoons granulated sugar
1 egg
1-3 cup orange juice
1/4 cup milk
1 tablespoon grated orange rind
3 tablespoons fat, melted
Mix ingredients. Beat one minute. Half-fill greased muffin pans and bake for 15 minutes in a moderate oven. Serve warm with butter.

LIGHT CRIME DOCKET WAITING GRAND JURY

An assault case, a half dozen minor criminal matters, including non-support charges, are scheduled to be presented to the new grand jury to be selected Monday morning at the opening of the October term of the circuit court. The district attorney's office anticipates the grand jury session will be short.

A jury panel of 31 names has been drawn for the new term, to report Monday morning. It includes seven women and 24 men.
