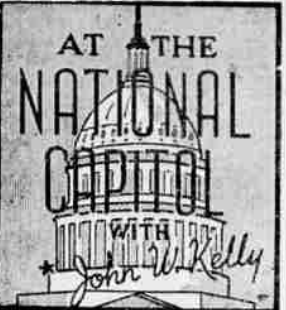

# HOUSE IN FAVOR OF EMBARGO REPEAL



Washington, D. C., Nov. 2.—Whenever cautious Republicans have criticized new deal policies to remedy this or that, new dealers have sneeringly answered: "What have you to offer that is as good or better?" It has been a rather devastating question, but at the regular congressional session the Republicans will undertake to answer with a complete program, submitted in the form of a series of measures.

Now being formed is a committee of Republicans who will study the farm problem (listed under 17 phases), and their ideas for resolution will be drafted and presented next spring. Only member of the committee from the Pacific northwest is Representative James W. Mott of Oregon.

Mr. Mott and Representative John Z. Anderson of California, are sole spokesmen on the committee for the vast area west of the Rocky mountains and Pacific ocean. This gives some idea of the burden placed on the committeemen and the scarcity of Republicans.

## ADMINISTRATION VICTORY ASSURED BY TEST BALLOT

Lower Branch Votes Down Motion to Include Embargo in Final Draft of Bill

Washington, Nov. 2.—(AP)—The house went on record in favor of repealing the arms embargo today, thereby insuring swift enactment of the neutrality bill advocated by President Roosevelt.

The action was taken on a motion by Rep. Shanley (D., Conn.) to instruct house conferees to include an arms embargo in the bill's final draft. The house assured that the embargo would be repealed by flatly rejecting the motion.

The vote was 242 against the motion to 181 in favor of it.

**Conferees To Meet**

House conferees will meet with senate conferees tomorrow morning to compose differences between senate and house versions of the neutrality bill, enactment of which Mr. Roosevelt asked when he called congress into special session September 21.

The principal point of variance between the two versions is that the house bill contains only a modification of the present ban on arms sales while the senate measure completely removes the embargo. Both measures provide for a cash and carry system of commerce with belligerents.

**Final Action Soon**

The conference committee was expected to pick the bill into final shape quickly. The house and senate may give it final approval either late tomorrow or Saturday. Administration leaders predicted adjournment of the session Saturday night.

The house vote on repeal was the third of the day.

First rejected was a proposal by Rep. Wolcott (R., Mich.) that the house advocate inclusion in the bill of a prohibition against federal reserve banks or other government agencies financing any purchases by belligerents. The vote was 228 to 196.

Then by a vote of 244 to 179 a motion for partial repeal of embargo was defeated.

### 3 NAZI BOMBERS KNOCKED DOWN ON NORTHERN FRONT

Anti-Aircraft Guns and British Planes Get Two Scouting Over British Lines

With The British Expeditionary Force in France, Nov. 2.—(AP)—A hail of anti-aircraft shells from British and French batteries and machine-gun bullets from British planes knocked down two German Heinkel bombers this morning when three of them attempted a scouting raid over the British lines.

(A dispatch from Lille, France, said two British fighting planes brought down a German bomber in a skirmish over northern France. It was not disclosed immediately whether this was the same encounter.)

Bursts of smoke from anti-aircraft shells encircled the three German planes. Out of the sky to the east streaked five British pursuit planes. Soon thereafter two of the German planes spun to earth.

A general headquarters communiqué failed to mention the third machine, which streaked homeward trailing smoke.

"One of the planes was shot down by British aircraft and the other was brought down by the joint attack of British and French anti-aircraft guns," the communiqué said.

### HOLMAN PRAISES M'NARY AS ABLE TO ASSURE PEACE

Senator Charges New Deal Not Unwilling Enter War to Erase Debauch Memory

Portland, Nov. 2.—(AP)—Speaking at a McNary-for-president rally last night, Senator Holman (R-Ore.) charged the new deal was not unwilling to see America in the European war so its "debauch of seven years of failure" might be stricken from the public's mind.

Holman, keynote speaker, commended Senator McNary (R-Ore.), minority floor leader, as the man best fitted by ability and temperament to assure peace and order for the country. He said no man was better qualified by experience to steer an American course at the present "crossroads."

"America stands," he said, "at the crossroads. On the right is the road to constitutional government, responsibility and confidence. On the other road, there is the way to rash experiment in the setting aside of the constitution and the possible loss of our form of government."

He asserted the administration's "must legislation" was a form of dictatorship and that certain foreign trade treaties were made for the benefit of foreign nations at the sacrifice of American interests.

Kern Crandall, state Republican central committee chairman, predicted the McNary-for-president movement would spread to the east rapidly.

McNary announced last Thursday that he would permit placing his name before the Republican national convention as a candidate for the presidential nomination.

### MARITIME UNION SEEN DOMINATED BY COMMUNISTS

Un-American Activities Chief Voices Charge After Ex-Union Members Testify

Washington, Nov. 2.—(AP)—Chairman Dies (D., Tex.) of the house committee on un-American activities, expressed the opinion today that Soviet Russia was "virtually in control of the situation here as far as our ships are concerned."

He made the comment after hearing testimony of Frederick C. Phillips of New York that 80 percent of the leadership in the National Maritime union was communist and "the other 20 percent are afraid to open their mouths."

**Intimidation Told**

After Phillips, a former union official, testified an attempt had been made to murder him because of his opposition to communism in the N.M.U., Dies urged him to present his case to the justice department. William McCustion, a preceding witness who related a similar story, complained to the department yesterday.

"There appears to have been a conspiracy on the part of N.M.U. officials to destroy the civil rights of an individual," Dies commented.

The witness said he had been elected secretary of the Atlantic district of the union and later had been suspended illegally by Joseph Curran, union president, "and a group of communists."

Phillips said he was a volunteer in the air corps during the world war and a member of the American Legion at Dover, Del.

**Could Paralyze Navy**

He expressed belief the communist party in Russia was trying to control the marine industry in the United States because it was a "paralyzing industry."

### FATAL SMASHUP CAUSED BY DEER

Klamath Falls, Nov. 2.—(AP)—A truck wreck caused by a deer crashing into the side of the vehicle last night proved fatal to Marion Orville Brailier, 29, in a hospital at Lakeview.

Charles Squires, who was slightly injured in the wreck, said the deer apparently was blinded by the truck's lights and dashed against the side of the cab. The truck turned over, crushing Brailier, the driver.

The wreck occurred on the Lakeview-Klamath highway as the men were returning to the Klamath Falls where Brailier is survived by his wife and three children.

### DR. W. S. CARY OF ROGUE RIVER DIES

Grants Pass, Nov. 2.—(AP)—Dr. W. S. Cary, 80, Rogue River physician, died here Wednesday afternoon. He underwent an emergency operation October 19 following rupture of his appendix.

Dr. Cary, native of Zanesville, Ohio, entered practice at Dallas, Ore., in 1895, and was Polk county coroner for six years. He moved to Rogue River in semi-retirement in 1916 to operate a drug store. However, he found the community without a physician and continued his practice until his death, being one of the state's oldest practicing physicians and surgeons.

His widow, Martha Cary, survives.

Funeral arrangements have not been made.

### FLYING MURDERER GIVEN LIFE TERM

Jefferson City, Mo., Nov. 2.—(AP)—The eccentric flying career of a Hoosier farmhand who had a passion to be an aviator, ended in a forced landing here today as a life term in the state prison.

In a surprise move at Macon, Mo., yesterday, Pletch, 29, pleaded guilty to slaying Flying Instructor Carl Bivens one mile above Macon county and was given a life sentence by Circuit Judge Harry J. Libby.

Earlley, Pletch had waived preliminary hearing and approved Judge Libby never to apply for a pardon or parole. The judge said the sentence was in accordance with the wish of Bivens' widow.

### Germany and Russia Speed Swap of Needed Materials

Berlin, Nov. 2.—(AP)—A great whirl of activity in the Soviet Russian trade headquarters today was visible evidence of nazi-communist economic cooperation whereby Germany hopes to get raw materials she needs for the war.

The trade deal with Russia has brought about a rush of business which has overflowed the Russian embassy. A separate headquarters has been established for the exchange of products as Russian-German political and economic objectives daily draw closer together.

While the German press was exhaling adjectives to praise Soviet Premier-Foreign Commissar Vyacheslav Molotov for outlining a foreign policy in which a strong Germany was regarded as necessary, economic cooperation between the states was being accelerated.

### Change in World Domination Predicted by Roger Babson

Boston, Nov. 2.—(AP)—Collapse of the British empire as now constituted, but emergence of Russia, Germany, England, Japan or China, and possibly the United States as the world's dominating nations was predicted today by Roger W. Babson, business statistician.

This forecast was made in an address prepared for the executives and sales manager clubs of the Boston chamber of commerce.

"There is no logical excuse for so many nations," said Babson. "There should be only four or five possessing armaments and a dominating voice in world affairs. The balance must exist to become protectorates, if not

### SISEMORE APPOINTED KLAMATH PROSECUTOR
