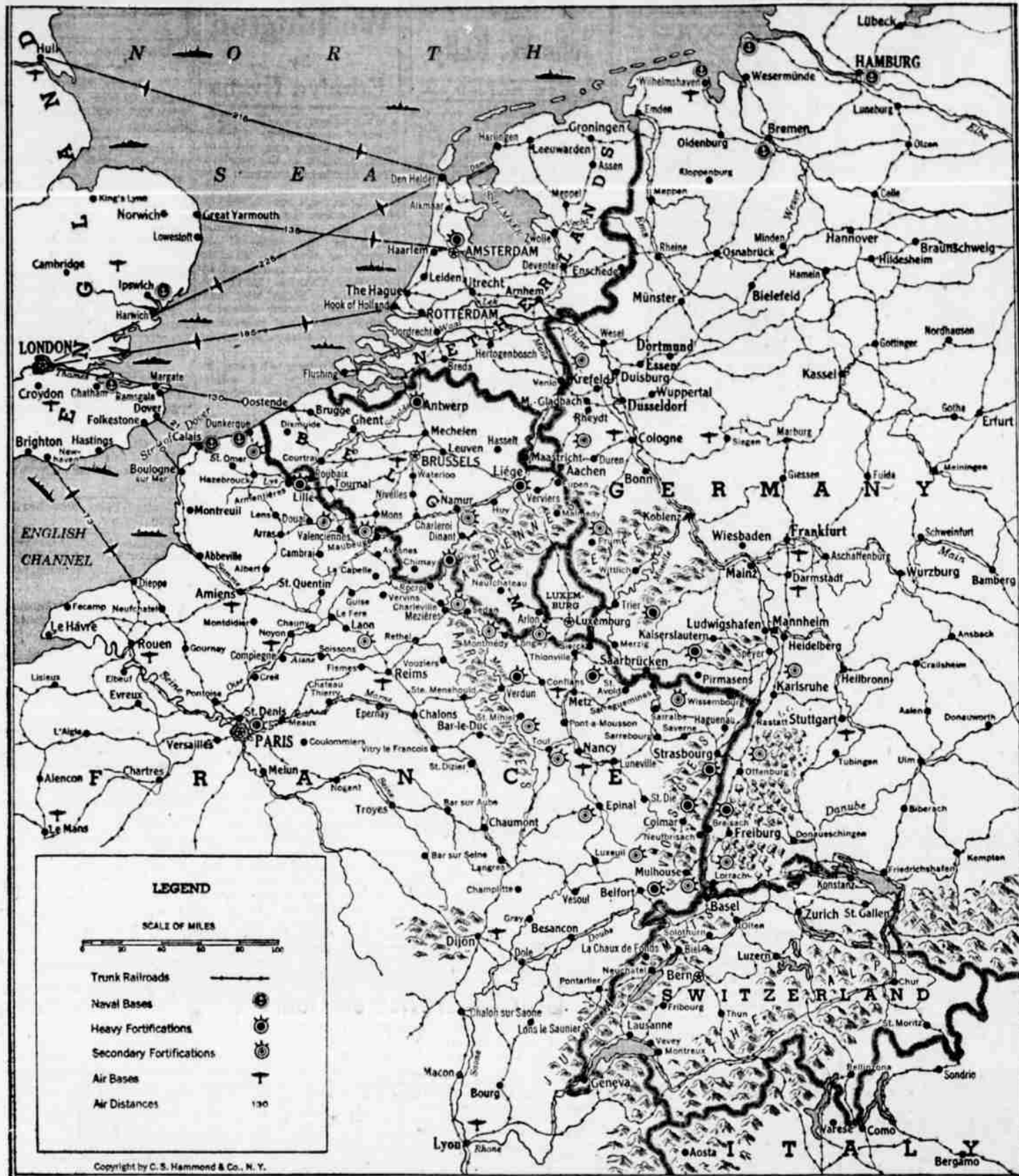


Mail Tribune's United Press Map Shows Theatre of War

949 IN MEDFORD PAID INCOME TAX TO GOVERNMENT

Treasury Listing of Individual Payments Shows 1315 From Jackson County

Washington, May 29.—(P)—The treasury announced today that 54,705 individual income tax returns were filed in Oregon in 1939.

There were 6,250,763 individual returns filed that year, the treasury said, compared with 6,398,541 in 1938. In making public the number of returns by states, counties, cities

and towns with a population of 1,000 or more, the treasury did not disclose the amount of tax paid.

TACOMA WIDENS FIGHT ON POLIO

Tacoma, May 29.—(P)—A four-point program designed to prevent further spread of a growing infantile paralysis epidemic was laid down today as two new suspected victims were hospitalized, bringing the number of cases under treatment to 15.

A bulletin signed by Dr. N. E. Magnussen, county health director, and distributed to all schools, suggested:

Cancellation of picnics and pre-vacation parties, cessation of inter-school athletics, isolation of pre-school children from students "as much as possible," and immediate reporting of any sickness.

San Francisco, May 29.—(P)—The army said today that a group of U. S. army reserve officers under 30 years of age would be ordered to six months active duty in the ninth corps area foris.

Headquarters at the Presidio here announced that in order to build the defense reserves, 110 lieutenants with less than six years' service would be admitted to California, Oregon, Washington and Wyoming posts for full-time training for the period.

The board also declined without comment the request of John Brite and Coke Brite, Siskiyou county slayers, for commutation of sentence to time served.

PEAR FILM SHOWN ALL OVER NATION TO MANY GROUPS

Ten Prints of West Coast Picture Much in Demand During 1939-40 Season

"Pear Lands of the Pacific," the motion picture advertising pears of the Rogue river valley and other fruit districts of the Pacific coast, produced by the Oregon-Washington-California Pear Bureau and shown at the Holly theatre about a year ago, has been shown at a remarkable number of points throughout the United States during the 1939-40 season. Nine 16 mm. prints have been used for ordinary showings with one 35 mm. print for infrequent showings where a theatre-size film was required, such as for conventions. The pear bureau declares several additional prints could be used as it has been unable to fill all requests.

A listing of the cities where the Y.M.C.A. motion picture bureau routed the one print furnished it last fall follows:

At Food Shows

In conjunction with food shows and conventions, the film was shown, sometimes in the auditorium, sometimes in a special moving picture "theatre" in conjunction with the convention, a new trend in such meetings, at the following cities: Chicago, Des Moines, Omaha, Boston, Worcester, Philadelphia, New York and Oklahoma City.

Among the shows or conventions at the cities where the film provided instruction and entertainment were the International Apple Shippers, Iowa State Retail Growers, New England Retail Grocers, National Hotel Association, Auditorium Food Show and National Restaurateurs.

Miscellaneous sources where the pear film was shown the past season were numerous, according to the pear bureau heads who state that among them were many civic, club, school and church groups.

Print Circulated

The one print left in the Seattle office of the pear bureau has been kept in circulation most of the season and as prints became available from fieldmen they were also used. Some of the places at which the last available print was shown were Albany, Ore.; Cincinnati, Emeryville, Cal.; Grandview, Wash.; Kent, Wash.; Portland, San Francisco, Seattle, Yakima, Kirkland and Renton, Wash. Some of the sponsors at these cities were nurses' conventions, school systems, Lions and Kiwanis clubs, chambers of commerce, public schools, state federations of women's clubs, container corporations, churches, college clubs, Safeway Stores and the San Francisco fair.

OFFICER INVENTS TERRIBLE WEAPON

San Francisco, May 29.—(UP)—A retired army officer said today he is submitting to the United States war department a weapon so terribly destructive that it will blow up an entire community. Major Harold W. Webb claims he has invented a device the nature of which he cannot reveal because of present wartime conditions.

He says he is leaving immediately for Washington to confer with his attorneys about making his weapon available immediately to the Allies, and will seek a private audience with President Roosevelt.

The retired army officer says the weapon is so destructive that he is reluctant to bring it into the open until the Allied cause becomes desperate.
