That it is the intention of the council to cause Park Avenue from Dakota Avenue to the north line of Catherine Street and Park Avenue Street from Park Avenue to King Street to be improved by placing on both sides thereof a concrete curb and gutter and by paving the same for a width of thirty feet from curb to curb.
