

MEAT PROSPECT LESS FAVORABLE IN NEAR FUTURE

Some Cuts May Be Returned
To Ration List; Distribu-
tion Troublesome Phase.

Washington, June 15 —(U.P.)—The agricultural department today issued a less favorable forecast on civilian meat supplies in the next few months with indications that some meats may be returned to the ration list in the not-too-distant future.

Supplies will remain "large" through the July-September quarter but will decline in quantity and quality as production drops seasonally and as non-civilian purchases increase, a survey said.

Distribution Trouble
"The smaller supplies of better grades of meat available for civilian consumption in the coming months may accentuate difficulties in the distribution of meat, since such a large proportion of civilians are financially

able to buy more meat of the better grades as well as choicer cuts," the department reported.

Difficulties of distribution as well as short supplies have usually preceded Office of Price Administration rationing action. The outlook for other foods: Milk—about the same supply this year as last but seasonally less during late summer and fall. Butter—less in the next six months than in the first half of 1944 but still more than in the first half of 1943.

Eggs — a more-than-seasonal decline in production is anticipated but large storage stocks accumulated this spring will be available for civilians.

Poultry—supplies are increasing from the low point reached early in the year.

Fruits—a 10 per cent larger citrus fruit crop is in prospect this fall, and more peaches, apricots and cherries than last year are in sight.

PRO-NAZIS PLAN REIGN OF TERROR ON FRENCH FRONT

London, June 15 —(U.P.)—Pro-Nazi collaborationists caused the arrest of at least 75,000 persons during the first four days after the Allied invasion of France and are planning a "reign of terror" to stamp out growing uprisings of underground armies, private reports from inside France disclosed today.

The reports said that a "terrible blood bath against the home front" was contemplated by Joseph Darnand, former secretary for maintenance of order and head of the Vichy militia. The informant reported that the greatest fear in France was that the desperate collaborationists would carry out their threat to plunge the country into general civil war.

Railroad transport was becoming increasingly chaotic and several thousand German engineers troops are working day and night repairing damage done by bombs and sabotage, the informant said.

Telegraph and telephone service has been so disorganized that occupation authorities have forbidden their private use, the report continued, adding that resistance forces evacuated from Lisieux reported Germans were rounding up partisans operating far behind the lines.
